 - (3) Can the Minister confirm the rate of participation and completion of these programs?

 - (a) How many young offenders in the past twelve (12) months have reoffended?
 - (b) What is the timeframe between reoffending?
 - (5) What sentences or community supervision sentences or community supervision is being imposed for reoffenders?
 - (a) How many have breached these orders?

I am advised:

- (1) As at 14 June 2023, there were 165 young people in detention.
- (2) Of the 165 young people in detention on 14 June 2023:
 - a) 110 (67%) were on remand
 - b) 6 (4%) were female
 - c) 90 (55%) were Aboriginal
 - d) and e)

Youth Justice is unable to provide this data as it only has access to information relating to young people who had previous contact with Youth Justice. Under the Young Offenders Act 1997, young people who commit an offence can be diverted through cautions and warnings and would only have contact with Youth Justice if they receive a custodial or community order.

- f) 132 (80%) had previously been in detention and 108 (65%) had previously been supervised in the community.
- (3) Over the last 12 months, the average length of time a young person spent in custody on remand before they received a custodial sentence was 122.2 days. Youth Justice is unable to provide this data for young people discharged from custody who received a community sentence.

Youth Justice provides a range of interventions and supports for young people in custody on both remand and control orders.

Young people in custody are supported through dedicated staffing roles and programs including a clinic run by medical staff from the Justice Health and Forensic Mental Health Network and Education Training Units staffed by Department of Education teachers.

Young people in custody are further supported by Youth Justice-employed caseworkers, psychologists and Aboriginal Practice Officers. Staff work proactively with young people to build rapport, establish positive relationships and promote desistance from future offending.

Evidence-based assessments and interventions are used to identify and address issues influencing offending behaviour and respond to the unique and specific needs of each young person (for example, cultural identity, disability, substance abuse problems, history of trauma and abuse).

Public sector awards and their expiry dates are publicly available.

The 2.5 per cent legislative wages cap blunted negotiations and eliminated genuine productivity based discussion and improvement. The Government has established an Industrial Relations Taskforce to rebuild a cooperative productivity-based bargaining system. A Comprehensive Spending Review is underway and will provide savings and I refer further questions to the responsible Minister.

The Government has announced a Whole-of-Government return-to-work policy. Under the former government a worker injured in one part of the public sector would rarely if ever return to a role, if that role was in another part of the public sector. Return-to-work rates are a key cost driver in the public sector insurance schem e (Treasury Managed Fund) and improving return-to-work rates will result in savings. The government inherited a \$669 million bill for the Treasury Managed Fund.

Sydney Trains has mapped out a large-scale maintenance program taking place every weekend for approximately the next year, designed to carry out several years' worth of normal maintenance works in that time. The works will cost an estimated \$97 million funded out of existing unspent budgets.

The Rail Repair Plan identified:

- More than 1,900 high priority defects repaired
- Around 3,700 repairs, upgrades, and refurbishments
- Around 100 worksites every weekend (around 300 additional worksites on some weekends)
- Around 450km of rail repair, such as grinding, and electrical inspections
