- * 0356 ENERGY—AUSGRID'S POLICIES—The Hon. Mark Latham to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—
 - (1) Can the Minister advise what involvement the Government has had with the development of Ausgrid's:
 - (a) Smart Cities policies?
 - (b) Smart Lighting policies?
 - (2) What do these policies hope to achieve?
 - (3) Are these policies consistent with the Government's policy direction for the management of the New South Wales electricity grid?

Answer-

(1) I am advised the Office of Energy and Climate Change was not involved in the development of Ausgrid's Smart Lighting or Smart Cities policies.

The NSW Government's More Efficient Street Lighting (MESL) program, which ran from 2019 to 2022, supported the rollout of high-efficiency LED street lights. Under the program, Ausgrid was awarded a grant of \$200,000 in 2021 to design a trial project on smart lighting.
