 - (1) The South Australian Government is currently developing an Autism Strategy focusing on addressing challenges and barriers for people with autism, and an Autism Charter to ensure state government agencies are committed to creating an inclusive workplace for people with autism, to complement the National Autism Strategy, can the Minister please advise:
 - (a) Has the Department explored developing an autism strategy or similar for New South Wales?
 - (b) Has the Minister considered developing an autism strategy or similar for New South Wales?

Answer—

The NSW Government is committed to supporting the development of the National Autism Strategy, which will be for all Australians with autism and will help to guide a more coordinated, national approach supporting people with autism at each stage of life. Following this body of work, further consideration will be given to the need for a NSW-specific strategy.

Answer—

I am advised

- (1) The former Liberal-National Government did not complete sealing the Cobb Highway during their 12 years in government. As such, the project is ongoing.
- (2) The premise of the question is incorrect. The December 2022 Community Update indicated that: *"The delivery program has been reviewed and it is expected that all remaining sections on the Cobb Highway will be completed by end October 2023, weather permitting."* <u>https://www.transport.nsw.gov.au/sites/default/files/media/documents/rww/projects/01documents/</u> <u>cobb-hwy-silver-city-hwy-upgrade/cobb-hwy-silver-city-hwy-community-update-2022-12.pdf</u>
- (3) Since the start of the project in 2018, there have been about 25-30 staff involved in the construction works at any given time.

- * 0474 REGIONAL TRANSPORT AND ROADS—COFFS HARBOUR BYPASS—The Hon. Sam Farraway to ask the Minister for Jobs and Tourism, Special Minister of State, Minister for Roads, Minister for the Arts, and Minister for Music and the Night-time Economy representing the Minister for Regional Transport and Roads—
 - (1) Will the Government and TFNSW fund the Pacific Bay sound wall as part of the Coffs Harbour Bypass?

- (2) As of 14 June 2023 has the Minister met with Pacific Bay Resort and Coffs Harbour City Council regarding the sound wall as part of the Coffs Harbour bypass project?
- (3) Will the funding for the sound wall as part of the Coffs Harbour bypass be included in the September Budget?

I am advised

(1) The former Liberal-National government did not include this as a part of the project Coffs Harbour Bypass project. Transport for NSW has addressed Pacific Bay Resort's preliminary concerns with alternate planning pathways to include a noise wall as part of Pacific Bay Resort's future developments. This includes working with Regions NSW on a business case to support a noise wall application.

The Coffs Harbour Bypass project has included space proofing for a future noise wall to be constructed if this is determined to be built at a later date. Furthermore, Transport for NSW has minimised the property acquisition footprint at the request of the Pacific Bay Resort landowner.

Noise modelling for the Coffs Harbour Bypass under the 2019 Environmental Impact Statement determined that noise mitigation is not required in the vicinity of Pacific Bay Resort as the existing Pacific Highway will have lower volumes of traffic noise once the bypass is completed. There is no evidence at this time to suggest a noise wall is required at this location however, further modelling will take place following the finalisation of the Coffs Harbour Bypass detailed design.

Noting that transport and roads in the regions are social determinants of health, education, opportunity and jobs, and that they are vital for social inclusion and ensuring access and equity to people from all backgrounds across regional, rural and remote areas, my top three goals as Minister for Regional Transport and Roads are;

1. Develop more collaborative relationships with local councils, members of parliament, industry, transport operators, community groups and other relevant stakeholders in regional, rural and remote areas which are focused on meeting the safety and transport needs of our communities in these areas.

- 2. Develop strategic regional integrated transport plans which ensure that the passenger and freight transport needs of people and industry in regional, rural and remote areas of NSW are met safely and efficiently.
- 3. Develop a more streamlined infrastructure and maintenance funding program to improve the deliverability of projects, financial and resource capacity of local councils, Transport for NSW and industry to deliver the projects, connectivity for people in regional, rural and remote areas, opportunities for betterment after natural disasters, and financial rather than the pork barrelling approach taken by the former Liberal and National Government which led to massive cost blow outs, massive increases in cost escalations and the failure of infrastructure to keep pace with some of the fastest growing regional communities in the state of New South Wales.

TfNSW complies with the NSW Government's procurement policy framework, to ensure all tenders are competitive and transparent, to deliver the best outcomes for customers and value for NSW taxpayers.

Budget blow outs can be defined as the difference between the initial cost estimate and the final cost. For example, The Spanish-built Regional Rail Fleet is publicly reported to be more than three years late and more than \$1 billion over budget, under the previous government. The Korean-built Mayrung Fleet was due to enter service in late 2019. It was reported under the previous government that cost overruns could exceed \$1 billion prior to entering revenue service.

There are many other examples of significant budget blow outs that meet this definition across the Transport portfolio over the last 12 years of the Liberals and Nationals being in Government.

A timeline for their delivery will be confirmed once the testing and assurance phase of the rollingstock is complete.

(1) No

- (2) Transport for NSW is seeking to obtain the approval of the previous government to provide a copy of the final report to the new Government.
- (3) As of 14 June 2023, 33 of the 37 recommendations from the panel's interim report had been implemented, constituting:
 - 38.42 km of Regional roads transferred to Transport for NSW management as a result of reclassification to State roads, across three Local Government areas;
 - 24.2 km of Local roads transferred to Transport for NSW management as a result of reclassification to State roads, across four Local Government areas;
 - 6.48 km of State roads transferred to Council management as a result of reclassification to Local roads, across two Local Government areas.
- (4) The NSW Government is working to improve road funding for regional Councils. The NSW Government has committed to create a \$670 million Regional Emergency Road Repair Fund to support regional Councils over the next two years to improve roads in Regional NSW. This includes:
 - Additional investment of \$390 million over the next two years and continuing the existing \$280 million regional pothole program, to ensure there is enough funding available to start the vital work of repairing our regional roads.
 - Deferral of the regional road transfer and reclassification program and putting the existing NSW Budget funding of \$193 million along with the additional \$197 million of new money into the new Emergency Road Repair Fund.

In addition, a capped \$334 million Regional Roads Fund will be established to build new roads in rural and regional areas.

I am advised

- (1) 39 properties have been impacted by the Singleton Bypass Project. The property acquisitions were conducted by the former Liberal-National government. I am advised that at that time, the local member refused to advocate on behalf of his constituents. All acquisitions have been completed except for six matters that remain before the Land and Environment Court (Court). Transport for NSW is unable to comment about matters before the Court. This court action proceeds the current NSW Government.
- (2) Transport for NSW is required to pay compensation in accordance with Section 55(a) of the Land Acquisition (Just Terms Compensation) Act 1991 "landowners are entitled to the market value of the land on the date of its acquisition". Market Value is determined by an independent valuation and is subject to negotiations between the parties involved to try to seek a mutual agreement. The property acquisitions were conducted by the former Liberal-National government. I am advised that at that time, the local member refused to advocate on behalf of his constituents.
