- \* 0792 LIZARD ROCK PROPOSAL—Mr Matt Cross to ask the Minister for Planning and Public Spaces— In relation to the Lizard Rock proposal:
  - (1) Have you commenced working with the Metropolitan Local Aboriginal Land Council and/or Northern Beaches Council to find a use for the site?
    - (a) If not, why not?

#### Answer-

I am advised the Department of Planning and Environment is working with the Metropolitan Local Aboriginal Land Council (Metro LALC) and Northern Beaches Council to progress the process for the Lizard Rock planning proposal.

A Gateway determination was supported on 9 June 2023, subject to several conditions and is available on the NSW Planning Portal.

The Metro LALC will now update the proposal to address the Gateway conditions prior to public exhibition. This will provide Council, state agencies and the community the opportunity to provide valuable feedback on the planning proposal.

\* 0794 FLIGHTS FROM SYDNEY TO TEL AVIV—Mr Matt Cross to ask the Premier—

What actions have you and/or your government undertaken to date in relation to direct flights between Sydney and Tel Aviv?

#### Answer-

I am advised that the Minister for Tourism has made representations on this matter.

- \* 0795 FUTURE OF MUSWELLBROOK HOSPITAL DAY CENTRE—Mr Dave Layzell to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—
  - (1) Does Hunter New England Local Health District propose any changes to the Day Centre operating at the Weidman Wing of Muswellbrook Hospital?
  - (2) If so;
    - (a) What community consultation was conducted regarding this proposed change?
    - (b) Were the carers and families of Day Centre clients consulted about the proposed change?
    - (c) What was the process used to determine the new arrangement?
    - (d) Should the change have been the subject of a tender to assess a new operator for the service?
  - (3) How many people use the Day Centre each week?
  - (4) How many people have used the Day Centre during 2022?

#### Answer-

## I am advised:

(1) On 30 June 2023, the Muswellbrook Social Support Group (previously Centre-Based Day Care) was transitioned to an NGO provider funded through the Australian Government's Commonwealth Home Support Program.

#### (2 a - d)

Before the transition, the District contacted clients and carers to find out if they would like to continue receiving this type of service, and to obtain consent to provide their personal details to the service provider.

The Federal Department of Health and Aged Care identified and contracted the new provider.

(3-4) The Muswellbrook service offered group activities to clients, 4 times a week, around 48 weeks a year.

\* 0797 VAPING IN NEW SOUTH WALES PUBLIC SCHOOLS—The Hon. Adam Marshall to ask the Deputy Premier, Minister for Education and Early Learning, and Minister for Western Sydney—

Does the Government have plans to install vape detectors in New South Wales public schools?

#### Answer-

The previous Liberal National government let vaping in schools get out of control. All NSW public schools are smoke-free environments and any tobacco products including vapes are banned.

In due course, the Minns Government will host a roundtable on smoking and vaping in schools.

In relation to the employment by Hunter New England Health District of locum doctors at the Armidale Hospital to fill ongoing vacancies -

- (1) Can you confirm that Hunter New England Health has terminated the employment as a locum of a doctor who has been employed as a long-term locum doctor in the Armidale Hospital Emergency department?
- (2) If yes, please advise why Hunter New England Health has taken the step of terminating his locum employment?
- (3) Will the termination of that doctor's regular locum employment leave the hospital critically short staffed?
- (4) Is the termination of that doctor's locum employment is in contravention of the Health industry status of employment award which clearly says a temporary employee can continue work without defaulting to a permanent staff member status in the absence of any existing permanent employees to fill the role?
- (5) Will NSW Health provide the number of FTE vacancies for doctors in the Armidale Hospital Emergency Department?

#### Answer-

(1-5) I am advised:

Termination of employment has not occurred.

Armidale Hospital management has been working to ensure all locum engagements comply with current policy and industrial instruments.

In accordance with NSW Health Policy and the Award, Armidale Hospital is seeking to engage permanent clinicians to fill the roles on an ongoing basis.

HNELHD would welcome the conversion of locums to permanent employees and regularly encourages all locums to apply to become permanent employees.

Until the positions are filled, the District continues to use locums secured through locum medical units or agencies to fill shifts.

As at 30 June 2023, there were 767 applicant households on the social housing waiting list in the CS08 Sutherland Allocation Zone. This is comprised of 154 priority applicants and 613 general applicants.

#### Answer-

#### I am advised:

- (a) The previous government announced this unfunded scheme without consulting the non-government sector leading up to an election. The NSW Government will make a decision following stakeholder consultation and the release of the Monash University Gender and Family Violence Prevention Centre research project on disclosure schemes.
- (b) The NSW Government is committed to reducing domestic and family violence and appropriately managing perpetrators of domestic violence, including through the use of electronic monitoring.
- (c) On 21 May 2023, the NSW Government announced a new government taskforce would look at expanding the Shared Equity Home Buyer Helper program to include access for victim survivors of domestic and family violence.
  - The Department of Communities and Justice currently offers the Rentstart Bond Loan product to all residents of NSW who comply with the eligibility requirements, including domestic violence victim-survivors.
- (d) The NSW Government will continue to monitor sentencing trends, including for domestic violence related offences.
- (e) The Specialist Domestic and Family Violence list will be piloted at five locations.
- (f) The NSW Government will continue to support efforts to embed specialist domestic and family violence practice in all Local Court sites.

- \* 0813 NOWRA BRIDGE PROJECT—Mr Gareth Ward to ask the Minister for Regional Transport and Roads—With respect to the Nowra Bridge Project:
  - (1) Do small businesses remain affected by the Nowra Bridge Project?
  - (2) Has the Minister met with Fulton Hogan to address concerns raised by affected small businesses?
  - (3) Can the Minister advise what steps Transport for New South Wales (TfNSW) has taken to mitigate these concerns?
  - (4) Will the Minister review and improve signage by TfNSW to support affected small businesses?
  - (5) Will the Minister provide compensation to affected businesses?

#### Answer-

#### I am advised

TfNSW acknowledges the social, environmental, and economic impacts construction work for the Nowra Bridge project has had on the community.

TfNSW has been in regular contact with affected businesses to address concerns and has reviewed the schedule of work near affected businesses.

Signage has been installed on the Princes Highway promoting the detour routes for all businesses affected by the temporary closure of Pleasant Way. TfNSW regularly reviews customer feedback and employs and adjusts both Electronic Message Board and static signage to support and update customers throughout construction of the Nowra Bridge project.

\* 0816 VEGETATION BUILD UP IN FERNBANK CREEK—The Hon. Leslie Williams to ask the Minister for Police and Counter-terrorism representing the Minister for Agriculture, Minister for Regional New South Wales, and Minister for Western New South Wales—

Can the Government advise what action is being undertaken to reduce the build up of vegetation in Fernbank Creek, Port Macquarie which has dramatically reduced the water flow in the creek bordering properties at Lot 1-498 Fernbank Creek Rd, Lot 10 – 598 Fernbank Creek Rd, Lot 53-57 Fernbank Creek Rd and 468 Fernbank Creek Rd?

## Answer—

To date LLS has not had any enquiries from private landholders regarding the management of vegetation along Fernbank Creek.

I am advised that the vegetation along Fernbank Creek occurs on a mix of private and Crown Lands.

- (a) The management of vegetation on Crown Lands should be referred by the Council to the Department of Planning.
- (b) Advice on the management of marine vegetation (seagrass, mangroves, saltmarsh) should be referred by the Council to the Department of Primary Industries Fisheries
- (c) Specific advice for the management of vegetation on private lands can be sought by the landholder from Local Land Services (LLS) noting that:

LLS provides landholders with advice and can assist them to understand the approvals required dependant on location, zoning and vegetation type.

The vegetation mapped in this area includes Coastal Wetland and Swamp Oak Forest (a state and federally listed Threatened and Endangered Ecological Community) which are vegetation communities that are significant and protected by regulation including the Biodiversity Conservation Act 2016, the Environmental Protection and Biodiversity Act 1999 and the Environmental Planning and Assessment Act 1979.

A Development Application may be required in relation to the management of the vegetation on this waterway under the Environmental Planning and Assessment Act 1979. The Development Application process is formally assessed by the relevant Local Government Authority.
