- * 0863 PREMIER—MINISTERIAL STAFF—The Hon. Chris Rath to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage representing the Premier—
 - (1) Can the Minister advise, when will 30 June 2023 ministerial staff numbers be disclosed to the public?
 - (a) Will this information be available on the Premier's Department website or the Cabinet Office website?
 - (2) How many ministerial staff vacancies were there as at 30 June 2023?
 - (3) How many ministerial staff were on loan / seconded to ministerial offices from other ministerial offices as at 30 June 2023?
 - (a) Which Ministers loaned / seconded Ministerial staff to which Ministers?
 - (4) How many ministerial staff left employment between 28 March 2023 and 30 June 2023?

Answer-

- * 0871 ENERGY—FREE UP GAS DEMAND THROUGH ELECTRIFICATION—Ms Sue Higginson to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—
 - (1) Can the Minister advise, what options have been explored to free up gas demand through electrification, fuel switching and energy efficiency under the New South Wales Energy and Emissions Bilateral Agreement between the NSW and Commonwealth Governments?
 - (a) How much gas demand has been freed-up as a result of the agreement to date?

Answer—

- (1) The bilateral agreement was an agreement between the previous Australian and NSW governments.
 - Electrification, fuel switching and energy efficiency have, and will continue to be, considered in the NSW Government's actions to reduce the State's emissions. They are already a part of the following initiatives to date:
 - The NSW Energy Savings Scheme provides incentives for businesses and households to undertake energy efficiency upgrades. Eligible activities include replacing existing gasusing equipment with electric alternatives such as heat pump water heaters, and replacing gas use with renewable fuels.
 - Renewable alternatives to gas, including green hydrogen and biomethane, are emerging substitutes for the gas used today. The NSW Government is helping the private sector establish renewable gas industries, including through the NSW Hydrogen Strategy, the hydrogen target under the Renewable Fuel Scheme, and a new renewable gas certification under the National GreenPower Program.
 - The Government has also committed \$25 million for a Hydrogen Centre of Excellence to train workers needed to enable a green hydrogen sector.

The NSW Government is working closely with the Australian Government and other states and territories to coordinate this work nationally.

- (a) There is no data available on the overall gas demand reduction from actions under the bilateral agreement with the Australian Government.
- * 0872 ENERGY—ENERGY AND EMISSIONS REDUCTION AGREEMENT MEMORANDUM—Ms Sue Higginson to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—
 - (1) Can the Minister advise, is the Energy and Emissions Reduction Agreement Memorandum of Understanding between the former Government and former Commonwealth Government still valid?
 - (a) Has there been any change to the quantum of the Memorandum of Understanding as a result of the federal Government committing to a 43 per cent emissions reduction by 2030 and net zero emissions by 2050?

Answer-

- (1) The Memorandum of Understanding NSW Energy Package was signed by the previous Commonwealth and NSW governments on 31 January 2020. It was superseded by the 21 December 2022 Rewiring the Nation agreement between the Commonwealth and NSW governments. The Memorandum of Understanding webpage on the energy.nsw.gov.au website has been removed accordingly.
 - (a) See answer above.
- * 0873 ENERGY—NSW EMISSIONS INTENSITY REDUCTION PROGRAM—Ms Sue Higginson to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—
 - (1) Can the Minister advise, how many large New South Wales-based sources of emission have transitioned their plants, equipment and other assets to low emissions alternatives under the NSW Emissions Intensity Reduction Program?
 - (2) How much of the \$450 million program has been disbursed to date?
 - (a) How many sources of emissions have received disbursement under the program?
 - (b) How many entities have received disbursement under the program?
 - (i) For each entity, list their name and amount of disbursement under the program.
 - (3) What reduction in emissions has been reported as a result of the program to date?

Answer-

- (1) One facility, Orica, based on Kooragang Island (Newcastle), is in the process of transitioning its plant to low emissions alternatives with funding from the NSW Emissions Intensity Reduction Program.
- (2) \$9,198,490 has been disbursed to date.
 - (a) Three of the entities that received disbursements are sources of emissions.
 - (b) Four entities have received disbursements.

- (3) Around 150,000 tonnes of carbon dioxide equivalent (tCO2-e) has been reduced to 30 June 2023.
 - This abatement is from the Orica site. The total annual abatement from Orica's fully commissioned plant is estimated to be more than 500,000 tCO2-e.
- * 0874 ENERGY—NET ZERO INDUSTRY AND INNOVATION PROGRAM—Ms Sue Higginson to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—
 - (1) Can the Minister advise, how much of the \$750 million Net Zero Industry and Innovation Program has been spent, allocated or otherwise used to date?
 - (a) How many entities have received disbursement under the program?
 - (i) For each entity, list their name and amount of disbursement under the program?
 - (2) How many projects under this program have focussed on reduction of gas demand?
 - (a) What has been the recorded reduction in demand of these gas demand reduction projects?
 - (b) How many petajoules of gas demand have been avoided as a result of implementation of projects under this program?
 - (c) How much emissions reductions have been achieved under this program?
 - (d) How much emissions reductions are predicted to be achieved under this program by 2030?

Answer—

- (1) \$24.1 million has been spent to date (up to 14 July 2023).
 - (a) 11 entities have received disbursement under the Net Zero Industry and Innovation Program.

- (2) No projects are focused on gas demand reduction at this time.
 - (a) This is not applicable as the Net Zero Industry and Innovation Program has not supported any gas demand reduction projects at this time.
 - (b) See response to question 2a above.
 - (c) 150,000 tonnes of carbon dioxide equivalent (tCO2-e) of emissions reductions have been achieved to 30 June 2023. This figure is expected to grow at an increasing rate as projects mature and additional projects are commissioned.
 - (d) Over 30 million tCO2-e of emissions reductions is predicted to be achieved by 2030.

- * 0875 ENERGY—GREENHOUSE GAS EMISSIONS—Ms Sue Higginson to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—
 - (1) Can the Minister advise, how many tonnes of Greenhouse Gas emission (CO2e) does the Government predict the Narrabri Gas Project is expected to contribute to the New South Wales carbon ledger?
 - (a) What proportion of New South Wales total emissions will that represent in 2035?
 - (b) Has the Government modelled the emissions profile of the Narrabri Gas Project using a range of estimates of fugitive emissions?
 - (i) If not, what proportion of fugitive emissions as a ratio of production was utilised for the prediction?

- (1) Based on NSW Current Policy projections, the Narrabri Gas Project is expected to contribute 0.45 Mt CO2-e in 2030 and 2035 and 0.38 Mt CO2-e in 2050, from all sources excluding downstream combustion of the gas.
 - (a) In 2035, emissions from the Narrabri Gas Project are projected to represent 0.9% of New South Wales total emissions.
 - (b) The emissions profile of the Narrabri Gas Project was not modelled using a range of estimates for fugitive emissions. The forecasted upper limit of emissions for the life of the project was obtained from the Environmental Impact Statement (EIS) and adjusted according to the Department of Regional NSW Mining, Exploration and Geoscience annual forward production estimates for the project.
 - (i) The proportion of fugitive emissions as a ratio of production was 6.2 tonnes C02-e per terajoule of gas produced.
- * 0876 ENERGY—CARBON CAPTURE UTILISATION AND STORAGE—Ms Sue Higginson to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—
 - (1) Can the Minister advise, what is the status of the Carbon Capture Utilisation and Storage Hubs that are referred to in the Future of Gas Statement?
 - (a) Has the Government received any of the \$313.7 million that the Commonwealth Government allocated to Carbon Capture Utilisation and Storage?

Answer—

This question should be referred to the Minister for Natural Resources, the Hon Courtney Houssos MLC.

- * 0877 ENERGY—COAL SEAM GAS REGULATION—Ms Sue Higginson to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—
 - (1) Can the Minister advise, what has coal seam gas regulation cost the Government over the past 10 years?
 - (a) How much money has the coal seam gas industry contributed to the costs of regulation?
 - (b) How much of the money spent on regulation has gone to the Environment Protection Authority?

Answer—

- (1) No data is held which can provide the whole of Government's costs of regulating the coal seam gas (CSG) industry over the last 10 years.
 - (a) With respect to the Environment Protection Authority (EPA) costs of regulation, the EPA implemented a cost recovery model on 1 July 2022. In 2021–22 the EPA received \$273,820 from licence fees for Santos and AGL. In 2022–23, and the first year of the cost recovery

- mechanism, the EPA received \$439,956. Fees are discounted by 60% for the first three years of the mechanism.
- (b) As other NSW agencies with responsibility for aspects of CSG regulation or support have their own cost recovery arrangements in place or relatively minor unrecovered costs, there is no data on the total cost of regulating the industry. The EPA is now recovering its own costs of regulating the CSG industry, albeit at a discounted rate, until full cost recovery commences in 2025–26.
- * 0878 ENERGY—DRAFT GAS ROADMAP—Ms Sue Higginson to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—
 - (1) Can the Minister advise, when will the draft Gas Roadmap be published by the Government?

- (1) The Government has a range of initiatives in place to support homes and businesses to decarbonise and to capitalise on the economic opportunities of new low carbon industries. This includes initiatives related to gas, such as incentives for fuel switching under the Energy Savings Scheme, and developing a green hydrogen industry through the NSW Hydrogen Strategy. The Government will also establish a Net Zero Commission, which will advise on economy-wide decarbonisation efforts.
- * 0879 ENERGY—GAS IMPORTS PORT KEMBLA—Ms Sue Higginson to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—
 - (1) Can the Minister advise, when does the Government anticipate that gas imports through the Port Kembla terminal that is under construction, will become available to the New South Wales gas market?

Answer-

- (1) The proponent anticipates the first gas deliveries from the Port Kembla Energy Terminal will be in 2026.
- * 0880 ENERGY—REDUCE CARBON EMISSIONS—Ms Sue Higginson to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—
 - (1) Can the Minister advise, does the Government agree with this statement from the Australian Energy Regulator that the overarching mandate to reduce carbon emissions "requires that natural gas, as a fossil fuel, must be replaced by low-emissions technologies."?

Answer—

(1) As outlined in the Net Zero Plan, NSW has strong and ambitious emissions reduction targets of 50% by 2030 based on 2005 levels and net zero by 2050. To achieve this, action will be required across all sectors of the NSW economy, including reducing emissions from gas use.

The NSW Government has a number of initiatives to support emissions reductions that also cover gas use. For example, the NSW Energy Savings Scheme provides incentives for businesses and households to undertake energy efficiency upgrades. Eligible activities include replacing existing gas- using equipment with electric alternatives such as heat pump water heaters.

Renewable alternatives to natural gas, including green hydrogen and biomethane, will over time replace some of the .natural gas used today. The Government is helping the private sector establish renewable gas industries, including through the NSW Hydrogen Strategy, the Net Zero Industry and Innovation Program, the hydrogen target under the Renewable Fuel Scheme, and a new renewable gas certification under the National GreenPower Program.

However, natural gas will remain a key part of NSW's energy portfolio in the medium term in providing firm capacity while consumers gradually switch to electric appliances and renewable alternatives to natural gas are scaled up.

- * 0881 ENERGY—SQUADRON ENERGY—Ms Sue Higginson to ask the Minister for Energy, Minister for Climate Change, Minister for the Environment, and Minister for Heritage—
 - (1) Can the Minister advise, does the Government agree with Squadron Energy that "early 2026" is the likely date "for services to commence based on prospective buyers' and Squadron Energy's own demand"?
 - (a) What does the Government project gas demand will be in New South Wales in 2026 in petajoules?
 - (b) How much of this demand does the Government predict could be supplied by this terminal?

- (1) Questions about the commencement date for the Port Kembla Energy Terminal are best directed to Squadron Energy. The Australia Energy Market Operator projects in its Gas Statement of Opportunities that:
 - (a) In 2026, annual total gas consumption in NSW is forecast to be approximately 118 petajoules (PJ).
 - (b) The Port Kembla Energy Terminal could have an annual production capacity of approximately 130 PJ per annum.

 - (a) Have all actions been implemented completely?
