Victim-survivors are referred to Safer Pathways for support following a domestic and family violence incident.

The NSW Government is investing \$43.6 million over four years to expand and enhance Safer Pathway. This will bolster case management services for victim-survivors with complex needs and expand referral pathways into the system.

Support is delivered by a state-wide network of service providers, including the Women's Domestic Violence Court Advocacy Services for female victim-survivors, and Local Support Services for male victim-survivors.

These services provide information, advocacy, safety planning and referrals to local services to assist with matters including but not limited to:

- Housing and emergency accommodation
- Safety and security audits
- Legal advice
- Financial assistance
- Medical assistance
- Counselling

The NSW Government is also investing more than \$426 million in the Core and Cluster program to expand refuge accommodation for victim-survivors.

By 2026, these projects will have capacity to support up to 2900 victim-survivors and children experiencing domestic violence annually.

All NSW employees, including those in small business, experiencing domestic and family violence, are now eligible to access 10 days of paid family and domestic violence leave. NSW Government sector employees have access to 20 days paid domestic and family violence leave.

Total expenditure since the NSW Timber Truss Conservation Strategy was published in 2012 is \$6.48 million.

The current estimated remaining cost of finalising development and rehabilitation of Brig O'Johnston Bridge is \$19.5 million. Pedestrian access is currently not included in this plan.

Completion of Council's new Clarence Town Bridge at Clarence Town is being delivered by Dungog Shire Council through a Restart NSW-funded project.

Transport for NSW and Dungog Shire Council are collaborating on the delivery of the two bridge projects to ensure the community receives a modern crossing that caters for the future needs of the region and retains the use of the heritage bridge.

Approval for funding for the new bridge is subject to the Federal infrastructure review.

The former Government's response to the Special Commission of Inquiry into the drug ice provided an overview of how the \$500 million over 4 years will address treatment gaps and improve health and social outcomes through a suite of cross-government initiatives.

Of the \$500 million, \$357.9 million is allocated to NSW Health to expand access to alcohol and other drug prevention, early intervention, treatment, and support programs across NSW. Allocations are being informed by sector consultation and determined through a range of procurement strategies including direct allocations, grants and tendering.

Based on processes completed to date, approval for expenditure over 4 years has been provided for:

- \$190.6 million (approx.) to support a range of alcohol and other drug treatment and support services in local health districts and specialty health networks
- \$134.6 million (approx.) for services provided by non-government organisations and Aboriginal community controlled and ACHCOs.
- \$29.5 million (approx.) for public sector and non-government health services to support court diversion programs, including the Magistrates Early Referral Into Treatment and Drug Court (Dubbo and Sydney).

Funding is being provided for new programs and enhancing existing services, delivered by public sector, non-government and Aboriginal community-controlled organisations, including:

- Two new residential rehabilitation and withdrawal management programs, one for Aboriginal women and one for young people.
- New community-based withdrawal management, counselling and support services for priority population groups.
- Delivery of public health and non-government services to support participants of court diversion programs across NSW

- New support services for people exiting custody, to be delivered by Aboriginal communitycontrolled organisations and non-government organisations
- Expansion of Preventure, a primary and early secondary prevention program designed to delay initiation into alcohol and other drug use
- A range of public sector programs being established across NSW, including Substance Use in Pregnancy and Parenting Services, Assertive Community Management; withdrawal management; youth services; Safe Assessment Units and hospital consultation liaison services
- Expansion of the Aboriginal health and peer workforce through creation of new positions in local health districts and non-government organisations.

Sector consultation and collaborative design work is underway for the establishment of a new family and carer program and new multidisciplinary Hub services to be delivered by Aboriginal community-controlled and non-government organisations.

Future grants opportunities will be available for targeted prevention strategies, research and evaluation and additional new service models.

Under Rule 52, before a person is appointed as the Secretary of a Department a report relating to the proposed appointment is required to be provided to the Minister by the Public Service Commissioner (for a report relating to the proposed appointment of the Secretary of the Premier's Department or Secretary of the Cabinet Office) or otherwise by the Secretary of the Premier's Department or the Secretary of the Cabinet Office.

A report by the Secretary of the Premier's Department or Secretary of the Cabinet Office is to be prepared after consultation with the Commissioner and the senior Minister to whom the relevant Department is responsible.
