# **1** MEETING OF THE HOUSE

The House met at 10.00 am according to adjournment. The President took the Chair and read the prayers.

The President acknowledged the Gadigal clan of the Eora Nation and its elders and thanked them for their custodianship of this land.

## 2 STATEMENT BY PRESIDENT—FILMING IN CHAMBER

The President made a statement concerning filming in the Legislative Council Chamber this day.

# 3 STATEMENT BY PRESIDENT—MEMBERS' PROFESSIONAL DEVELOPMENT SEMINARS

The President made a statement concerning an ongoing series of professional development seminars for members.

#### 4 YOUTH ON TRACK (Formal Business)

Mrs MacDonald moved, as formal business:

- (1) That this House affirms its support for the Youth on Track program helping young people reduce their risk of re-offending or committing more serious crimes.
- (2) That this House notes that:
  - (a) the program works with the young person, their family, non-government organisations, caseworkers and members of Youth Justice NSW, to help young people make better decisions about their life,
  - (b) Youth on Track is an early intervention program that identifies young people aged 10 to 17 who are at risk of long-term involvement in the criminal justice system, and
  - (c) Youth on Track is location specific and operates in locations in Blacktown, the Hunter, the Mid North Coast, the Central West, Coffs Harbour, New England and the Riverina and is funded through the Department of Communities and Justice.
- (3) That this House notes that:
  - (a) the Youth on Track program was introduced by the Coalition Government in 2013 and commenced on 1 July 2013 in Blacktown, Newcastle City and the Mid North Coast Local Area Command, in 2015 expanded to include the Manning Great Lakes, Lake Macquarie, Port Stephens, Mount Druitt and Quakers Hill, and in December 2016 commenced in the Central West, Coffs Harbour and New England, then in 2018 expanded to the Riverina.
  - (b) the key objectives or aims of the Youth on Track program are as follows:
    - (i) to identify young people at risk of continuing in the criminal justice system, in a timely way,
    - (ii) to provide one-on-one case management and evidence-informed interventions targeted to address the individual criminogenic risk factors of the young person,
    - (iii) to provide an evidence-informed family intervention to support the family of young offenders to reduce the young person's contact with police, and
  - (c) since its inception in 2013, Youth on Track has supported over 350 young people, who have had contact with the criminal justice system, a second chance to turn their life around.

(4) That this House calls on the Government to continue to support and fund the Youth on Track initiative.

Question put and passed.

# 5 FIFA WOMEN'S WORLD CUP VIEWERSHIP (Formal Business)

Dr Cohn moved, as formal business:

- (1) That this House notes that:
  - (a) the FIFA Women's World Cup semi-final between the Matildas and England drew a television audience of 7.13 million, the highest ever recorded since the current ratings agency was launched in 2001, and was the most streamed event ever in Australia, with 957,000 viewers on 7plus,
  - (b) communities across New South Wales came together to watch the Women's World Cup semi-final at over 44 live sites,
  - (c) the event has been compared to previously highest rated sporting events in Australian history such as Cathy Freeman's iconic Olympic 400-metre final and Ash Barty's Australian Open win,
  - (d) the Matildas have a combined social media following of double the Socceroos,
  - (e) Nike has confirmed the Matildas sold more official jerseys by 19 July 2023 than the Socceroos sold before, during and since the 2022 Men's World Cup in Qatar, and
  - (f) in the England vs Nigeria match at the FIFA Women's World Cup, Chloe Kelly kicked a penalty at 110.79 km/h, more powerful than the Premier League's hardest-hit goal last season.
- (2) That this House further notes that on the eve of the World Cup, 23 Matildas players spoke in a video from Professional Footballers Australia in which they:
  - (a) reflected on the rights for which past and present Matildas have fought through collective bargaining, including to play on natural turf,
  - (b) highlighted the inequity in prize money offered by FIFA, with an overall prize pool for women worth one quarter of the men's pool, and
  - (c) explicitly called on all those in positions of power across football, business and politics to work to provide opportunities for girls and women in football, for A-League women not to have to work part-time jobs, and for fans to continue their support by getting out to an A-League women's game to lift up the next generation of Matildas.
- (3) That this House congratulates and thanks the Matildas for their extraordinary success and leadership.
- (4) That this House acknowledges the tremendous interest in women's sport, and particularly women's football, that communities across New South Wales have demonstrated.
- (5) That this House calls on the Government to commit to initiatives to improve access and remove barriers to participation in sport, including equal prize money, equal pay and equal conditions for women in any programs or events that receive New South Wales government support.

Question put and passed.

#### 6 RE-ESTABLISHMENT OF PARLIAMENTARY FRIENDS OF ISRAEL (Formal Business)

Mrs Ward moved, as formal business: That this House notes that:

- (a) on 24 May 2023, a meeting was held in NSW Parliament House at which the NSW Parliamentary Friends of Israel was re-established for the term of the 58th Parliament,
- (b) the meeting was chaired by the Speaker of the 58th Parliament, the Honourable Greg Piper MP,
- (c) the meeting was attended and supported by a number of members of both Houses of NSW Parliament including:

- (d) by a vote of those present at the meeting, the Honourable Natalie Ward MLC and Dr Marjorie O'Neill MP were elected Co-Chairs, and the Honourable Robert Borsak MLC was elected Treasurer, of the NSW Parliamentary Friends of Israel,
- (e) members of the NSW Parliamentary Friends of Israel acknowledge the work of the NSW Jewish Board of Deputies and its President Mr David Ossip, and
- (f) members of the Parliamentary Friends of Israel look forward to working with the Jewish community in New South Wales and advancing the mutual respect, understanding and friendship between the Parliamentary Democracies of Israel and New South Wales.

#### 7 ORANGE EMUS RUGBY CLUB (Formal Business)

Mr Fang (on behalf of Mr Farraway) moved, as formal business:

- (1) That this House notes that:
  - (a) the Orange Emus Rugby Club held their annual President's Long Lunch on Friday 28 July 2023,
  - (b) over 160 members, supporters and sponsors attended the event in Orange,

- (c) the guest speaker was former Australian cricket player Kerry O'Keefe, and
- (d) proceeds and money raised from the lunch go towards paying for women and juniors' registration, equipment and apparel costs.
- (2) That this House acknowledges:
  - (a) the significant history of Orange Emus Rugby Club in the Central West rugby union competition since 1947,
  - (b) the Orange Emus will be playing the Bathurst Bulldogs in the Central West Blows Cup Rugby Union Grand Final this Saturday 26 August 2023, and
  - (c) the outstanding work the Emus Rugby Club is doing to encourage increased female participation in rugby union by building purpose built changerooms for female players.
- (3) That this House congratulates Orange Emus Rugby Club President Jamil Khaflim, the club board and organising committee on the successful running of the 2023 President long lunch.

## 8 50TH ANNIVERSARY OF VIETNAM VETERANS DAY (Formal Business)

Mrs Maclaren-Jones moved, as formal business: That the House notes that:

- (a) on 18 August 2023, a commemorative service was held to acknowledge the 50th Anniversary of Vietnam Veterans' Day,
- (b) Vietnam Veterans' Day is a deeply significant occasion marking the milestone of the Battle of Long Tan in 1966 and the end of Australia's participation in the war,
- (c) it is a day to honour the sacrifices and unwavering dedication of those who served during Australia's 10 years of participation in the Vietnam War,
- (d) the apology given by the Prime Minister and the RSL NSW recognises our country failed our Vietnam Veterans and the emotional toll and hardships that many veterans endured due to inadequate support,
- (e) we express our sincere gratitude to the 60,0000 veterans who served in Vietnam, remember the sacrifice of the 523 who died and more than 3,000 wounded, and
- (f) we remember not only all of those who served but also those who waited, who lost loved ones and who, by their efforts, made a considerable sacrifice in the defence of Australia.

  - (3) To limit duplication, Transport has endeavoured to provide only the final versions of documents and final emails in a chain, rather than progressive working draft versions or multiple versions of an email chain.".

    "document means any record of information, and includes— (a) anything on which there is writing, or (b) anything on which there are marks, figures, symbols or perforations having a meaning for persons qualified to interpret them, or (c) anything from which sounds, images or writings can be reproduced with or without the aid of anything else, or (d) a map, plan, drawing or photograph", and

- (c) all documents relating to the remuneration packages, allowances, conflicts of interest, declarations and other governance arrangements for the position of Secretary of Transport for NSW,
- (d) all documents provided by NGS Global relating to the recruitment search, selection, application and appointment of Mr Josh Murray to the position of Secretary of Transport for NSW,
- (e) all documents relating to the public announcement of the appointment of the position of Secretary of Transport for NSW,
- (f) all minutes that discuss the appointment of the position Secretary of Transport for NSW,
- (g) all briefs or briefings, however described, including attachments sent to, signed by, drafted by, received by or approved by, the Premier, Minister for Transport, Minister for Roads, Minister for Regional Transport and Roads, or the Acting Secretary of the Premier's Department in relation to the recruitment process and selection of the Secretary of Transport for NSW,

### 34 NATURAL RESOURCES ACCESS REGULATOR AND WATER METERING COMPLIANCE

Mr Buckingham moved, according to notice:

- (1) That this House notes that:
  - (a) in 2017 media reports of mismanagement of water in New South Wales led to considerable public concern and loss of confidence in the regulation and use of the State's water resources,
  - (b) subsequently the Government commissioned Mr Ken Matthews to inquire into and report on aspects of water management in New South Wales,
  - (c) the Matthews interim and final reports highlighted several significant shortcomings and presented a significant case for change in the water compliance and enforcement system in New South Wales,
  - (d) established under the Natural Resources Access Regulator Act 2017, the Natural Resources Access Regulator (NRAR) was created as a recommendation of the Matthews Inquiry,
  - (e) the NRAR is an independent water regulator with an independent board which is appointed by, and reports to, the Minister for Water and any directions to the NRAR by the Minister must be made according to the provisions of the NRAR Act,
  - (f) the NRAR works to deliver effective, transparent and accountable enforcement of New South Wales laws, and maintain public confidence in the enforcement of those laws by putting in place new standards to ensure the effectiveness and transparency of compliance activities at an individual, water sharing plan, and State level,
  - (g) under New South Wales water metering reforms, pattern-approved meters for surface water pumps 500 mm and above were required to be installed by 1 December 2020,
  - (h) according to the latest NRAR compliance reports, and despite being required under New South Wales law, significant numbers of irrigators in the Northern Inland region have failed to comply with their "no meter no pump" obligations,
  - (i) by 1 December 2022, owners of the remaining works in the Southern Inland region were required to comply with the metering regulations,
  - (j) under New South Wales metering reforms, duly qualified persons (DQPs) are required to ensure that metering equipment has been installed and verified correctly, and
  - (k) the NRAR has warned that it will undertake checks of DQPs' installation and verification of metering equipment to ensure consistency and accuracy of work and that it retains the right to investigate and take regulatory action against DQPs who are not complying with their obligations.
- (2) That this House calls on the Government to:
  - (a) ensure that the NRAR has the powers and resources required to meet its regulatory role,
  - (b) act urgently to ensure that there is full compliance with the laws regulating water access and metering requirements in New South Wales,
  - (c) ensure the independence and integrity of the DQP regime in New South Wales, and
  - (d) ensure the safety of all NRAR staff in the exercise of their regulatory roles.

(3) That this House commends the NRAR and all its staff for their work towards the restoration of public confidence in the equitable regulation, and the use, of water resources in New South Wales.

  - (b) on 25 July 2023, the Honourable Rose Jackson, Minister for Water, Minister for Housing, Minister for Homelessness, Minister for Mental Health, Minister for Youth and Minister for the North Coast was quoted in the Sydney Morning Herald as wanting to make sure that the extra 450 gigalitres of water that needs to be returned for the environment by June 2024 under the Murray-Darling Basin Plan was achieved through infrastructure rather than through buybacks from irrigators.
- (2) That the House further notes that:
  - (a) environmental water has protected rivers and wetlands, including Ramsar sites in the Macquarie Marshes, Gwydir Wetlands, and Narran Lake, it has kept rivers flowing, and in the Barwon-Darling/Baaka has provided water to towns when the water agencies turned the water off,

- (b) one study by Professor Glyn Wittwer from Victoria University has shown that spending on health, education and basic services produced three to four times more jobs than the same level of expenditure on irrigation infrastructure investment,
- (c) irrigation efficiency projects are 2.7 times more expensive than buybacks,
- (d) the \$4.5 billion irrigation efficiency scheme has been riddled with maladministration, including that the Commonwealth and New South Wales Governments have been unable to account for 250 gigalitres worth of New South Wales irrigation efficiency projects costing \$1.8 billion, and
- (e) at the end of the last drought, there were 364 gigalitres of unused water (carried over) in the New South Wales Murray River, three quarters of which was owned and carried over by Murray Irrigation Limited.
- (3) That this House calls on the Government to review:
  - (a) the socio-economic impact of water moving to its highest value use,
  - (b) carryover, including carryover within private irrigation schemes and accounts not associated with land, and
  - (c) the efficiency projects undertaken to date, including verifying their savings and whether all savings have been passed onto the Commonwealth.

#### Debate ensued.

Ms Jackson moved: That the question be amended as follows:

- (1) Omit paragraphs (2)(c) to (2)(e).
- (2) In paragraph (3) omit "review" and insert instead "consider".

Debate continued.

Question put: That the amendment of Ms Jackson be agreed to.
