- (1) This year studies have been undertaken by Tiba Biotech Inc, Boston on the mRNA construct shown to give antibody levels in blood to Foot and Mouth Disease Virus (FMDV) type O virus in pigs in studies done in Europe. When this construct was retested, using current dendrimer nanoparticle formulations in mice, these results were not replicated.
 - NSW Department of Primary Industries (DPI) and Meat and Livestock Australia (MLA) are considering a revised proposal to look at a number of alternative constructs in mice, then other species, to replicate the earlier studies funded by Gates Foundation to find effective vaccines.
- (2) Six mRNA vaccine candidates have been shown to produce antibody levels in mice that neutralise Lumpy skin disease (LSD) virus in vitro. Further, mixtures of serum show greater than additive levels of activity in vitro and a mixture of constructs is likely to be required in the end product. At present the consortium is seeking to test the candidates in other species including livestock.
