Answer—

The Local Small Commitments Allocation has been designed to evenly spread funding across all 93 Legislative Assembly electorates.

It has been designed to prevent pork barrelling and ensure that all electorates receive the exact same amount of funding.

The election commitment ensured \$400,000 went to every electorate in NSW regardless of political allegiance; whether or not a Labor candidate won the seat.

The NSW Government will put every single project through a rigorous assessment process including by an expert independent assessment panel.

Independent probity advisors have been appointed to advise on the management of conflicts of interest and provide probity advice.

\* 1317 CLOSURE OF DAYDREAM STREET WARRIEWOOD—Mr Rory Amon to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—

Could the Minister please provide detailed reasons as to why Daydream Street, Warriewood, is proposed to remain closed onto Mona Vale Road moving forward?

Answer—

I am advised

The closure of the Daydream Street access was part of several local road connections with Mona Vale Road that were identified for closure to improve safety. Ongoing safety issues existed with vehicles turning in and out of Daydream Street into Mona Vale Road. This identification followed Transport for NSW's 1999 road safety audit, which the local traffic committee approved in 2002.

While this closure took place over 20 years ago the justification still applies in light of the increase in development and traffic volumes in the area.

The Mona Vale Road upgrade is almost complete and will provide new and more reliable traffic light access via the nearby Ponderosa Parade to Daydream Street.

- \* 1318 TAMWORTH EARLY CHILDHOOD SECTOR—The Hon. Kevin Anderson to ask the Deputy Premier, Minister for Education and Early Learning, Minister for Western Sydney, and Minister for Skills, TAFE and Tertiary Education—

Answer—

The Minns Government's record investment in public preschools is targeting support for families and children experiencing disadvantage, poorer educational outcomes and in areas where there is undersupply of preschool places based on predicted future demand.

The department is considering locations based on a range of data and feedback from the sector. This includes consideration of Socio-Economic Indexes for Areas (SEIFA) and Australian Early Development Census (AEDC) data. Community consultation will occur as part of the rollout of these preschools, with the operational timeframes for each preschool to be determined as part of that process.

The government's 100 public preschools commitment focuses on increasing the supply of preschool in areas of need where there is an undersupply of preschool places.

The NSW government has also established the Childcare and Economic Opportunity Fund (the Fund), to foster sector growth over the coming decade.

The Department of Education does not hold specific information on waiting lists for private day care services.

\* 1319 M5 TOLL CASHBACK—Mrs Tina Ayyad to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—

- (1) How many individuals claim the M5 toll cashback as of 31 August 2023?
- (2) What is the average amount of money reclaimed per quarter for an individual claiming the M5 toll cashback as of 31 August 2023?

Answer—

I am advised

- (1) Between January to August 2023, 307,039 individuals claimed rebates through the M5 South-West Cashback Scheme. A motorist holding more than one tolling account in this period will be counted on multiple occasions.
- (2) In the quarter ending in March 2023, the average amount of money claimed by an individual was \$172.97, while the average amount of money claimed in the quarter ending in June 2023 was \$173.92. These figures are prepared on a cash basis and include no provision for accrued expenses. An individual with multiple tags attached to their account in this period may be counted on multiple occasions.

\* 1320 MAGNETIC RESONANCE IMAGING MACHINE LIVERPOOL HOSPITAL—Mrs Tina Ayyad to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

- (1) Has a business case been submitted and/or approved for the purchase of an additional MRI machine for Liverpool Hospital?
- (2) Does the Government have plans to provide an additional MRI machine for Liverpool Hospital?
- (3) How many MRI machines are available, by Public Hospital, in the South West Sydney Local Health District and South Eastern Sydney Local Health District?

Answer—

I am advised:

As part of the hospital's redevelopment, Liverpool Hospital will obtain an additional MRI machine in 2024.

Information on facilities with MRI machines is published on the Australian Government Department of Health and Aged Care website.

\* 1321 SURPLUS LAND IN HOLSWORTHY—Mrs Tina Ayyad to ask the Minister for Small Business, Minister for Lands and Property, Minister for Multiculturalism, and Minister for Sport—

- (1) Can the Minister identify which, if any, parcels of surplus Government land in the electorate of Holsworthy have been found viable for development?

Answer—

I am advised:

The NSW Government is committed to ensuring that the State's property portfolio is put to best possible use in delivering key infrastructure and services and in particular, delivering housing.

The Premier of NSW has requested all Ministers participate in a portfolio-wide audit of NSW Government property, which includes government owned land in the electorate of Holsworthy, to identify land that could be used to deliver housing.

Property and Development NSW has been tasked with working in partnership with the Cabinet Office to lead a centralised process to identify government owned land that may be suitable for housing.

Properties are currently being reviewed and assessed for development potential for housing with the first tranche due to be submitted for Government approval by the end of 2023. At this stage, no decisions have been made around the use of specific NSW Government Properties for housing as part of the audit.

- \* 1322 COOTAMUNDRA POLICE FUNDING—Ms Steph Cooke to ask the Minister for Police and Counter-terrorism, and Minister for the Hunter—

With respect to adequate funding for police resources across the Cootamundra electorate:

- (1) What are the Government's plans for upgrading police stations in need of improvement in the Cootamundra electorate?
- (2) What are the Government's plans for upgrading police residences in need of improvement in the Cootamundra electorate?
- (3) Can the Government provide a schedule for any upgrades or maintenance work planned for police stations and residences, over the next 12 months, in the Cootamundra electorate?

Answer—

- (1) The following projects are currently underway or at planning/proposal stage:
  - upgrade to garage facilities at Cootamundra Police Station is currently underway;
  - proposed refurbishment and external painting for Narrandera Police Station;
  - proposed CCTV upgrade for Junee Police Station; and
  - proposed anti-jump barrier at Stockinbingal Police Station.
- (2) This question should be referred to the Property and Development NSW, which is the agency responsible for police residence properties.
- (3) Police stations in the Cootamundra electorate will continue to receive planned preventative maintenance and reactive maintenance works as required.

- \* 1323 PAEDIATRICIANS IN REGIONAL NSW—Ms Steph Cooke to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

With respect to paediatricians within regional New South Wales:

- (1) How is the Government working with the Commonwealth Government to attract more paediatricians into the regional New South Wales workforce?
- (2) What is the Government actively doing to retain paediatricians in regional New South Wales?
- (3) What strategies does the Government have in place to reduce the extensive wait times families currently face to see a paediatrician, including those in my electorate?

Answer—

- (1 - 2) The NSW Government will also continue to work in collaboration with the Commonwealth Government on improving health outcomes for people living in regional NSW. NSW Health is focused on efforts to boost the health workforce across all parts of regional NSW through workforce incentive schemes and training programs.

In NSW, paediatric training is coordinated through three training networks that link rural, regional and metropolitan hospitals. This supports doctors working across a range of settings to complete training requirements and while having the opportunity to train in a rural and regional location.

- (3) NSW Health is [piloting a new model of care](#) for children with behavioural issues and/or Attention Deficit Hyperactivity Disorder (ADHD) in in Hunter New England and Western NSW LHDs. The trial builds on the recommendations of the Review of Health Services for Children, Young People

and Families within the NSW Health System (the Henry Review), which identifies the need for a new approach in the management of behavioural issues and ADHD.

NSW Health has a longstanding relationship with Royal Far West (RFW) to provide the Paediatric Development Program (PDP).

- \* 1324 FIRE AND RESCUE NSW—Ms Steph Cooke to ask the Minister for Customer Service and Digital Government, Minister for Emergency Services, and Minister for Youth Justice—

With respect to firefighters for Fire and Rescue New South Wales which are assigned to fire stations across the Cootamundra Electorate:

- (1) As at the date for which the most recent data is available, how many permanent fire fighters are assigned to each of the Fire and Rescue Stations across the Cootamundra electorate?
  - (a) Of these Stations, how many permanent firefighter positions are currently vacant?
- (2) As at the date for which the most recent data is available, how many on-call fire fighters are assigned to each of the Fire and Rescue Stations across the Cootamundra electorate?
  - (a) Of these Stations how many on-call positions are currently vacant?
- (3) What is the Government doing to fill these both permanent and on-call vacancies?

Answer—

I am advised that:

- (1) Nil. All Fire and Rescue NSW (FRNSW) stations in the Cootamundra electorate are staffed by On-Call firefighters.
- (2) As at 7 September 2023, the on-call staffing and vacancies at FRNSW stations in the Cootamundra electorate are:

- (3) There are no permanent firefighter vacancies at FRNSW stations in the Cootamundra electorate.

On-call firefighter applications are accepted through the FRNSW website from all members of the community and are assessed on merit and physical aptitude.

FRNSW has also introduced the Sustainable On Call Firefighter Program to improve the recruitment and retention of on call firefighters and to increase inclusion.

The program aims to attract more on-call firefighters and improve working conditions to sustain long-term employment, through on-call to permanent career pathways, effective and efficient recruitment and station leadership and development.

- \* 1325 SCHOOL VENTILATION—Mr Matt Cross to ask the Deputy Premier, Minister for Education and Early Learning, Minister for Western Sydney, and Minister for Skills, TAFE and Tertiary Education—

In relation to ventilation in school learning spaces:

- (1) At what temperatures does a school qualify for heating, ventilation and air conditioning (HVAC) equipment?
- (2) Was the Department of Education allocated funds in the 2023-24 Budget for the installation of heating, ventilation and air conditioning (HVAC) equipment to improve ventilation in learning spaces?
- (3) Is there a strategy to continually monitor the more than 150,000 spaces across our more than 2,200 public schools in relation to windows, fans and ventilation systems?

Answer—

The NSW Department of Education continues to deliver air conditioning upgrades in NSW public schools. The Department will continue to work with schools to address their local needs. School Principals can nominate projects for additional air conditioning which are assessed statewide.

As part of funding for new schools, major upgrades, redevelopments and relocated schools, air conditioning will also be installed in permanent learning spaces and libraries.

NSW public schools use a mix of natural ventilation and fresh air ventilation systems, with decisions on permanent fresh air ventilation systems made on a case-by-case basis.

The Department of Education regularly inspects NSW public schools to assess the condition of facilities and carries out proactive maintenance to ensure schools remain safe and compliant. The department's maintenance program and other works, including air conditioning upgrades, are assessed in consultation with schools. In addition to this, school principals can raise maintenance requests with their local Asset Services Officer at any time.

- \* 1326 SUPPORTING OUR VETERANS—Mr Matt Cross to ask the Minister for Customer Service and Digital Government, Minister for Emergency Services, and Minister for Youth Justice—

In relation to supporting our Veterans:

- (1) Is Service NSW automatically validating Commonwealth Department of Veteran Affairs (OVA) file numbers for veterans and eligible concession holder customers when accessing services?
- (2) Can you advise whether New South Wales veterans and eligible concession holder customers will no longer need to provide evidence of eligibility, OVA Gold Card or a letter each year when accessing services?

Answer—

I am advised:

- (1) New and existing Commonwealth Department of Veterans Affairs (DVA) customers can establish their concession by providing their DVA file number to Service NSW over the phone for instant validation, resulting in concessions being automatically applied to licence and registration transactions.
- (2) Provided the veteran or eligible concession holder has their DVA file number recorded for vehicle registration transactions, they no longer need to provide evidence of eligibility each year and their registration will be automatically renewed after required vehicle checks. For other transactions, customers will still need to present their DVA eligibility.

\* 1327 KILLARA INTERSECTION—Mr Matt Cross to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—

In relation to pedestrian safety at the intersection of the Pacific Highway and Lorne Avenue in Killara:

- (1) When will the feasibility study commence?
- (2) When will the feasibility study be completed?

Answer—

I am advised

Transport for NSW has already commenced a feasibility review for improving pedestrian facilities at this intersection, which has several complex utility and access constraints. Transport for NSW will seek future funding for potential improvements if the review deems it feasible. The feasibility study is due to be completed by the end of February 2024.

Funding allocations are prioritised on a state-wide basis. The priorities are determined on strict criteria which include reported crashes, road geometry and the safety benefits returned to the community.

\* 1328 SMALL BUSINESS ADJUSTMENT PREMIUMS—Mr Matt Cross to ask the Minister for Industrial Relations, and Minister for Work Health and Safety—

In relation to small businesses, what is the median and/or average "hindsight adjustment premium" notice amount broken down by financial year from iCare?

Answer—

At the station where the planned outage will occur, there is signage displayed in the lead up to the event to notify customers.

Under the ALRA, the Minister for Crown Lands is responsible for the investigation, assessment, and determination of Aboriginal land claims. The rate at which Aboriginal land claims are determined varies depending on the land tenure and occupation of the Crown Land Parcel.

The Department of Planning and Environment supports the Minister for Crown Lands to investigate, assess, and determine Aboriginal land claims. Through the investigation process, the Department of Planning and Environment undertakes significant consultation with stakeholders, including Local Aboriginal Land Councils.

Crown Lands have been working with Local Aboriginal Land Councils to identify priority Aboriginal land claims for streamlined determination.

Answer—

I am advised:

- (1) Acting magistrates are offered the same training programs as fulltime magistrates. Educational activities relating to domestic violence include presentation of papers, and workshops covering domestic violence, sexual assault and sentencing in domestic violence matters is an ongoing priority. Judicial education programs are also recorded and available on Judicial Information Research System (JIRS), the Judicial Commission's comprehensive database of legal information for judicial officers.
- (2) All magistrates receive ongoing training in the understanding of family and domestic violence, its impact on victims and children, and good practice in its management by the court, including judicial commentary. Maintaining awareness by magistrates and acting magistrates of ongoing and significant developments in domestic violence policy and service responses in NSW is of high priority.

All Magistrates, including those Acting are also provided with regular education in domestic violence through updates to Bench Books. These are available on JIRS, the Judicial Commission's

Additionally, the Judicial Commission, in accordance with its charter, produces reports aimed at specifically informing judicial officers about developments in sentencing law and approaches in the court relating to domestic violence.

A major issue in courts dealing with domestic violence is the high levels of trauma. To assist judicial officers implement more trauma informed practices, the Judicial Commission has developed a number of resources including a new publication "Trauma-informed courts: guidance for trauma-informed judicial practices" available at <https://www.judcom.nsw.gov.au/trauma-informed-courts-guidance-for-trauma-informed-judicial-practices/>

A monthly Judicial Officers Bulletin also showcases articles on domestic violence.

(3 - 4) Judicial education is not mandatory for judges or magistrates.

However, the National Judicial College of Australia has developed a national standard for the amount of time that should be available for each member of the Australian judiciary for professional development. The standard is that each judicial officer should be able to spend at least 5 days each calendar year participating in professional development activities relating to the judicial officer's responsibilities. This has been endorsed by the Council of Chief Justices of Australia, chief judges, chief magistrates and judicial education bodies throughout Australia. Participation rates in Judicial Commission programs are very high.

Answer—

The wellbeing of students and staff at all NSW public schools is a key priority for the Minns Government.

Wherever hazardous materials are suspected or found in NSW public schools, the Department shares that information with school communities and immediately acts to protect students and staff, including isolating the area and engaging experts to investigate and remediate the site to SafeWork NSW standards where required.

There is a current investigation by SafeWork NSW into historic asbestos management practices at Castle Hill High School. It is appropriate that this investigation continues, and that the Department continues to cooperate.

The Department advises that all asbestos remediation in NSW public schools is completed by licensed and accredited contractors and monitored by independent occupational hygienists. These independent hygienists issue clearance certificates on the condition that the work complies with the relevant safety standards, legislation and regulations, allowing the building or area to return to normal use.

The Department also conducts asbestos resurvey inspections in NSW public schools which identify areas of possible future risk and enable the appropriate mitigations to be put in place.

In relation to the information issued to parents and carers in late August and early September 2023, I am advised by the Department that powder, which was suspected to be hazardous material, was found in a locked science block storeroom at Castle Hill High School. On the same day, an occupational hygienist attended the school and removed the material to undertake testing, which subsequently found no asbestos material was present. In removing the material, a small sealed container was identified which was suspected to have been a historical artefact used to support science experiments in the past. As a precaution, the storeroom was completely sealed until further testing could be carried out. Experts attended the school site to remove the material safely, and subsequent testing confirmed that no radiological material was present in the small sealed container found in the room, and that there was no radiological hazard to staff or students. The Department has advised that students and staff were informed in writing at the earliest opportunity, principally via works notifications and emails.
