(1) In March this year, approval was given to upgrade the Mendooran to Dunedoo school bus service to a category 4 bus in order to accommodate the growing number of students using the service, can the Minister provide an update on when the category 4 bus will be made available to this community?

The Mendooran to Dunedoo school bus service is currently delivered on a category 2 bus.

A change to a larger capacity category 4 bus has been approved on the basis of increased student numbers anticipated in 2024. Transport for NSW has been working closely with the Operator of this service and the bus manufacturer regarding the build spot, delivery of the new bus and interim measures.

- (1) The NSW Government is committed to job growth in Western Sydney and across the State, including our proposal to establish a NSW Jobs First Commission, rebuild domestic manufacturing, fund an additional 500 paramedics, recruit an additional 1,200 nurses and midwives, hire 1,000 additional apprentices and invest \$22 million in the early childhood workforce.

Answer-

(1) (a)

Youth unemployment and under-employment is a cross-portfolio consideration of the NSW Government, and as such there are several government agencies with a role to play when responding to the needs of young people.

There are several established initiatives within the Department of Communities and Justice (DCJ) that are helping young people across NSW:

- Targeted Early Intervention (TEI) program In South Western Sydney (SWS), the 'Facilitate Employment Pathways' stream has a funding commitment of \$5,647,901 (excluding GST) for financial year 2023/24
- Opportunity Pathways Social Impact Investment (OP-SIi) Program -this program, from July 2022 to June 2025 is delivering the OP-SIi program in SWS in partnership with Community Housing Provider Evolve Housing (Evolve) and the Commonwealth government. The NSW Government will fund Evolve Housing up to \$3,336,200 (excluding GST) to deliver the program in SWS.
- Youth Frontiers Each program location is provided with \$500,000 for financial year 2023/24.

Youth-led initiatives - this includes projects funded under the Youth Opportunities Program where young people can lead and drive their own projects that respond to their own needs while addressing an issue of importance to them.

Monitoring for Program Outcomes:

- Initiatives such as TEI and Youth Frontiers are monitored through regular contact meetings and review of data entered by the Service providers into the Data Exchange (DEX) system.
- The OP-SII (Evolve) is monitored through quarterly reporting and weekly updates on client referral numbers, education outcome and employment numbers. DCJ also holds monthly progress meetings with Evolve, and both work closely together.
- Projects supported under the Youth Opportunities Program are monitored through contact meetings, progress and completion reporting, and an online survey tool.

The NSW Government is committed to investing \$1.3 billion for the New Bankstown Hospital.

The services listed are part of the planning scope for the New Bankstown Hospital project. The scope of services will be confirmed when consultation recommences following a site announcement.

The New Bankstown Hospital project team has consulted extensively with staff and consumer representatives about the scope and location of the project. Broad consultation will resume with hospital staff and the local community following a decision on the site.

The site selection process is underway and an announcement will be made in due course.

- \* 1364 SYDNEY STARTUP HUB—Mr Mark Coure to ask the Minister for Better Regulation and Fair Trading, Minister for Industry and Trade, Minister for Innovation, Science and Technology, Minister for Building, and Minister for Corrections—

#### \* 1365 INDEPENDENT COMMISSION AGAINST CORRUPTION MINISTERIAL CODE OF CONDUCT— Mr Matt Cross to ask the Premier—

In relation to the Independent Commission Against Corruption Amendment (Ministerial Code of Conduct) Regulation 2014, in relation to Part 4 Gifts and hospitality:

- (1) Have all Ministers and Parliamentary Secretaries fulfilled their obligations?
  - (a) If not, what action(s) have you taken?

Answer—

I am advised that the NSW Ministerial Code of Conduct (Ministerial Code) is contained in an appendix to the Independent Commission Against Corruption Regulation 2017.

Ministers and Parliamentary Secretaries are required to declare to the Secretary of The Cabinet Office certain gifts and hospitality with a market value of more than \$500 under Part 4 of the Schedule to the Ministerial Code. This is a continuous obligation for which Ministers and Parliamentary Secretaries are personally responsible.

Disclosures are kept on the Ministerial Register of Gifts maintained by The Cabinet Office on behalf of the Premier.

All Ministers and Parliamentary Secretaries are required to comply with the Ministerial Code and I expect them to do so.

- \* 1366 STRATEGIC INFRASTRUCTURE REVIEW AMBULANCE STATIONS—Mr Adam Crouch to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—
  - (1) Can the Minister please advise a commencement date for the Strategic Infrastructure Review which affects the delivery of ambulance stations at Kincumber, Lisarow and Berkely Vale on the Central Coast and timeline for its completion?
  - (2) Can the Minister provide certainty to the Central Coast that the proposed ambulance stations funded under the NSW Ambulance Infrastructure Program which are scheduled to be complete and ready for operations from mid-2025 through to 2027 will be delivered on budget and on time?

Questions about the Strategic Infrastructure Review are a matter for the Treasurer.

Health Infrastructure is working with NSW Ambulance and other key stakeholders within government to identify potential sites for the new ambulance stations and prioritise delivery of the new stations. Construction timeframes for new Ambulance stations will be confirmed once the lands earch and acquisition process is finalised.

\* 1367 BOATING NOW FUNDING—Mr Adam Crouch to ask the Minister for Transport—

(1) Will the Minister confirm if the Government will continue to support boating infrastructure and amenity improvements by continuing the NSW Boating Now Program and if so, how much will be committed in this year's Budget?

The Government has announced it will undertake a review of the Boating Now program, which is currently underway. The applications for grants in the unfunded Round 4 of Boating Now will be considered post completion of the review.

Answer-

The Local Small Commitments Allocation has been designed to evenly spread funding across all 93 Legislative Assembly electorates.

It has been designed to prevent pork barrelling and ensure that all electorates receive the exact same amount of funding.

The election commitment ensured \$400,000 went to every electorate in NSW regardless of political allegiance; whether or not a Labor candidate won the seat.

The NSW Government will put every single project through a rigorous assessment process including by an expert independent assessment panel.

Independent probity advisors have been appointed to advise on the management of conflicts of interest and provide probity advice.

The Local Small Commitments Allocation (LSCA) Program Guidelines outline how the grant program will be administered.

- \* 1369 VICTORIA ROAD DRUMMOYNE—Ms Stephanie Di Pasqua to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—
  - (1) Are there plans to address road safety issues along Victoria Road in Drummoyne?
    - (a) If so, what is the timeframe?

- (3) Are there plans to improve public amenity along Victoria Road in Drummoyne?
  - (a) If so, what is the timeframe?
- (5) Is Transport for NSW looking to extend clearways along Victoria Road in Drummoyne?

I am advised

The NSW Government has a vision to improve the liveability of Victoria Road, to provide better access to different modes of transport and support local economies. In March 2023, potential short, medium and long-term options were announced, to enhance public transport, to support growth on Victoria Road and the corridor's urban transformation.

Over time and in partnership with local government and industry, Transport for NSW will also investigate opportunities to improve cycling and pedestrian facilities including upgrades to footpaths for better pedestrian experience, with greening to activate more enjoyable public spaces for the local community. The community, local Government and industry will be kept informed as these options progress.

Transport for NSW completed an upgrade to the traffic signals at the intersection of Victoria Road and Lyons Road at Drummoyne. This upgrade is expected to improve safety for both motorists and pedestrian and improve bus priority in the morning peak periods for citybound services.

Decisions on Clearway extensions require careful consideration by balancing local community needs against overall transport corridor operation. Transport for NSW will continue to monitor operation of the corridor and initiate projects when required, with community consultation being undertaken where and when appropriate.

- \* 1370 IRON COVE LINK TRAFFIC MODELLING FOR DRUMMOYNE—Ms Stephanie Di Pasqua to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—
  - (1) Is traffic modelling available for Drummoyne (including at Victoria Road) for the opening of the Iron Cove Link Tunnels.
  - (2) What traffic mitigation strategies has Transport for NSW developed and implemented to prevent rat running in Drummoyne, particularly following the opening of the tunnel?

Answer—

#### I am advised

Transport for NSW has undertaken traffic modelling along Victoria Road as part of the Road Network Performance Plan (Rozelle Interchange Project Condition of Approval E63). The Plan includes assessments of impacts at several intersections in Drummoyne, including the Victoria Road and Lyons Road intersection, and considers impacts on local roads expected from the opening of Rozelle Interchange.

Following consultation with Inner West, City of Sydney, Bayside and Canada Bay Councils and finalisation of the Plan, it will be submitted to the Department of Planning and Environment and be made publicly available.

Transport for NSW will assess the network after the opening of Rozelle Interchange and determine if further impacts have occurred on the network including on local roads, propose mitigation measures to identified impacts and assess the adequacy of mitigations implemented as part of the pre-opening Plan (Condition of Approval E63).

- \* 1371 COMMUNITY BUILDING PARTNERSHIP 2023—Ms Stephanie Di Pasqua to ask the Premier—

\* 1372 INTERSECTION OF LYON AND VICTORIA ROADS DRUMMOYNE—Ms Stephanie Di Pasqua to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—

(1) Are there plans to improve pedestrian and vehicle safety at the intersection of Lyons and Victoria Roads in Drummoyne?

Answer—

I am advised

The NSW Government has a vision to improve the liveability of Victoria Road, to provide better access to different modes of transport, and support local economies. Transport for NSW will keep the community, local government and industry informed as short, medium, and long-term options progress.

Transport for NSW completed an upgrade to traffic signals at the Victoria Road intersection with Lyons Road, Drummoyne. This upgrade is expected to improve both motorists and pedestrian safety, and improve bus priority in the morning peak periods for citybound bus services accessing Victoria Road from Lyons Road.

- \* 1374 CONCORD AMBULANCE STATION—Ms Stephanie Di Pasqua to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—
  - (1) Is the Concord Ambulance Station located at Concord Hospital is operating at full capacity?
  - (2) Are staff being redeployed away from the station?

Answer—

I'm advised:

Concord Ambulance Station has sufficient staff to maintain rosters.

The paramedic workforce is mobile. They regularly respond from one patient to the next, whether they are located at a hospital, an ambulance station, or another location.

Vehicles and paramedic crews are moved throughout shifts to provide coverage of ambulance resources across NSW.

During periods of higher demand NSW Ambulance can deploy resources to where they are needed most, helping deliver the best possible out-of-hospital care for the community.

\* 1375 DRUMMOYNE AMBULANCE STATION—Ms Stephanie Di Pasqua to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

(1) Will there be a reduction in services and staff working out of Drummoyne Ambulance Station once the Glebe station opens?

Answer-

I am advised:

There will be no reduction in services and staff working out of Drummoyne Ambulance Station once the Central Sydney Ambulance Station opens.

\* 1376 CONCORD HIGH SCHOOL BUSINESS CASE—Ms Stephanie Di Pasqua to ask the Minister for Planning and Public Spaces representing the Treasurer—

The Business case for the Concord High School upgrade is currently before New South Wales Treasury.

- (1) Does the Government plan to approve the business case?
- (2) If so, when will it be approved?

#### Answer-

- \* 1377 ABORIGINAL LAND RIGHTS ACT—Mr Alex Greenwich to ask the Minister for Aboriginal Affairs and Treaty, Minister for Gaming and Racing, Minister for Veterans, Minister for Medical Research, and Minister for the Central Coast—
  - (1) What steps have been taken to implement the recommendations of the 2021 review of the Aboriginal Land Rights Act?
  - (2) What changes are being considered to address the review consultation feedback about membership and administration problems?
  - (3) What changes are being considered to ensure that appropriate people can be members of Local Aboriginal Land Councils and be elected to their boards?
  - (4) When does the Government intend to release reform proposals for public comment?

Answer-

(1) Section 252A of the Aboriginal Land Rights Act 1983 (ALRA) requires the Minister for Aboriginal Affairs and Treaty to review the ALRA every five years. The statutory review was most recently conducted and completed in 2021. The final report was tabled in the NSW Parliament on 26 November 2021.

The ALRA Statutory Review final report recommended three stages of amendments to the ALRA. In 2022, the NSW Government delivered the first stage of amendments to the ALRA.

Stage one reforms included a range of administrative and operational changes to better existing structures and provisions to improve the administration of the ALRA and Local Aboriginal Land Councils. Stage two reforms were identified as part of the Statutory Review final report, which centre on sec 42 of the ALRA, to have a greater functionality between land rights and native title rights.

The more contentious provisions originally intended to be included in stage one have been deferred for further consultation with the NSW Aboriginal Land Council.

These provisions relate to the management of Local Aboriginal Land Council membership rolls and increasing the disciplinary powers of the Registrar of the ALRA. These complex matters are sensitive and are the most concerning for the Local Aboriginal Land Council network. It is entirely appropriate that more time is allowed to collaboratively consider these provisions.

The Aboriginal Land Rights Amendment Bill 2022 was assented to on 25 November 2022. To date Schedule 2.1 [15]-[19] and [26] have not commenced.

(2) In 2022, the former Coalition Minister for Aboriginal Affairs approved ongoing consultation with key stakeholders including the NSW Aboriginal Land Council and the Registrar of the ALRA to progress the further legislative drafting required in relation to centralising the membership rolls of Local Aboriginal Land Councils.

The Registrar of the ALRA recommended several reforms to the membership provisions including the centralisation of the membership roll and other administrative changes and clarifications.

This however was not contained within the Aboriginal Land Rights Amendment Bill 2022 and carried over and will be dealt with after the stage two ALRA reforms have progressed.

- (3) The stage one reforms also included amendments to the disqualifications provision relating to officers. The provisions were amended to disqualify officers for convictions of offences punishable by imprisonment for five years or more equivalent to the provisions in the Local Government Act 1993. It was previously convictions of offences punishable by imprisonment of 12 months or more.
- (4) NSW Government is currently progressing stage two reforms in consultation with NSW Aboriginal Land Council, Native Title Services Corporation, and the local land council network. The NSW Government is proposing to undertake public consultation in the next 12 months with the lands rights and native title networks across NSW on possible amendments to see 42 of the ALRA.
- \* 1378 ABORIGINAL LANGUAGES—Mr Alex Greenwich to ask the Minister for Aboriginal Affairs and Treaty, Minister for Gaming and Racing, Minister for Veterans, Minister for Medical Research, and Minister for the Central Coast—
  - (1) What funds have been allocated under the \$138 million Aboriginal Languages Strategic Plan?
  - (2) What grants were allocated that cover the inner city or Sydney electorate?
  - (3) How does the Government ensure that grants are allocated equitably across all communities?

Answer—

- (1) What funds have been allocated under the \$138 million Aboriginal Languages Strategic Plan?
  - The \$138 million over ten years funding commitment in the 2022 budget provides for the implementation of the Aboriginal Languages Act and supports the delivery of the Aboriginal Languages Trust's inaugural five-year 2022-2027 Strategic Plan, which is based on significant community consultation.
  - To date the Aboriginal Languages Trust has received \$17.6 million in budget funding which includes \$9.9 million for 2023-24 and \$7.7 million in 2022-23.
  - A further \$4.3 million recurrent funding, along with \$0.2 million capital expenditure, from 2022 to 2026 has been committed to the Trust in the 2022 budget for a specific Closing the Gap Target 16 initiative to support increased Aboriginal Community access to the NSW State Archives.
- (2) What grants were allocated that cover the inner city or Sydney electorate?
  - Since the Aboriginal Languages Trust was formed in March 2020, over \$6.5 million

(\$6,509,399) has been awarded in grants to 77 Aboriginal Community organisations, groups, and individuals to review, grow and nurture languages across NSW.

- The inner city and the Sydney electorate have received ten per cent or \$664,768 of this grant funding, including:
  - \$204,788 to the Gujaga (Goo-JAH-guh) Foundation in Randwick City Council since 2020 to deliver training to employment package to upskill local Aboriginal Community members to enable them to be employed as Dharawal (DUH-ruh-wul) language and culture tutors and contribute to the revival and teaching of Dharawal (DUH-ruh-wul) language within community. This funding also includes \$5,000 to produce a Dharawal (DUH-ruh-wul) language activity week book as part of this year's inaugural NSW Aboriginal Languages Week.
  - \$160,000 to Mooghalin (Moo-GAH-lin) Performing Arts since 2020, whose office is located in Redfern in inner Sydney, but the funded project was with local women from different languages groups across Brewarrina Local Government Area. Moohgalin

Performing Arts collaborated with these women to gather stories, language, and act as cultural guides to create 21 new dances incorporating Murruwarri (Moo-roo-wuh-REE), Ngemba (Nee-yem-PUH) and Yuwaalaraay (Yoo-wah-lah-RAI) languages.

- \$125,000 to the Coota Girls Aboriginal Corporation since 2020, whose office is located in Haymarket in inner Sydney, but their work benefits Aboriginal people across the State. Projects have sought to promote healing through strengthening connections to language and culture for survivors of the Stolen Generations and their descendants including the Walking Our Songlines with Language online project.
- \$99,980 to Colly Gamilaraay Indigenous Corporation since 2020, whose office is located in Glebe in inner Sydney, but the project aimed to preserve and revive the Gamilaraay (Gah-mil-lah-RAI) / Yuwaalaraay (Yoo-wah-lah-RAI) / Yuwaaliyaay (Yoo-wuh-lah-YAI) / Northern Gamilaraay (Gah-mil-lah-RAI) languages of Gallarinbaraay (Gah-luh-rin-buh-RAI) by connecting to country, recording, and transcribing stories about cultural history and ecological stewardship and provide access to language resources. These language groups encompass a large section of the state from Singleton in the Hunter Valley through to the Warrumbungle Mountains in the west and stretching up to the Queensland border.
- \$75,000 to Kinchela Boys Home Aboriginal Corporation in 2023, whose office is located in Waterloo in inner Sydney, but their work benefits Aboriginal people across the State. Projects have been designed to assist boys who are now men and their families to reconnect to their traditional languages from all nations across NSW. Their most current project is Healing with Language.
- (3) How does the Government ensure that grants are allocated equitably across all communities?
  - The Aboriginal Languages Trust offers a range of grant programs open to eligible NSW Aboriginal not for profit community organisations and groups, and Aboriginal sole traders, consistent with the Aboriginal Languages Act 2017 (NSW).
  - There are currently five grant programs administered by the Aboriginal Languages Trust. The different funding streams are designed to help ensure funds are administered equitably and fairly across communities in NSW.
  - Grant programs are promoted to Aboriginal communities through various means including the Aboriginal Languages Trust's social media channels, direct emails to the Trust's stakeholder database and also at times paid advertising in appropriate publications like the Koori Mail.
  - To ensure equity and non-biased assessment and approval, disclosed or perceived conflicts of interest are considered and managed as part of the grants process. Conflicts of interest documentation, including a Register, is kept for grant assessments. When a conflict of interest is identified, the affected assessor or approver is removed from the process. If the Executive Director of the Aboriginal Languages Trust has any conflicts of interest, the approval is escalated to the Deputy Secretary of Aboriginal Affairs NSW.
  - A Program assessment team reviews all applications and check these against the Grant Guidelines. They look to confirm:
    - that the organisation or group is eligible;
    - that the project meets program aims and objectives;
    - the potential impact of the project based on who will benefit from the project and how this will be achieved;
    - the organisation's or group's capacity to manage the project, based on previous projects managed and key staff involved;

- the value for money based on the detail included in the project budget and if it reasonable and realistic;
- an equitable geographical distribution of funds and project diversity.
- An assessment panel of three to four people is formed including:
  - o an Aboriginal Languages Trust staff member;
  - o an independent (non-Trust) public servant with relevant expertise;
  - one or two Aboriginal Community members/language champions. A language champion is an Aboriginal person that has worked on the revival of Aboriginal languages within their community and is recognised by their community as a language champion.
- \* 1379 MOTORWAY LAND EAST SYDNEY—Mr Alex Greenwich to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—
  - (1) What action has been taken to remove long-vacant Cross City Tunnel and Eastern Distributor land at 110-130 William Street and Egan Place Woolloomooloo to allow Transport for NSW land to be used for community benefit, as indicated in the response to LA Q 8867 answered 16 November 2022?
  - (2) What plans have been investigated for this land and what use does the Government propose?
  - (3) What action has been taken about reuse of long-vacant motorway land in Palmer Street Darlinghurst associated with the Eastern Distributor?
  - (4) What plans have been investigated for this land and what use does the Government propose?
  - (5) Has the Government considered these sites for low cost housing, green open space, recreation/play facilities, outdoor exercise or homelessness services?
  - (6) When does the Government plan to begin community consultation on uses for these sites?

I am advised

Transport for NSW continually reviews opportunities to make underutilised or surplus land available to be repurposed, so that it may contribute to a lively and liveable city.

Transport for NSW is exploring options for the land at William St, Woolloomooloo.

The community and stakeholders will be consulted on any opportunities to transform sites at the appropriate time through the normal planning assessment processes.

Transport for NSW manages the security of the sites, including the painting over of graffiti when required.

I am open to future submissions from your local community on the matter.

\* 1381 OFFICIAL COMMUNITY VISITORS SCHEME—Mr Alex Greenwich to ask the Minister for Families and Communities, and Minister for Disability Inclusion—

Regarding the Official Community Visitors Scheme

(1) How many Offical Community Visitors (OCVs) are currently employed in New South Wales?

- (2) How many are employed OCVs are budgeted for?
- (3) How many visitable services are operating across the state?
- (4) How many of these visitable services had an OCV visit in:
  - (a) 2022?
  - (b) 2021?
  - (c) 2020?
- (5) How many of these visitable services that had an OCV visit in each year had a follow-up visit within 12 months of the initial visit?
- (6) Of the visitable services that had an OCV visit, how many resulted in a conduct report or advice provided to the minister, the Ageing and Disability Commissioner, the NSW Ombudsman or the Office of the Children's Guardian?
- (7) Of the visitable services that were subject to a conduct report or advice, how many received a follow-up visit within six months of the initial report?
- (8) What plans are there to expand the OCV scheme to ensure all visitable services receive regular visits?

Answer—

I am advised:

- (1) On 29 September 2023, there were 36 active visitors.
- (2) Based on an average allocation and number of visits, the recurrent budget for the OCV scheme can support 25 visitors. The higher number of visitors currently employed is possible due to additional funding provisions to account for increased demand and other staffing pressures.
- (3) On 29 September 2023, there were 3,050 visitable services in NSW registered in the OCV scheme database.
- (4) The OCV scheme reports its data by financial year.
  - In 2022/23, there were 2,856 visitable services registered in the OCV scheme database. Of these, 1,305 services (46 per cent) were allocated for visiting in that financial year.
  - In 2021/22, there were 2,394 visitable services registered in the OCV scheme database. Of these, 1,180 services (49 per cent) were allocated for visiting in that financial year.
  - In 2020/21, there were 2,285 visitable services registered in the OCV scheme database. Of these, 1,281 services (56 per cent) were allocated for visiting in that financial year.
  - In 2019/20, there were 2,160 visitable services registered in the OCV scheme database. Of these, 1,401 services (65 per cent) were allocated for visiting in that financial year.
- (5) The OCV scheme has a legacy database that does not currently enable the ADC to run a report to extract the requested data.

Allocated visitable services are visited at least twice in a financial year:

- allocated disability accommodation services receive two visits in a year
- allocated assisted boarding houses receive four visits in a year
- allocated residential out-of-home care services receive four visits in a year.

Not all services are able to be allocated each year. The decisions of the ADC about which services to allocate for visiting are based on several key factors, including whether there are significant issues

or concerns about the service, availability of visitors in a geographical area; and the length of time since the service was visited.

- (6) OCVs regularly discuss concerns and provide advice to the ADC about issues arising from their visits, including about the conduct of visitable services or welfare of residents.
  - In 2022/23, OCVs formally referred 21 matters of concern to the ADC, the NSW Ombudsman or the OCG.
  - In 2021/22, OCVs formally referred 7 matters of concern to the ADC, the NSW Ombudsman or the OCG.
  - In 2020/21, OCVs formally referred 10 matters of concern to the NSW Ombudsman or the OCG.
  - In 2019/20, OCVs formally referred 24 matters of concern to the NSW Ombudsman or the OCG.
- (7) The OCV scheme has a legacy database that does not currently enable the ADC to run a report to extract the requested data.

The ADC typically continues to allocate services in which OCVs have formally referred matters of concern in the preceding year. This can be impacted by changes in the availability of visitors, who may be inactive for periods due to illness or caring responsibilities.

(8) The OCV scheme seeks to allocate as many visitable services as possible across NSW within its allocated budget.

Additionally, in 2022/23 the OCV scheme undertook a trial of 100 one-off visits to increase the number of visits with the existing visitor pool, focusing on services that had never been visited or had not been visited for some time. These were in addition to the services allocated for regular visiting.

- \* 1382 REGISTERED BOARDING HOUSES PLANNING—Mr Alex Greenwich to ask the Minister for Planning and Public Spaces—
  - (1) What data does the Government have about the number of registered boarding houses in Sydney and in inner Sydney over the past 10 years?
  - (2) What assessment has the Government made of the rapidly decreasing number of boarding houses providing low cost accommodation?
  - (3) Has the Government considered blanket measures to prevent change of use approvals to convert boarding houses to other use:
    - (a) temporarily during times of high housing stress?
    - (b) permanently?
  - (4) What measures will the Government use to prevent change of use of existing boarding houses and consequent loss of low cost accommodation?
  - (5) What changes have been made to the Housing State Environmental Planning Policy to facilitate low cost housing like boarding houses?
  - (6) What plans does the Government have to ensure this low cost type of accommodation remains an option, including in the inner city?

Answer—

I am advised:

(1) The Boarding Houses Act 2012 (BH Act) established a public register of boarding houses and provides for compliance and enforcement of certain standards for registered boarding houses.

A list of registered boarding houses can be found on the NSW Fair Trading website at

https://applications.fairtrading.nsw.gov.au/accomregister/AccommodationSearch.aspx .

- (2) The State Environmental Planning Policy (Housing) 2021 (Housing SEPP) incentivises the development of new boarding houses and establishes appropriate standards for such development.
- (3) The planning system incentivises the development of boarding houses through the Housing SEPP, so that this important form of affordable rental housing is better able to compete with other permitted land uses.
- (4) The Housing SEPP requires a consent authority to consider whether a proposed development (change of use, alterations and additions or demolition) would result in the loss of existing lowrental dwelling, including low-rental boarding houses. Where a proposed development would result in the loss of existing low-rental dwellings, the consent authority can levy a contribution when issuing development consent. These requirements are set out in Chapter 2, Part 3 of the Housing SEPP. The contributions are either used by the council for affordable housing projects, or forwarded to Department of Communities and Justice. More information about this process is available on the Department's website at <u>https://www.planning.nsw.gov.au/policy-and-legislation/housing/housingsepp/retention-of-existing-affordable-housing</u>
- (5) When the Housing SEPP was made it introduced new requirements to require boarding houses to be managed by registered community housing providers for the purpose of affordable housing in perpetuity.

In December 2022, the Department exhibited amendments to expand boarding house permissibility in regional areas and extend the application of the floor space bonuses. Proposed amendments include the following.

- In areas outside Greater Sydney, boarding houses are only permitted on R2 Low Density Residential land within 400 metres walking distance of zones B2 Local Centre or B4 Mixed Use. It is proposed to expand the list of nearby zones to include B1 Neighbourhood Centre and increase the distance to 800 metres.
- Currently, boarding houses delivered on land where residential flat buildings are permitted attract a 25 per cent floor space ratio (FSR) bonus. It is proposed to extend FSR bonus to boarding houses delivered on land where shop-top housing is permitted.
- (6) In June 2023 the Government announced a range of planning system changes to encourage private sector investment in more social, affordable and market housing across NSW.
- \* 1383 SYDNEY FOOTBALL STADIUM SECONDARY CARPARK EGRESS—Mr Alex Greenwich to ask the Minister for Small Business, Minister for Lands and Property, Minister for Multiculturalism, and Minister for Sport—
  - (1) What is the rationale for removing the University of Technology Sydney campus entrance on Moore Park Road to provide for a secondary carpark egress?
  - (2) Why is egress on Moore Park Road in addition to the Driver Avenue egress needed?
  - (3) Did the Government prepare a business case for this proposal?
  - (4) How is this consistent with the Government's policy to support active transport?
  - (5) How is this consistent with the Green Travel Plan for Moore Park?
  - (6) How will the Government prevent conflict with pedestrians and bike riders on Moore Park Road?

I am advised that:

- (1) The secondary egress from the new 1500-space multilevel carpark will reinstate the former vehicle egress driveway to Moore Park Road that was in use from 1988 to 2016. The secondary egress supports the efficient distribution of traffic across the road network, ensuring all traffic movements are not concentrated to Driver Avenue and reducing post-event congestion on surrounding roads.
- (2) Best practice with respect to major car parking areas is to provide for a point of access to the external road network for every 500-750 parking spaces. The two access points serving the future multilevel carpark onto the external road network aligns with this guidance.
- (3) A business case was prepared for the Precinct Village and Multilevel Carpark.
- (4) Efforts to increase active transport recognise that there will always be some people who need to drive their car to attend events at the SCG Precinct. It is important that when they do, their egress is managed in a way to reduce post-event congestion on surrounding roads.
- (5) Allianz Stadium's open public domain, improved wayfinding, bicycle storage facilities, as well as integrated ticketing and improved public transport access, means patrons are no longer dependent on private vehicles to attend events at the SCG Precinct. However, the Green Travel Plan, like the Moore Park Master Plan 2040, recognises that there will always be some people who need to drive their car. It is important that when they do, their egress is managed in a way to reduce post-event congestion on surrounding roads.
- (6) Transport for NSW and the NSW Police Force oversee egress on Moore Park Road on match days, with priority always given to pedestrian safety. As such, during egress the Moore Park Bike Lane is closed to cyclists 30 minutes prior to the conclusion of an event and for one hour after an event finishes. This closure enables additional space to move large numbers of pedestrians from the front of the stadium and along the walking route to Central Station.

\* 1384 BICYCLE LOCKERS—Mr Alex Greenwich to ask the Minister for Transport—

- (1) What data does the Government have about bikes being stolen from bicycle lockers provided at railway stations?

I am advised

Transport for NSW offers a bike and ride option, providing free bike sheds or rented bike lockers to customers when planning to catch a train, bus or ferry. The Terms & Conditions of bike storage facilities and use is publicly available online (<u>https://bikelocker.transport.nsw.gov.au/</u>). Transport for NSW holds no liability for loss, theft or damage to bikes.

If there is a theft from a bike locker or bike shed, it is recommended to report to the NSW Police Force. In August 2023, the NSW Police Force recommended installing additional cameras at Penrith and Emu Plains due to high volume theft occurring from these areas.

I am advised that the Register of Boarding Houses maintained by NSW Fair Trading does not provide historical data on the number of boarding houses registered. The Boarding Houses Act 2012 provides that a resident is entitled to four weeks' written notice before the proprietor increases the occupancy fee.

Premises that are approved as a boarding house under the Housing SEPP are affordable housing that are managed by Community Housing Providers and subject to limits on the occupancy fee that can be charged. Questions on this issue and the supply of boarding houses should be referred to the Minister for Planning and Public Spaces.

Questions regarding land tax exemptions for land used as a boarding house in NSW should be referred to the Minister for Finance, Minister for Domestic Manufacturing and Government Procurement, and Minister for Natural Resources.

(3) The North Shore PAC continues to devise and implement strategies to address the issue of Break, Enter and Steal offences occurring throughout the Command, including in suburbs such as Northbridg.

Strategies include the delivery of crime prevention and target hardening information to community groups via on-site engagement sessions as well as through targeted letter box drop-offs at-risk localities. Property crime prevention information is regularly shared via the North Shore PAC Eyewatch page and with local media outlets.

The Command regularly conducts high visibility patrols of at-risk locations during times when offending is identified to most likely occur. Daily intelligence briefings are provided to all staff with up-to-date information on local incidents.

Strikeforce Sweetenham was established by North West Metropolitan Region to combat offenders involved in ongoing occurrences of Aggravated Break, Enter and Steal offences involving theft of luxury and high performance vehicles across the Sydney Metropolitan area. Officers attached to Strikeforce Sweetenham operate from North Sydney Police Station and deliver a dedicated response to this crime type with a focus on identifying offenders and putting them before the court.

The project's contractor analysed the proposed road and traffic changes and Transport for NSW is progressing the detailed design, including completing a review based on the recent community consultation.

(1) Can you clarify which Government Minister is responsible for Emergency Accommodation expenditure?

Answer—

Under the previous government, emergency accommodation expenditure was within the portfolio responsibilities of the Minister for Emergency Services and was managed by Resilience NSW which has since dissolved.

The original question specifically referenced funding in the years prior to the new Government.

From March 2023, emergency accommodation expenditure is managed by the Department of Communities and Justice and under the current government sits within my portfolio of responsibilities as the Minister for Housing.

The NSW Reconstruction Authority has access to historical expenditure data if required.

- \* 1411 KPI DEFAULTS AND SERVICE DEFAULTS—Mr Michael Regan to ask the Minister for Transport—

(1) The performance of Keolis Downer Northern Beaches has been below KPI target predominantly in two KPIs, being Cancelled and Incomplete Trips, largely due to the prevailing driver shortage, and also On Time Running performance, although this has been during a shorter period.

Transport for NSW continues to work with all operators to improve performance especially in the area of driver recruitment which is an industry wide shortage.

- (2) Contract payment amounts are commercial in confidence.
- (3) Keolis Downer Northern Beaches have performed below the target of KPI SD7, Cancelled and Incomplete Trips, due to the prevailing driver shortage. No Termination Event has occurred (as defined in clause 47.1 of the contract).
- (4) Clause 47.3 references the Termination for Convenience clause in the contract. This is a complex process both legally and operationally but does allow Transport for NSW to terminate the contract for convenience subject to the conditions of the contract.
- \* 1412 NORTHERN BEACHES BUS SERVICES ESTIMATED SAVINGS—Mr Michael Regan to ask the Minister for Transport—

- (1) The expected savings are to be delivered over the term of the 8 year contract. The savings achieved to date reflect that the contract is on track to meet the published anticipated savings. Details of the savings achieved in each contract year are commercial in confidence.
- (2) Any savings delivered are reprioritised to allow the continuation of existing bus growth services across the Greater Sydney operating regions.

\* 1413 BIKES ON BUSES—Ms Kobi Shetty to ask the Minister for Transport—

- (1) What restrictions are currently in place regarding travel with a bicycle on public trains, light rail, buses and ferries in New South Wales?
- (2) What plans do the Government and/or Transport for NSW have to consider or implement changes to policy concerning travel with a bicycle on public transport?
- (3) What was the outcome of the Bikes on Buses in the Bush trial conducted in Queanbeyan and Yass in 2021?

#### Answer—

I am advised

- (1) For the safety and comfort of passengers there are varying restrictions for traveling with a bicycle on public transport in Sydney. The main rules for each mode of public transport are as follows:
  - Sydney Light Rail: Bikes allowed when space permits.
  - Newcastle Light Rail: Only fold-up bikes allowed for safety.
  - Buses: Bikes not allowed; fold-up bikes may be allowed on Greater Sydney buses with a paying passenger if space is available.

- Ferries (Sydney, Manly Fast Ferry, Stockton Ferry): Bikes allowed, subject to safety and space; some ferries have special storage areas.
- Sydney Trains: Bicycles and surfboards allowed for free when space is available.
- NSW Train Link services: Bikes and large items like surfboards allowed with certain conditions, not included in luggage allowance.

Details are available on the Transport for NSW website (<u>https://transportnsw.info/travel-info/using-public-transport/travelling-with-bikes-surfboards</u>).

(2) NSW Train Link is reviewing its bike storage policy and working with stakeholders to enhance bicycle access, aiming to eliminate the need for boxing bikes on regional services. A trial on an XPT and regional coach service is set for early 2024.

The current regional and intercity train fleets have limited bike storage. Transport for NSW conducted research with passengers on various train lines to improve intercity train features. This input led to enhancements in bicycle storage areas, which will be included in the Mariyung Fleet entering service in 2024.

Efforts will continue to improve communication through customer platforms.

(3) A trial conducted from December 2021 to March 2022 on two commuter bus routes in Canberra (Queanbeyan and Yass) aimed to assess demand, usage frequency, motivations, and drivers of a bike-on-bus service.

The trial faced challenges including safety concerns, willingness of operators and authorities to accept risks, responsibilities for insecurely loaded bicycles, regulatory constraints, and operational limitations.

End-of-trial research showed strong support for the concept, with 94% of regular public transport users in Queanbeyan and Yass considering using a bike-on-bus service. Approximately 120 combined bike and bus trips were taken, with 144 triallists providing feedback.

Key findings from customer research revealed that regular public transport users, who commute for work, education, shopping, and recreation, had high bike ownership and would use a bike-on-bus service. They also expressed interest in secure bike racks at bus stops. The service would attract non-public transport users and offer increased convenience, accessibility, and flexibility.

(1) Yes, Transport for NSW has advocated for the Australian Government to increase the quantum of funding made available to local governments for basic road maintenance and repairs, as part of the recent review and reform processes. This position recognises the limited financial capacity of local governments to fund such capital works, coupled with greater challenges posed to road maintenance as a result of more frequent climate events in recent years, particularly in regional NSW.

Current Australian Government sub-programs, which focus on local road investment, include both the Local Roads and Community Infrastructure Program and the Roads to Recovery Program.

(2) Regardless of the funding source or support provided by the NSW Government, all councils in NSW are required to follow the Integrated Planning and Reporting framework to guide their planning and reporting activities, which allows councils to identify community infrastructure needs and advocate on behalf of the community to the NSW and the Australian Governments for support.

Under the 2023-24 Budget, a new Regional Emergency Road Repair Fund will deliver \$390 million directly into the hands of regional and rural councils for urgent road and pothole repairs, expanding the total fund for road repairs to \$670 million and in addition to the \$220 million currently allocated for Urban Councils.

TfNSW provides subsidies to Local Government via Block Maintenance Grants which take account of state government road standards.

TfNSW works with councils to develop nominations for projects under various funding programs, such as road safety.

- the median time from arrival at ED to leaving has improved from 4 hours and 21 minutes to 3 hours and 58 minutes a reduction of 23 minutes,
- the percentage of patients starting treatment on time in the ED has improved by 8.9 percentage points,

• triage category 2 and 3 patients waited less time to be seen by a doctor, with a median time to start treatment improvement of 5 minutes (down to 14 minutes) and 11 minutes

(down to 33 minutes) respectively, and

• the median time to transfer a patient's care from NSW Ambulance paramedics to ED staff has improved by 13 minutes, down from 34 minutes to 21 minutes.

ED workforce at Shoalhaven has also increased under the Minns Labor Government:
