- * 1793 AVALON AMBULANCE STATION—Mr Rory Amon to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

In 2022, the lease for the Avalon ambulance station was renewed for 10 years, until 2032. The lease has options to extend beyond 2032.

NSW Ambulance will continue to monitor demand and service planning data in the Avalon area to inform future decisions about service delivery.

* 1794 PITTWATER RAOD AND WAKEHURST PARKWAY INTERSECTION—Mr Rory Amon to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—

There are no current plans or committed funding allocated for Transport for NSW to upgrade the intersection of Pittwater Road and Wakehurst Parkway in North Narrabeen.

The intersection was investigated when developing the scope for the Wakehurst Parkway - Frenchs Forest to Narrabeen Improvements Project. The location did not form part of the sites prioritised as part of this project,

- * 1795 KEORIDE ON DEMAND TRANSPORT SERVICES ON THE NORTHERN BEACHES—Mr Rory Amon to ask the Minister for Transport—

The expiration date of the Greater Sydney Bus Contract 8 is 30 October 2029.

 - (1) Could the Minister please advise if the Government has ruled out selling the Narrabeen Ambulance Station to property developers once it is closed?

No decision has been made about the future use of the current Narrabeen Ambulance Station site.

The new Dee Why Ambulance Station is being delivered as part of the NSW Government's

\$488.8 million NSW Ambulance Infrastructure Program. It will support local paramedics to provide the best emergency medical care now and into the future.

Paramedics and ambulances from Narrabeen Ambulance Station will relocate to the new Dee Why Ambulance Station when it opens. Narrabeen station will then be decommissioned, and the site will be manaaged in line with NSW Government policy.

* 1799 FULL TIME TEACHERS IN PITTWATER ELECTORATE—Mr Rory Amon to ask the Deputy Premier, Minister for Education and Early Learning, and Minister for Western Sydney—

- (1) As of the date for which the most recent data is available, how many full-time equivalent (FTE) teachers are employed at each public school across the Pittwater electorate?
 - (a) Of this information, how many FTE teacher vacancies are currently noted for each public school across the Pittwater electorate?
 - (b) As of the date for which the most recent data is available, how many temporary teachers and support staff are employed at public schools across the Pittwater electorate?
 - Please provide the above answers for each school individually.
- (2) How many temporary teachers and support staff have been or will be offered a permanent position at a public school in the Pittwater electorate?
 - Please advise the number of offers for each public school in Pittwater individually.

Answer-

For 12 years, the former Liberal National Government undervalued teachers and suppressed their salaries with an unfair wages cap. This led to a teacher shortage crisis which the former Government denied existed.

In Pittwater, permanent teacher vacancies increased by 167%.

It has led to schools struggling to find 3,200 casual teachers every day, impacting almost 10,000 lessons that have to be merged, collapsed or cancelled.

Under the Liberal National Government, the number of temporary teachers in schools also skyrocketed from 11,700 in 2011 to more than 24,000 in 2023.

When the former Government left office, only about 60% of teachers had permanent and stable employment.

That is why in just eight months, the Minns Labor Government has so far provided permanent employment to almost 16,900 temporary teachers and support staff.

In Pittwater, a total of 103 offers of permanent employment have been made to all eligible temporary teachers and school support staff across 11 schools in the Pittwater electorate.

- * 1800 FULL TIME POLICE IN THE NORTHERN BEACHES POLICE AREA COMMAND—Mr Rory Amon to ask the Minister for Police and Counter-terrorism, and Minister for the Hunter—
 - (1) As at the date for which the most recent data is available, what is the exact number of FTE police officers are allocated to the Northern Beaches Police Area Command?
 - (a) Of these district/command areas, how many current full-time employment vacancies are at each police station?
 - (b) Of the FTE referenced above, what is the exact number currently:
 - (i) On long service leave,
 - (ii) On administrative or sick leave relating to workplace injuries or experiences,
 - (iii) On parental leave,
 - (iv) Seconded to task forces or other Area Commands outside of the Northern Beaches.
 - (2) What is the Government doing to fill any vacancies?

Answer-

(1) (a – b) The NSW Police Force (NSWPF) publishes information about employee numbers in each Police Area Command and Police District in its annual report.

Staffing numbers at any particular police station can fluctuate daily in response to leave, crime trends and operational requirements.

All police positions attached to a Police Area Command or Police District are flexible resources available to respond to incidents across the local area. Local resources are also supplemented by specialist police (highway patrol, major crime squads, covert resources, and others) who are managed centrally but can be deployed across Police Area Command and Police District boundaries in response to operational needs.

(2) The NSWPF is actively seeking ways to attract candidates to become future police officers and has recently implemented a number of strategies to incentivise recruitment.

On 31 October 2023, the NSW Government and the NSWPF announced that from March 2024, Student Police Officers will be engaged as paid temporary administrative employees whilst studying at the Police Academy in Goulburn. This is a significant development for the NSWPF to provide a greater incentive for individuals to choose a policing career and enable the NSWPF to remain competitive in the current labour market.

* 1801 PAYROLL TAX THRESHOLDS—Mrs Tina Ayyad to ask the Minister for Planning and Public Spaces representing the Treasurer—

With regards to payroll tax thresholds:

* 1803 EDUCATION FUTURE FUND—Mrs Tina Ayyad to ask the Deputy Premier, Minister for Education and Early Learning, and Minister for Western Sydney—

In relation to the Government's Election Commitment to the Education Future Fund:

- (1) Can the Minister advise the number of vacancies of Full-Time, Part-Time, and Casual teacher positions in the Holsworthy Electorate?
- (2) Can the Minister advise the number of vacancies of Teacher Aide Positions in the Holsworthy Electorate?
- (3) Can the Minister advise the number of vacancies of School Counsellor positions in the Holsworthy Electorate?

Answer-

For 12 years, the former Liberal National Government undervalued teachers and suppressed their salaries with an unfair wages cap. This led to a teacher shortage crisis which the former Government denied existed.

In Holsworthy, this saw permanent teacher vacancies double from eight permanent vacancies, to 16 when it left office in 2023.

This is why the Minns Labor Government has delivered the biggest increase in teachers' salary in a generation and made NSW teachers among the highest paid in the country. It is disappointing that this pay rise for teachers in Holsworthy has been opposed by the Liberals and Nationals.

There was 6.5 full-time equivalent (FTE) vacant SLSO positions and one FTE vacant counselling position at NSW public schools in the Holsworthy state electorate.

- * 1804 WILD DOG FENCE EXTENSION PROJECT—Mr Roy Butler to ask the Minister for Skills, TAFE and Tertiary Education representing the Minister for Agriculture, Minister for Regional New South Wales, and Minister for Western New South Wales—
 - (1) In reference to the Ministers response to Question 243 (24/05/2023) regarding the Wild Dog Fence Extension Project. It was stated that construction of the 32 km priority section of the fence would commence once all relevant approvals were in place. Can the Minister confirm whether these approvals have been finalised?
 - (a) If so, when does the Minister expect construction works to begin?
 - (b) If not, can the Minister advise what is holding up the approval process?

Answer—

- (1) The approvals required prior to construction are currently being finalised.
 - (a) Construction activities will commence once required approvals have been finalised. This is estimated to be completed before the end of 2023 to allow for construction to begin in 2023. On-ground activities started on 13 November 2023 and include:
 - (i) surveying of the proposed 32 km alignment
 - (ii) finalising documentation with adjoining landholders
 - (iii) Aboriginal cultural heritage mitigation works and approvals
 - (iv) procurement activities for construction services.
 - (b) There are currently two ongoing approval processes.
 - (i) Completion of mitigation works required by the Aboriginal Cultural Heritage approval process.
 - (ii) Preservation of Surveying Infrastructure approval and mitigations process.
- * 1806 PATIENT TRANSFERS FROM PRIVATE RESIDENCES—Mr Roy Butler to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—
 - (1) Are paramedics being called on to perform patient transfers because the designated Patient Transfer services are unable to transport patients from private residences or from aged care due to Local Health District payment agreements?
 - (2) Is the Minister planning to investigate ways to renegotiate these agreements to allow Patient Transfer services to take over these duties to free up paramedics for their core duties?

Answer—

I'm advised:

Across many local heath districts, HealthShare NSW Patient Transport Service provides non- emergency patient transport for eligible patients from residences and aged care facilities to medical appointments.

In some areas a range of health services are engaged to provide patient transport. These arrangements are guided by specific business rules. Where NSW Ambulance provide non- emergency patient transport, emergency response calls are prioritised over non-emergency transport.

The NSW Government's safe staffing levels commitment includes ongoing funding for the nominal equivalent of 1,112 full-time equivalent nurses.

NSW Health and the NSW Nurses and Midwives' Association have entered a memorandum of understanding to implement the safe staffing levels commitment. A safe staffing levels taskforce is working through key implementation areas.

From 2024, Murrumbidgee Local Health District and Western NSW Local Health District will make all new graduate nursing and midwifery appointments permanent. Appointments will be made to the local health district rather than to individual hospitals.

Before 2023, successful GradStart program candidates were recruited under a 12-month contract.

* 1808 DOWNSIZING—Mr Matt Cross to ask the Minister for Planning and Public Spaces—

Can the Minister advise how the Government is working to reduce the economic barrier to downsizing to provide greater housing supply for young families?

* 1809 PREVENTATIVE HEALTH SPENDING—Mr Matt Cross to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

In relation to the \$30.5 billion committed in the 2023-24 Budget to Health, what percentage is being spent on preventative health?

Answer—

The National Preventive Health Strategy 2021-2030 uses data reported by the Australian Institute of Health and Welfare to track a target to increase spending on prevention across federal, state and territory budgets.

The latest report for 2021-22 was released 25 October 2023 and is available at <u>Health expenditure Australia</u> 2021-22, About - Australian Institute of Health and Welfare (aihw.gov.au)

In NSW, prevention is integrated into the health system at multiple levels of delivery and for this reason it is not possible to reliably disaggregate it

* 1810 NEW SOUTH WALES HEALTHY EATING AND ACTIVING LIVING STRATEGY—Mr Matt Cross to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

In relation to the New South Wales Healthy Eating and Active Living Strategy 2022-2032: Guiding the next decade of overweight and obesity prevention in New South Wales

- (1) Have you received a briefing about the strategy from NSW Health?
- (2) Will there be an update to the targets before the 10 year mark in 2030 (reporting in 2032) to ensure the targets are on track?

Answer-

I'm advised:

The NSW Health Population Health Survey is used to monitor the population prevalence of overweight and obesity in NSW children, young people, and adults. The survey also includes surveillance of food, physical activity, and sedentary behaviours at a population level. Survey data is released annually and helps inform high-level monitoring against the targets and objective of the Healthy Eating and Active Living Strategy.

* 1811 STATE RECORDS ACT OBLIGATIONS-Mr Matt Cross to ask the Premier-

Is the Premier's Office complying with the recordkeeping obligations set out in the State Records Act 1998?

Answer-

I expect all Ministers' offices to comply with their obligations under the State Records Act 1998.

The Ministers' Office Handbook provides guidance in relation to these obligations to assist each Ministers' office.

The Premier's Department and The Cabinet Office also provide guidance, advice1 training and support on these obligations for all Ministers' offices.

Other modifications include relocation of CCTV viewing screens and passenger door controls, changes to the digital radio system, adjustments to fire detection management and emergency door release functions.

Work is also currently underway to modify the affected trackside and station infrastructure to accommodate the changes to the Mariyung operating model as agreed with the Rail Tram and Bus Union.

The final cost of the network modifications will be confirmed once the full scope is determined and contracts to carry out the work are finalised.

Transport for NSW has advised residents that between Friday 13 October and Friday 3 November 2023, concrete pavement slabs were being replaced in various locations on the southbound lanes along the Hume Highway at Marulan. This work will support future rehabilitation of the Hume Highway at Marulan and improve safety.

The slab replacement works have a total budget of \$35M. The 2023-24 NSW Budget allocated \$27.1 million over the next four years to continue to replace sections of the existing concrete pavement. This will be spent on slab replacement and an overlay solution.

The damaged concrete pavement slabs on the southbound carriageway from the exit lane of the BP service centre southbound, to the overhead bridge at South Marulan, are not proposed to be replaced during the current works. These are planned for future replacement.

Work to stabilise the approach slabs to the bridges over the railway and Marulan entrance ramp (Brayton Road) were completed in February 2022. Bridge works were carried out to stabilise the road pavement behind the bridge abutments, not to test crossovers.

The northbound detour that was in operation for Highland Way via Murrimba Road between Monday 16 October and Wednesday 25 October 2023, was for both heavy and light vehicles. Transport for NSW has consulted with Goulburn Mulwaree Council, freight authorities and freight operators regarding this detour.
