- \* 1393 INDUSTRIAL RELATIONS—HINDSIGHT ADJUSTMENT PREMIUM—The Hon. Chris Rath to ask the Treasurer representing the Minister for Industrial Relations, and Minister for Work Health and Safety—
  - (1) In relation to small businesses that receive a "hindsight adjustment premium" notice can the Minister advise, what are the top 10 suburbs in NSW where small businesses receive this notice?
    - (a) By what number for each of the 10 suburbs?

Answer-

I am advised-

The 10 postcodes in NSW with the most hindsight adjustments over the last three financial years are as follows:

In relation to the above figures, it is important to note that:

- as the FY2022-23 policy period has just finished, there are wage declarations yet to be submitted and therefore, hindsight adjustments yet to processed;
- one postcode can have multiple suburbs; and
- there is a correlation between the 10 postcodes with the most hindsight adjustments and the number of employers in the scheme in those postcodes.

- (2) On the Independent Pricing and Regulatory Tribunal (IPART) website there are 51 listed Accredited Certificate Providers, will the Government be more transparent and update the IPART website to advise which regions/postcodes will be serviced by specific Accredited Certificate Providers?

#### Answer-

(1) The Energy Savings Scheme is a market-based scheme and Accredited Certificate Providers (ACP) make commercial decisions about the areas they service and the services they provide. The Government cannot compel a supplier to service a particular location, or to undertake a specific project. As such, a definitive list cannot be provided.

The NSW Climate and Energy Action website has a list of providers that have nominated themselves as servicing households and small businesses in the requested regions. The Office of Energy and Climate Change contacts the listed providers every six months to confirm their intent to service different areas.

(2) The Independent Pricing and Regulatory Tribunal's (IPART) website lists all active ACPs and the activities they are accredited to undertake.

The Office of Energy and Climate Change is working with IPART to improve the transparency of information to show public information on when certificates have been created for different activities in different locations.

However, the location of where providers will operate cannot be guaranteed as it is at the ACP's discretion whether to service an area or undertake a particular project depending on various factors. The region that a provider has indicated they can service is listed on the NSW Climate and Energy Action website and updated regularly.

- \* 1395 CUSTOMER SERVICE AND DIGITAL GOVERNMENT—CHEQUE PAYMENTS TO SERVICE NSW—The Hon. Sarah Mitchell to ask the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism representing the Minister for Customer Service and Digital Government, Minister for Emergency Services, and Minister for Youth Justice—
  - (1) With respect to payments made via cheque to Service NSW Centres, can the Minister advise, how often are cheques collected?

## Answer-

# I am advised:

- (1) Cheques are collected daily in the Sydney metropolitan area. The collection schedule varies in regional areas.
  - (a) cheques are collected by Armaguard
  - (b) cheques are processed at a Westpac Bank branch.
- (2) On average, 5,300 cheques are received each month.

- (3) From 1 April 2023 to 20 October 2023 there were 94 cheques unaccounted for. From 1 April 2022 to 31 March 2023 there were 192 cheques unaccounted for.
- (4) The Department of Customer Service directly notifies individuals once all lines of inquiry have been exhausted, including lodging a replacement cheque request with the individual's bank.

A replacement cheque request is typically made within two weeks of the cheque collection date. The individual is given 21 business days to provide a response. If no response is provided, the Department of Customer Service will write to the individual requesting a response within 14 days.

- (1) This question is best directed to the Minister for Customer Service and Digital Government.
- (2) Since January 2023, the average payments made via cheque is 244 per month.
- (3) Revenue NSW does not hold this information as it is unable to have visibility over cheques that have not yet been received by the Department.

- \* 1399 POLICE AND COUNTER-TERRORISM—STATE RECORDS ACT OBLIGATIONS—The Hon. Chris Rath to ask the Minister for Agriculture, Minister for Regional New South Wales, and Minister for Western New South Wales representing the Minister for Police and Counter-terrorism, and Minister for the Hunter—
  - (1) Is the Minister complying with the record keeping obligations set out in the State Records Act 1998?

#### Answer-

The Minister complies with the record keeping obligations as set out in the State Records Act 1998.

- \* 1400 TREASURER—ROYALTIES IN THE HUNTER—The Hon. Jeremy Buckingham to ask the Treasurer—
  - (1) Last financial year, how much income did the state receive in coal royalties sourced from mining operations in each of the Singleton and Muswellbrook local government areas?
  - (2) What percentage of the state's total coal royalty revenue was sourced from each of those mining operations in the local government areas referenced in (1)?
  - (3) What percentage of the state's total income was sourced from coal royalties in each of the local government areas referenced in (1)?
  - (4) Last financial year, how much of the state's expenditure was directed to the local government areas of Singleton and Muswellbrook, in both bare amount, and as a proportion of the state's total expenditure?

## Answer-

- (1) The data reported here is indicative and may be subject to revision. In 2022-23, coal royalties revenue from mining operations in the Singleton local government area (LGA) totalled \$1,704 million, and coal royalties revenue from mining operations in the Muswellbrook LGA totalled \$984 million.
- (2) In 2022-23, 36 per cent of total coal royalties revenue in NSW was received from mining operations in the Singleton LGA, and 21 per cent of total coal royalties revenue in NSW was received from mining operations in the Muswellbrook LGA.
- (3) In 2022-23, coal royalties revenue received from mining operations in the Singleton LGA represented around 1.6 per cent of general government sector revenue in NSW, whereas coal royalties revenue received from mining operations in the Muswellbrook LGA represented around 0.9 per cent of general government sector revenue in NSW.
- (4) I am advised that this information is not available by local government area.
- \* 1401 NATURAL RESOURCES—MINE REHABILITATION—The Hon. Jeremy Buckingham to ask the Minister for Finance, Minister for Domestic Manufacturing and Government Procurement, and Minister for Natural Resources—
  - (1) Clause 12 Schedule 8 of the *Mining Regulation 2016* (the 'progressive rehabilitation' reforms) came into force for large coal mines on 2 July 2022, and requires those mines to submit certain "rehabilitation outcome documents" to the department secretary for approval, which mines in the state have submitted these documents?
    - (a) For which mines have these documents been approved by the secretary?

- (2) As it is the policy of the government that the rehabilitation security bond required of each mine leaseholder covers the full projected costs of rehabilitating the mine, how confident is the Minister/Department that this policy objective is being met?
  - (a) How is each mine's projected rehabilitation cost, and security bond, calculated?
