- (2) Acknowledges Mr Egan's nearly quarter century of political service, including as:
  - (a) The Member for Cronulla between 1978 and 1984.
  - (b) Member of the Legislative Council between 1986 and 2005.
  - (c) Becoming the first New South Wales Treasurer to serve from the Legislative Council, going on to be the longest serving Treasurer in New South Wales history.
- (3) Recognises the extraordinary contribution Mr Egan made to the state of New South Wales, including the state's near-elimination of net government debt under his stewardship.
- (4) Acknowledges Mr Egan's career after politics in which he continued to dedicate himself to serving his community, including as Macquarie University's longest serving Chancellor from 2008 to 2019, Chair of the Australia Day Council of New South Wales, and Chair of the Centenary Institute of Cancer Medicine and Cell Biology.
- (5) Mourns the void left in our state by the loss of Mr Egan.

### 13 E-CIGARETTE INQUIRY

Ms Liesl Tesch moved, pursuant to notice, That this House:

(1) Commends the Government on establishing the e-cigarette inquiry into the regulatory framework governing e-cigarettes and their prevalence among children and young people.

- (2) Acknowledges the Government's commitment to reducing e-cigarette related harm in young people with a further funding injection of \$6.8 million to crack down on the sale of illegal vapes and increase support for vape addicted young people.
- (3) Notes that by working with the Federal Government to introduce stronger reforms, commends the Government for taking strong and decisive action to stamp out e-cigarette related harm through stronger legislation, enforcement, education and support.

Debate ensued.

Mr Matt Kean moved, That the motion be amended by inserting:

'(4) Commends the work of the former Government and former Minister for Health, the Hon. Brad Hazzard, for kickstarting the important work to combat the harm of e-cigarettes in 2022 through an education and awareness program.'
