* 2255 ROAD PROJECTS IN THE TAMWORTH ELECTORATE—The Hon. Kevin Anderson to ask the Minister for Regional Transport and Roads—

In relation to road projects in the Tamworth electorate:

- (1) Could you provide updated delivery timeframes for the following projects, including an anticipated start of construction and completion:
 - (a) Goonoo Goonoo Road?
 - (b) Port Stephen Cutting?

Answer-

I am advised

(1)

- (a) The project is moving towards NSW Treasury Gateway 2 approval to allow the project to progress in earnest. Once this is received, a Project Proposal Request will be submitted to the Commonwealth Department of Infrastructure to confirm funding. Pending that approval, Transport for NSW aims to begin construction in December 2024 with a scheduled completion date of early 2027.
- (b) Similarly, a Project Proposal request for the Port Stephens Cutting project is with the Commonwealth Department of Infrastructure for consideration, following the investment of \$5 million by the NSW Government for this project. I am advised Tamworth Regional Council is using this State funding for preliminary investigations. Designs are underway and works will begin once the designs are completed and Commonwealth funding is confirmed.
- * 2256 MANILLA VIADUCT AND RAIL BRIDGE—The Hon. Kevin Anderson to ask the Minister for Customer Service and Digital Government, Minister for Emergency Services, and Minister for Youth Justice representing the Minister for Climate Change, Minister for Energy, Minister for the Environment, and Minister for Heritage—
 - (1) What compliance measures does the Government now hold to ensure the Manilla Viaduct and Rail Bridge is protected as an asset listed on the State Heritage Register?
 - (2) Does the New South Wales Heritage listing allow for modifications of the structure to allow alternate use?
 - (3) Would placing a walkway on top of the Manilla Viaduct and Rail Bridge be deemed appropriate under the New South Wales Heritage Adaptive Reuse policy?
 - (4) Has Transport for NSW been contacted regarding the viaduct and their additional responsibilities to protect the asset under the New South Wales Heritage Act?

Answer-

- (1) All items listed on the State Heritage Register are protected by the provisions of the Heritage Act 1977 (the Heritage Act).
- (2) Under the Heritage Act, an application for approval is required for works or activities that may impact a State Heritage Register listed item. Certain activities and works with little to no impact on the item's heritage significance may be exempt from approval.
- (3) Applications for approval, including for public access and engagement, are considered on merit under the Heritage Act.

- (4) Heritage NSW has provided information to Transport for NSW concerning management of items on the State Heritage Register.
- * 2257 MANILLA VIADUCT AND RAIL BRIDGE HERITAGE ASSET ACTION PLAN—The Hon. Kevin Anderson to ask the Minister for Regional Transport and Roads—

In relation to the Manilla Viaduct and Rail Bridge:

(1) Was the Heritage Asset Action Plan (HAAP) for the Manilla viaduct placed on hold?

(a) If so, why?

- (2) Does this affect the ongoing maintenance of the structure?
- (3) Will the Manilla Viaduct and Rail Bridge still be included in the Regional Rail Heritage strategy?
- (4) Has Transport for NSW allocated additional funding to the preservation of the viaduct since the viaduct was listed on the NSW Heritage Register?
- (5) Has Transport for NSW been in contact with the Heritage team in the NSW Department of Planning and Environment?
- (6) How many of the following interactions have occurred with Heritage since the viaduct was listen on the NSW Heritage register:
 - (a) meetings
 - (b) emails
 - (c) phone calls
- (7) What additional measures have been considered to ensure the safety and preservation of the viaduct?

Answer-

I am advised

- (1) The Heritage Asset Action Plan was put on hold in September 2023 because it was not deemed critical to the finalisation of the Regional Rail Heritage Strategy.
- (2) No, placing the Heritage Asset Action Plan on hold does not impact maintenance on the Manilla viaduct or any other heritage-listed asset.
- (3) Yes, all heritage listed assets on the Country Regional Network are being assessed as part of the Regional Rail Heritage Strategy. This includes Manilla viaduct. The Regional Rail Heritage Strategy will set priorities for conservation, including across the timber underbridge asset class and will enable resources to be used most effectively.
- (4) No, additional funding has been allocated.
- (5-6) Transport for NSW met with Heritage NSW in November 2023, to discuss bridges on the regional rail network and to seek advice on how best to navigate heritage requirements to address safety.
- (7) Transport for NSW continues to work with Country Regional Network service provider, UGL Regional Linx, to determine if any additional measures are required to maintain safety at Manilla viaduct in both the short and longer term. Additional fencing, catch nets, the use of a shipping containers to facilitate safe pedestrian access and protection of pylons from vehicle strike are all measures that are being considered. As the viaduct is now listed on the State Heritage Register, any measures implemented will need to comply with all relevant heritage requirements.

- * 2258 COURT COSTS IN THE CHILDREN'S COURT—Mrs Tina Ayyad to ask the Minister for Families and Communities, and Minister for Disability Inclusion—
 - (1) What criteria or policy, if any, exists to determine whether the Department of Families and Communities appeals against costs in the Children's Court?

I am advised:

There is no set policy for making decisions as to when an appeal will be brought as each matter is dealt with on a case-by-case basis.

* 2259 LIVERPOOL HIGH SCHOOL MERGER—Mrs Tina Ayyad to ask the Deputy Premier, Minister for Education and Early Learning, and Minister for Western Sydney—

(1) Are there any plans to merge Liverpool Girls High School and Liverpool Boys High School?

Answer-

The NSW Government is building a new comprehensive public high school for Liverpool, which will bring Liverpool Girls and Boys High Schools together into one school.

This follows consultation with the local school communities, which was undertaken in 2022, and demonstrated support for co-education.

- * 2260 PRIMARY SCHOOL TEACHERS BY GENDER—Mrs Tina Ayyad to ask the Deputy Premier, Minister for Education and Early Learning, and Minister for Western Sydney—
 - (1) What percentage of primary school teachers (both permanent and casual) are male?
 - (2) What percentage of primary school teachers (both permanent and casual) are female?
 - (3) By gender, how many primary school teachers left the workforce in 2023?

Answer-

The Minns Labor Government is committed to attracting and retaining more hard-working and committed teachers in NSW schools. It is why the Government has delivered NSW teachers the most significant uplift in salaries in a generation. It will take teachers in NSW from being the worst paid in the country to among the highest.

It is disappointing that the Member for Holsworthy has not publicly supported this government's historic and fair wages deal for teachers in her electorate.

- (1) The percentage of primary school teachers that are male is 14 per cent.
- (2) The percentage of primary school teachers that are female is 86 per cent.
- (3) By gender, primary school teachers who left the workforce in 2023 are: Female 86.5%; Male 13.5%
- * 2261 POLICIES FOR OUT OF AREA STUDENT TRANSFERS—Mrs Tina Ayyad to ask the Deputy Premier, Minister for Education and Early Learning, and Minister for Western Sydney—
 - (1) What is the Department of Education's policy regarding appealing a transfer request for out of area students?

Answer—

Information regarding school enrolments, including non-local enrolments, is publicly available on the department's website.

- 2262 REDESIGNATION OF STAFF REGARDING RANDWICK GIRLS AND BOYS HIGH SCHOOL MERGER—Mrs Tina Ayyad to ask the Deputy Premier, Minister for Education and Early Learning, and Minister for Western Sydney—
 - (1) How many staff members have resigned from Randwick Girls High School since the announced merger with Randwick Boys High School?
 - (2) How many staff members have resigned from Randwick Boys High School since the announced merger with Randwick Girls High School?

There have been two resignations during this period, with both staff members taking up other opportunities. One of these teachers continues to teach at the school on a casual basis.

- * 2263 HOMES NSW ASBESTOS POLICY FOR PUBLIC HOUSING—Mrs Tina Ayyad to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast representing the Minister for Water, Minister for Housing, Minister for Homelessness, Minister for Mental Health, Minister for Youth, and Minister for the North Coast—
 - (1) What is Homes NSW's asbestos policy for public housing?

Answer—

Homes NSW tenants, staff and contractors, including agencies engaged for tenancy management, have a responsibility to report and take steps to resolve potential asbestos hazards in Homes NSW owned residential properties as soon as they become aware of them.

Homes NSW considers that any disturbance to asbestos in its residential properties is a potential health risk. Disturbance includes natural (weathering) mechanical, flood or fire actions.

Homes NSW will investigate reports of property damage to materials that may contain asbestos, manage its actions in working with asbestos and take all reasonable, timely and practical actions to protect the health of all parties involved.

- * 2264 UNIVERSAL SERVICE OBLIGATION—Mr Roy Butler to ask the Minister for Customer Service and Digital Government, Minister for Emergency Services, and Minister for Youth Justice—
 - (1) Given the widespread use of the Mobile Network as a form of communication, does the Government plan to include it under the Universal Service Obligation (USO) and Universal Service Guarantee (USG) regulations to ensure everyone has access to mobiles, landlines or payphones regardless of where they live?

Answer—

I am advised the Universal Service Guarantee and Universal Service Obligation are regulated by the Commonwealth Government under the portfolio of the Minister for Communications, the Hon Michelle Rowland MP. The NSW Government is engaging with the Commonwealth's current consultation on the Universal Service Obligation, including highlighting the need for equitable pricing and access for all NSW residents.

- * 2265 TRAUMA INFORMED CARE IMPLEMENTATION—Mr Roy Butler to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—
 - (1) Given that ambulance officers have no prior knowledge of a patient's history before attending an emergency event/crisis, can the Minister advise how they can implement trauma informed care?

(2) If ambulance officers and emergency service providers have applied trauma informed care to a patient, is there a follow up requirement for NSW Health to discuss this with the patient?

Answer-

I'm advised:

NSW Ambulance paramedics are trained to assess patients and deliver a broad range of interventions and high-quality out of hospital care. Paramedics are required to conduct a comprehensive assessment on all patients.

Trauma informed care is taught to NSW Ambulance paramedics as part of their Mental Health Induction. Trauma-informed care takes a 'universal precautions' approach, providing care in a way that reflects that every person - clients and staff - may have experienced trauma. In line with this approach, it is not necessary for a health worker to have previous knowledge of a patient's history to provide trauma-informed care. I am advised:

(1) The Department of Communities and Justice, including Youth Justice NSW, and the NSW Police Force have undertaken a targeted review of the Young Offenders Act 1997 (the Act).

The review considered relevant recommendations made by the NSW Legislative Assembly Law and Safety Committee Inquiry into the adequacy of youth diversionary programs in NSW, including increasing the number of cautions and expanding the scope of offences that fall under the Act.

The review is currently being considered by government.

With respect to the question asked of the Premier on 10 October 2023 in relation to the Local Small Commitments Allocation Program to which a response received from the Premier on 7 September 2023:

- (1) What does the assessment process entail?
- (2) What consultation process has the Government had with Councils around the Local Small Commitment Allocation Program to ensure that Councils' requirements are heard?

Answer-

All LSCA Projects are assessed and administered in accordance with the NSW Grants Administration Guide and the LSCA Program Guidelines. The LSCA Program Guidelines are publicly available on the NSW Grant and Funding website (Local Small Commitments Allocation - Home Page | NSW Government).

Community organisations and local councils were nominated by Members of Parliament or candidates prior to the 2023 election to receive grants to fund small projects, events, programs and charitable donations within their electorate.

In some electorates a number of community projects were specified, with the remaining portion of the allocated \$400,000 nominated for playground and park upgrade projects to be delivered by local councils. In October 2023, these councils were advised in writing and have been working with the relevant Member of Parliament to identify the priority projects for playground and park upgrades in their electorate.

* 2270 REGIONAL ABORIGINAL WATER COMMITTEES—Ms Steph Cooke to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast representing the Minister for Water, Minister for Housing, Minister for Homelessness, Minister for Mental Health, Minister for Youth, and Minister for the North Coast—

With respect to the response received on 17 October 2023 in relation to the Regional Aboriginal Water Committees:

- (1) In relation to the DPE Water's Aboriginal Water Program team planning to commence Regional Aboriginal Water Committees in late October 2023, could you please advise where and when these meetings will take place?
- (2) Will the Minister please provide a timeline as to when the assessment criteria will be established?

Answer-

I am advised:

- (1) Three initial on boarding meetings for the Regional Aboriginal Water Committees were held in Wagga Wagga, Dubbo and Ballina in November 2023, December 2023 and February 2024 respectively. Each of the 12 Aboriginal Water Committees have now commenced meeting separately in their own regions. As of the end of February 2024, meetings will have been held in Condobolin, Nowra, the Hunter Valley and Dubbo.
- (2) Assessment criteria will be developed with the Committees once the Terms of Reference are finalised, commencing after April 2024.

I am advised:

(1 - 2) Police Officers are generally allocated to Police Area Commands (PACs), Police Districts (PDs) or Specialist Commands, not to individual police stations. The Cootamundra electorate is serviced by Chifley PD, Murrumbidgee PD, Riverina PD and The Hume PD.

The NSW Police Force publishes information regarding police officer numbers in each PAC and PD in its annual report. Staffing at any particular police station can fluctuate daily in response to crime trends and other intelligence-led operational requirements.

- (3) Positions substantively occupied by an employee on sick leave or workers compensation are not considered a vacancy.
- (4) All police positions attached to PACs and PDs are flexible resources available to respond to incidents across the district. All local resources are supplemented by specialist police (highway patrol, major crime squads, covert resources) who are managed centrally but can be deployed across boundaries to meet changing community needs and respond to crime patterns and emerging issues.

On 31 October 2023, the NSW Government announced that from March 2024, Student Police Officers will be engaged as paid temporary employees whilst studying at the Police Academy in

Goulburn. This is a significant development for the NSW Police Force to provide a greater incentive for individuals to choose a policing career and to enable its workforce to remain competitive in the current labour market.

- * 2273 TRANSPORT ORIENTED DEVELOPMENT—Mr Matt Cross to ask the Minister for Planning and Public Spaces—
 - (1) In relation to the Transport Oriented Development State Environmental Planning Policy (SEPP) for Roseville, Lindfield, Killara and Gordon railway stations:
 - (a) How and why were these locations selected?
 - (b) What consultation and feedback has taken place with each community?
 - (c) What consultation and feedback is planned to take place with each community?

Answer-

I am advised:

(1)

- (a) Stations included as part of the Transport Oriented Development Program were identified as having enabling infrastructure capacity to support additional housing growth. This was informed by planning, infrastructure and spatial data, along with expert advice and feasibility analysis.
- (b) The Secretary and Deputy Secretary of the Department of Planning, Housing and Infrastructure have been briefing mayors and councillors of affected councils. Departmental staff have also held briefings with staff of these councils.
- (c) Councils have been invited to make a submission on behalf of their communities.
- * 2274 ERYLDENE HISTORIC HOUSE—Mr Matt Cross to ask the Minister for Planning and Public Spaces—
 - (1) In relation to Eryldene Historic House and Garden located at 17 McIntosh Street Gordon, within 400 metres of Gordon Railway Station:
 - (a) Will Eryldene Historic House and Garden be exempt from the Transport Oriented Development State Environmental Planning Policy?
 - (b) Will the properties that sit and directly surround Eryldene Historic House and Garden be exempt from the Transport Oriented Development State Environmental Planning Policy?

Answer—

I am advised:

The Transport Oriented Development State Environmental Planning Policy (TOD SEPP) will not make changes to heritage listings or heritage conservation areas as outlined in council Local Environmental Plans (LEPs). As a heritage item listed on the NSW State Heritage Register, the TOD SEPP will not apply to the Eryldene Historic House and Garden.

Any development applications under the TOD SEPP will go through a merit based assessment with the local council, who are well placed to assess applications for the impact of development in heritage conservation areas. Where applications involve the removal of a non-contributory building to the heritage value of the area, new development would be required to improve and enhance the heritage values.

Currently the NextSense Institute supports teachers to access online courses in United English Braille (UEB).

The dates on which double demerits apply are prescribed by section 71 of the Road Transport (Driver Licensing) Regulation 2017 (the Regulation). This section sets out how double demerit periods are calculated by reference to public holidays listed in the Public Holidays Act 2010 (NSW).

In accordance with the Regulation, the days included in a double demerit period can vary from year-to-year for many public holidays, in accordance with the day of the week on which the public holiday falls. The date of the Easter public holidays, and the corresponding double demerit period, also vary from year to year.

Transport for NSW publishes upcoming double demerits periods on its website and runs road safety enforcement campaigns before and during double demerits periods to increase community awareness.

Transit Cleaners clean and collect rubbish during the day while trains are in service and all trains are cleaned while in fleet maintenance and train stabling facilities each evening. Every train goes through a deep cleaning cycle every 90 days.
- (2) Cleaning of Metro trains and stations occurs daily with staff rostered 24/7 to maintain fleet presentation. On top of routine cleans, litter picking and spot mopping occurs throughout the day to respond as quickly as possible to cleanliness issues as they occur. In addition, various deep cleaning activities are scheduled throughout the year. Operator Metro Trains Sydney also manage removal of graffiti where required.

(2) Transport for NSW's Open Data & Innovation team collaborates with and supports endorsed apps to ensure data is kept as accurate as possible. This includes regular communications regarding major service changes and planned/unplanned data outages.

Developers of endorsed Open Data apps are given access to new data feeds for testing and feedback prior to wider release to minimise any issues when data is published. Endorsed app developers also have a direct line of communication to the Open Data & Innovation team who will triage data issues and customer feedback and raise support tickets with the relevant Transport for NSW team on their behalf.

- (3) The TripView app is wholly owned and developed by a third party who controls and manages all development in the apps including usability and functionality. Transport for NSW works collaboratively with the TripView developer to provide advice on how to best utilise data feeds to for clear customer messaging.

- (1) The NSW and Federal Governments will fund a major upgrade at Markham Street Armidale level crossing through the combined NSW Level Crossing Improvement Program (LCIP) and Australian Government's Regional Level Crossing Upgrade Fund (RLCUF) between 2023-24 and 2026-27. The level crossing will be upgraded from flashing lights to new high-intensity LED lights, bells and retro-reflective boom gates, with new signage and line marking for both the rail and roadway.
- (2) From 2023-24 to 2026-27, the NSW and Federal Governments will fund major upgrades at 23 priority level crossings in regional NSW through the combined LCIP and RLCUF. The upgrades will include the installation of high-intensity LED lights, bells and retro-reflective boom gates, with new signage and line marking for both the rail and roadway.
- (3) Data obtained from the National Level Crossing Portal on 13 February 2024 suggests that there were no collisions between trains and road vehicles at Markham Street Armidale level crossing from July 2014 to December 2023. As per my response to Question on Notice #1410, emergency accommodation expenditure under the current government sits within my portfolio of responsibilities as the Minister for Housing. Emergency accommodation has been managed by Homes NSW within the Department of Communities and Justice (DCJ) since March 2023. Under the previous government, it was under the portfolio responsibilities of the Minister for Emergency Services and was managed by Resilience NSW (which has since dissolved).

During 2022, DCJ spent \$1,022,864 on emergency accommodation, however this figure is not indicative of the true expenditure total as Resilience NSW also made payments for forms of accommodation.

DCJ liaised directly with the NSW Reconstruction Authority on historical expenditure data that was managed by Resilience NSW. I am informed that, due to legacy systems issues, the data is not attainable. While accurate data for 2020/21 expenditure is not accessible, financial reports to do with Resilience NSW are available in the dissolved agency's annual report which can be found at https://www.opengov.nsw.gov.au/

The legacy system is a reference to a database that was used to manage payments. At some point, the system moved to a different system. I'd be hapyy to brief the Member further on this matter if he has any further questions.

* 2311 NEW SOUTH WALES VALUER GENERAL REFORMS—Mr Michael Regan to ask the Minister for Small Business, Minister for Lands and Property, Minister for Multiculturalism, and Minister for Sport—

IQ will generate significant benefits to all property owners. Once delivered, property owners will have more timely, accurate and transparent access to valuation information and services that are delivered by the Valuer General or the agency set up to support their office, Valuation NSW (VNSW).

Val IQ will be delivered in 3 stages, through to December 2025.

- (2) The Valuer General is implementing a strategy to educate the community on the valuation system including how land is valued. The strategy includes:
 - an overhaul of the Valuer General website and available public information
 - reforms to the valuation objection process to deliver more timely and appropriate responses to property owners in NSW
 - utilisation of targeted digital public education communication campaigns across a variety of mediums coinciding with the delivery of annual land values, with real time objection volume analysis a key determinant factor in digital campaign location, and
 - reviewing customer service resourcing to: better disseminate valuation information, and respond in a more timely manner.

In addition, and once delivered, Val IQ will also make it easier for property owners to lodge objections, access their property and valuation information and interact with VNS customer service staff.

- * 2312 USE OF 1080 IN NEW SOUTH WALES—Mr Michael Regan to ask the Minister for Skills, TAFE and Tertiary Education representing the Minister for Agriculture, Minister for Regional New South Wales, and Minister for Western New South Wales—
 - (1) What work is being done by the Government to investigate humane methods other than 1080 poison, which are also as effective, to control feral invasive species in our state?

Answer-

(1) While there are clear advantages of 1080 as a pest animal control technique in Australia, there has also been extensive research over many decades to find additional toxins and alternative methods to reduce the impacts of pest animals, including non-lethal techniques.

Some of the alternative methods that have been investigated (and in some cases developed into operational techniques) include: immunocontraception, hormone-based fertility control, virus-based biocontrol (rabbits), PAPP (para-aminopropiophenone) toxin, sodium nitrite toxin, exclusion fencing, guard animals (to protect small livestock against foxes and wild dogs), and more efficient and humane approaches to aerial shooting and trapping.

In some cases, a viable control technique was not delivered. In other cases (e.g. guard animals), the technique is only suitable for small properties and when combined with other control techniques. Some of the alternative techniques that are used commonly such as aerial shooting and exclusion fencing, are very expensive and not readily available to all landholders.

The Department of Primary Industries (DPI) continues to collaborate within NSW, nationally and internationally to improve the efficacy, efficiency, humaneness and safety of existing pest animal control approaches; and, to investigate new control approaches. For example, DPI is currently collaborating with the National Wild Dog Management Coordinator on further investigation of the potential application of guard animals to help protect livestock against wild dog attack.

- * 2313 PEDESTRIAN SAFETY ON FOREST WAY—Mr Michael Regan to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—
 - (1) In relation to the investigation being undertaken by Transport for NSW into ways to improve pedestrian safety and amenity on Forest Way:
 - (a) What is the scope of this investigation?
 - (b) What will the outputs from this investigation be?
 - (c) When will the investigation be complete?
 - (2) Has Transport for NSW investigated the potential to install speed cameras along Forest Way, between Wearden Road and Bowman Avenue to reduce instances of vehicles exceeding the 70km/h speed limit in this area?
 - (3) Can the Minister advise when the funding decisions are expected to be made in the relevant State and Federal road safety programs determining if and when pedestrian fencing and high friction asphalt upgrades will be delivered on Forest Way?
 - (4) What would be the approximate cost of a pedestrian overpass bridge across Forest Way based on similar projects in other locations?

I am advised

- (1) Investigations are underway for Forest Way, between Adams Street and Wearden Road, to identify and assess the feasibility of short, medium and long-term options to improve safety, which include:
 - Pedestrian fencing in the vicinity of Glen Street and Wearden Road
 - Forest Way School Zone review for Wakehurst Public School
 - Traffic light investigations at Glen Street and Wearden Road
 - Pedestrian overpass in the vicinity of Bambara Oval.

Investigations for pedestrian fencing are expected to be completed by mid-2024, at which time a funding nomination will be submitted that would be subject to a business case approval. Each project nomination in NSW competes with other nominations on a 12-month basis for limited available funding. The priorities are determined on strict criteria and on a state-wide priority basis.

A review of the current school zone is currently underway and is expected to be completed by the end of March 2024. Traffic light investigations are underway to determine if any changes can be made to provide additional safety for pedestrians.

Investigations for a pedestrian overpass have been completed. The current policy for assessing a site for any pedestrian facility, including pedestrian bridges, requires that consideration be given to vehicular and pedestrian traffic, road conditions, future demand, and the accident history of the site. The site is then prioritised for funding on a state-wide basis.

Construction of pedestrian bridges can be complex and involve additional factors, including land acquisition and environmental impacts, surrounding infrastructure, community impacts and the design and funding approvals. Based on this, the site is unlikely to be eligible for road safety funding at this time. Further investigations may be undertaken subject to future funding. All investigations are expected to be completed by mid-2024.

(2) Transport for NSW has not investigated for a fixed speed camera at this location.

The intersection of Forest Way and Glen Street. Belrose was considered for a red-light speed camera during the 2023-24 financial year. It was not one of the ten new red-light speed camera locations

chosen due to its ranking of approximately 1,750 out of 4,000 eligible intersections based on the selection criteria.

Forest Way, Belrose is approved for mobile speed camera enforcement, however, the road environment, most notably the presence of clearways, no stopping restrictions and a footpath precludes mobile speed camera enforcement being undertaken safely on this road.

- (3) Funding decisions are generally made annually towards the end of a program round when project applications are invited, reviewed and approved. This project application, submitted by Northern Beaches Council, proposing pedestrian fencing, high-friction asphalt upgrades and other pedestrian safety improvements was reviewed in September 2023 by Transport for NSW, as part of the Australian Government Black Spot Program 2023-24 and was returned to Council seeking further supporting information. Transport for NSW is currently seeking funding to progress the pedestrian fencing works.
- (4) There have not been investigations to estimate the cost of a pedestrian bridge for this location. The cost would depend on the design, constructability, public utility impacts, any land acquisition required and whether it requires lifts and/or ramps.

The highlighted area in the map on the DPI webpage correctly outlines the spearfishing closure, noting Glaisher Point is located adjacent to the north eastern point of Oak Park ocean pool at South Cronulla. It is noted that some mapping software websites incorrectly label Glaisher Point as Windy Point (about 400m north of Glaisher Point) while other websites, including the online Sutherland Shire Council maps, show the correct location of Glaisher Point.

(1)

In 2019/20, the former NSW Government committed \$2.7 million to establish a new Public Sector Prosecutions unit within the Office of the Director of Public Prosecutions (ODPP), focused on expediting prosecutions arising from ICAC investigations.

The ICAC must seek the advice of the Director of Public Prosecutions (DPP) about whether any prosecution should be commenced in respect of investigations by the ICAC. The DPP determines

whether any criminal charges are to be laid and, if so, conducts the prosecution. The progress of matters is generally within the hands of the DPP.

The DPP is an independent statutory office holder exercising her prosecutorial functions independently of Government and is not subject to the direction or control of the Attorney General.

In May 2023, the ODPP and ICAC endorsed a new Memorandum of Understanding, streamlining the process of referrals to the ODPP from the ICAC.

(2)

The ICAC publishes information relating to prosecution briefs with the ODPP and outcomes which can be accessed at <u>https://www.icac.nsw.gov.au/</u>.

As 19 November 2019, ODPP advice as to whether any prosecution should be commenced was pending in respect of 26 persons of interest. As of 25 January 2024, ODPP advice is pending in respect of 2 persons of interest. This represents a significant reduction in matters awaiting advice from the DPP.

In June and July 2023, new rider training agreements were executed with three rider training providers to deliver rider training across 20 locations, providing coverage for 90 per cent of the NSW population.

More information on the new rider training providers is available on the NSW Government eTendering website, Provision of Motorcycle Licence Training and Testing Scheme (MLTTS) CW2557521.

Where a customer lives determines the path taken, to obtain a motorcycle learner's licence or upgrade to a motorcycle P1 licence.

If the person lives in:

- a declared area, i.e., where rider training is available, then, it is mandatory to complete the relevant rider training course/test.
- an undeclared area, i.e., where there are no rider training providers, then, they have the option of:
- undertaking the required testing by Service NSW, or,
- completing the relevant rider training course/test.

Rider training is available at Taree, about 80km away from Port Macquarie, which is considered a reasonable distance for the purpose of Port Macquarie being a declared area.

Most NSW city and regional postcodes are in declared areas. More information about rider training is available at <u>Getting your rider licence | NSW Government</u>.

(1) Section 92(1) of the Civil and Administrative Tribunal Act 2013 provides that:

- the Minister is to review the Act to determine whether the policy objectives remain valid and whether the terms of the Act remain appropriate for securing those objectives.
- The review is to be undertaken as soon as possible after the period of 5 years commencing on the establishment day.
- A report on the outcome of the review is to be tabled in each House of Parliament within 12 months after the end of the period of 5 years.

The Report of the Statutory Review of the Civil and Administrative Tribunal Act 2013 was tabled in Parliament on 23 December 2021.

- (a) The Attorney General has administrative responsibility for the Civil and Administrative Tribunal Act 2013, which establishes the Civil and Administrative Tribunal of NSW (NCAT) as an independent statutory tribunal.
- (2) NCAT members are not employees, they are statutory appointees. Under Section 10(3) of the Civil and Administrative Tribunal Act 2013 a non-presidential member appointed as a term member is to be appointed by the Minister by written instrument. The process of appointing new members by the Attorney General currently involves widespread advertising, seeking expressions of interest in appointment and the convening of an appointment committee (including a nominee or nominees of the Attorney General) which assesses applications, interviews candidates, and conducts reference checks.
 - (a) Under Section 20(1)(e) of the Civil and Administrative Tribunal Act 2013, the President provides advice to the Minister about the appointment, re-appointment and removal of members.
- (3) Yes.
 - (a) See response to question (2)(a).
- (4) Yes, noting that members are appointed, not employed.
 - (a) See response to question (2)(a).
- (5) Under Schedule 2, Clause 7(2) of the Civil and Administrative Tribunal Act 2013 the Governor may remove a member (other than the President) from office for incapacity, incompetence or misbehaviour.
 - (a) The Attorney General may provide advice to the Governor noting that under section 20(1)(e) of the Civil and Administrative Tribunal Act 2013, the President provides advice to the Minister about the appointment, re-appointment and removal of members.
- (6) See response to question (1)(a).
 - (a) Depending on the matter, NCAT decisions can be appealed to NCAT's internal appeal panel or to the NSW District Court, Supreme Court and Land and Environment Court. The Supreme Court can also conduct judicial review of certain NCAT decisions.
- (7) NCAT does not reimburse expenses. Under Schedule 2, Clause 4 of the Civil and Administrative Tribunal Act 2013, a member has, in the exercise of functions performed as a member, the same protection and immunities as a Judge of the Supreme Court.
- (8) If an NCAT member does not comply with the NCAT Member Code of Conduct, the President may direct the member to specified action to rectify the conduct or determine that further work is not

allocated to the member, until the breach is rectified. In cases of serious breach, the President may refer it to the Attorney General or recommend that the member not be reappointed at the expiration of their term.

(a) There is no specified timeframe for this process. Complaints regarding alleged

misconduct are referred to the responsible Division Head and, if substantiated,

may form part of a performance review or a referral to the President.

(b) The performance of a member no longer appointed to NCAT is unable to be

reviewed by the relevant Division Head or the President.

(9) Under Schedule 2, Clause 7(2) the Governor may remove a member (other than the

President) from office for incapacity, incompetence or misbehaviour.

Following recent catastrophic bushfires in the Pilliga State Forest and Pilliga State Conservation Area:

Answer-

- (1) The NSW Government is aware of the community!s concerns about coal seam gas infrastructure in the Pilliga State Forest and potential fire risks from methane gas.
- (2) The Environment Protection Authority (EPA) is an independent regulatory government body and the lead regulator for all gas activities in NSW. The EPA conducts regular and ongoing independent audits on all coal seam gas infrastructure in NSW. The audits are captured in the EPA Onshore Gas Inspection Program, which includes a Leak Detection and Repair (LOAR) program conducted each financial year.
- (3) The EPA has conducted onsite inspections including as part of the LOAR program and can confirm no damage to gas infrastructure occurred due to the Pilliga State Forest fires. All power lines, water and gas pipelines and communications lines in the Bibblewindi to Leewood corridor are underground and were not exposed to the bushfire.

Furthermore, an independent environmental audit conducted by a suitably qualified independent contractor must be completed within one year of the project's commencement with results made publicly available.
- (5) In addition to the EPA's current independent audits, the EPA completed a "post-fire" LOAR program in response to the fires at Pilliga State Forest for each well that has not been plugged and abandoned. The Forestry Corporation of NSW granted the EPA restricted access to Pilliga State Forest on Tuesday 30 January 2024, the EPA has since assessed the infrastructure and conducted inspections on all 26 operational gas wells.
- * 2376 JURY DUTY—Mr Alex Greenwich to ask the Attorney General—
 - (1) What assessment has been made of the impact of jury duty on small business operators, including sole traders?
 - (2) What consideration has been given to fair compensation for citizens when they perform jury duty;
 - (a) Does the Government intend to increase fees to cover the loss of income for those doing jury duty?

Answer—

I am advised:

- (1) The Jury Act 1977 allows jurors to seek excusal from jury duty due to undue hardship or serious inconvenience to the person, the person's family, or the public. Jurors can submit supporting documentation from their employer, who may be a small business operator, outlining the impact an employee's absence would have on the workplace. Such requests are assessed on a case-by-case basis.
- (2) A juror is entitled to be paid for their service as a juror. Payment allows for attendance, travel, and refreshments. All payments made to jurors in NSW are mandated by legislation, namely Schedule 1 of the Jury Regulation 2022 (NSW). Additionally, while it is acknowledged that serving on a jury is an interruption and possibly an inconvenience to a juror's financial circumstance, the allowance paid to jurors is not intended to substitute an individual's income, rather to acknowledge the individual's contribution to their civic duty.
 - (a) Under s 111 of the Fair Work Act 2009 (Cth), employers are required to pay employees who are completing jury service a make-up payment for the first 10 days of jury service. A make-up payment is the difference between a juror's allowance that is provided by the Government, and the amount the juror usually receives as wages or salary. As the average length of trial in NSW is approximately 8 days, most jurors should not experience significant financial disadvantage while completing their civic duty.
- (3) At present, jury service allowances in NSW are more generous in comparison to allowances paid by other jurisdictions and the Government continues to monitor the rate of remuneration paid to jurors in NSW. Last year the NSW Government introduced the Jury Amendment Bill 2023 seeking to amend the Jury Act 1977 to improve the operation and management of juries in NSW. Two of the proposed amendments in the Bill seek to:
 - clarify what constitutes "good cause" for the purpose of seeking an exemption or excusal from jury service, to include any circumstance that could affect a person's ability to perform the functions of a juror and can extend to temporary disabilities of other physical or mental conditions, and
 - ensure that part-time employees have the same protections as full-time employees and are not prejudiced by their employer when they attend jury service.

Answer-

(1) In 2018, the Heritage Council of NSW commissioned a study on the heritage values of Sydney Harbour. Authored by the Australian Institute of Landscape Architects, this study resulted in the nomination of 10 landscapes around Sydney Harbour.

In 2023, one of those nominations, Badangi (Berry Island and Wollstonecraft Foreshore reserves), was listed on the State Heritage Register.

- (2) Some of the most popular tourism destinations in NSW are on Sydney Harbour and their heritage values are recognised through listing on the State Heritage Register. These places include the Sydney Opera House, Sydney Harbour Bridge, and Royal Botanic Gardens and Domain. Listing information can be found on the State Heritage Inventory on the Heritage NSW website.
- (3) Heritage NSW is not aware of any nominations to list Sydney Harbour on either the Commonwealth Heritage List or National Heritage List. The Australian Government's Department of Climate Change, Energy, the Environment and Water is responsible for these heritage lists and would be best placed to support the community in nominating Sydney Harbour for the Commonwealth Heritage List or National Heritage List.

In relation to Abercrombie Caves:

- (1) As of February 2024, how long has Abercrombie Caves been closed to the public?
- (2) When the caves are open, how many visitors visit Abercrombie Caves annually?
- (3) In dollars, what does this visitation inject into the local economy annually?
- (4) What damage was caused by the recent flooding event?
- (5) Is there any other damage caused by other factors?
- (6) What works are currently underway to reopen the caves to the public?
- (7) Please outline the scope of works and timeline for completion.
- (8) What is the budget or anticipated cost to reopen the caves?

Answer-

- (1) Abercrombie caves has been closed since 29 January 2022 due to flood damage. A second major flood event on 3 November 2022 caused further damage to infrastructure and recently completed repair works.
- (2) Prior to the COVID-19 Pandemic, Abercrombie caves had an estimated 8,000 to 10,000 visitors per annum.
- (3) Based on pre-COVD visitation figures, day and overnight visitation to the site is estimated to inject approximately \$895,000 into the local economy annually.
- (4) Damage from the two floods impacted the Archway cave precinct, which is the main visitor attraction to the site and incorporates a self-guided tour. Damaged infrastructure included:
 - damage to internal and external pedestrian bridges
 - electrical system (lights and movement sensors, cables, entrance hardware including token box, gate latch)
 - internal and external fences and hand railings
 - internal and external paths
 - silt and vegetation debris deposition throughout the cave systems
 - directional/interpretative signs
 - entrance wall (stone and concrete security wall)
 - concrete steps.

Other damage included:

- plant and equipment (trailer washed away)
- erosion of walking tracks
- damage to outdoor furniture

- damage to mains power cables at Grove Creek Crossing and exposure of cables in other locations, including telecommunications
- fallen trees in and along the creek throughout the visitor precinct.
- external light fixtures
- significant mass erosion of creek banks
- timber stairways
- entrance road cutting erosion and surface destabilisation
- undermining and destabilisation of the causeway across the creek accessing the campground.

The access road to the site that is managed by Bathurst Regional Council was also closed for an extended period due to landslips and rockfalls.

- (5) There is damage to the northern end of the caves walking track (fences, railings, concrete steps, track surface and signs) from rock fall and associated geotechnical works.
- (6) Works are underway to repair all the damage and these works are in various stages of completion.
- (7) Damage has been assessed and investigations, including geotechnical, are underway. The next steps are:
 - engineer designs
 - environmental assessment
 - reinstate access track to the caves
 - repairs to all affected pathways and stairways
 - replacement of fences and barriers
 - replacement of interior swing bridge
 - repairs to exterior swing bridge
 - reinstallation of mains power to the caves
 - repair/replace external light fittings
 - replace light posts, signs and furniture
 - replacement of the causeway.

Timeline for the completion of works and re-opening the site is the end of December 2024.
