* 2918 FIREARM PROHIBITION ORDERS—Mr Roy Butler to ask the Minister for Police and Counterterrorism, and Minister for the Hunter—

Can the Minister please provide a statistical breakdown of the figures, by year, of the number of Firearm Prohibition Orders issued in the last five years, broken down by the number issued to people with firearms licences and those without licences?

Answer-

I am advised:

2019: 743 - 9 issued to people with firearms licences*, 734 without licences.

2020: 895 - 9 issued to people with firearms licences*, 886 without licences.

2021: 588 - 6 issued to people with firearms licences*, 582 without licences.

2022: 602 - 3 issued to people with firearms licences*, 599 without licences.

2023: 855 - 4 issued to people with firearms licences*, 851 without licences.

* 2919 ACCELERATING INFRASTRUCTURE IN GROWING AREAS - COOTAMUNDRA—Ms Steph Cooke to ask the Minister for Planning and Public Spaces—

With respect to the Government's \$62.5 million to accelerate infrastructure in growing areas:

- (1) Would the Minister please advise why this funding does not include regional New South Wales, in particular the Cootamundra electorate?
- (2) Would the Minister please advise what is the Government doing to support infrastructure in growing regional areas such as the Cootamundra electorate?

Answer-

I am advised:

- (1) The \$62.5 million in funding is being provided as part of the State Voluntary Planning Agreement (VPA) Funding Program which uses developer contributions to deliver state and regional infrastructure that supports new homes. Developer contributions collected through State VPA's are required to be invested in the area they were made. There are currently no State VPAs in the Cootamundra electorate.

- * 2920 DOMESTIC VIOLENCE PREVENTION AND SUPPORT—Ms Steph Cooke to ask the Minister for Women, Minister for Seniors, and Minister for the Prevention of Domestic Violence and Sexual Assault—

With respect to the \$230 million to improve New South Wales domestic violence prevention and support:

- (1) Would the Minister please advise how much of the \$230 million will be allocated to regional New South Wales?
- (2) Of this allocation to regional New South Wales, what will these funds be allocated to?
- (3) Would the Minister please advise how many extra case workers will be appointed to regional New South Wales, including where will they be located and if these case workers will be available seven days a week?

Answer-

I am advised:

The focus of this emergency funding package will be to allocate resources to areas of greatest need and unmet demand in NSW.

Increasing funding to domestic and family violence services in regional, rural and remote NSW will be a priority.

Work is underway on how the funding will be allocated.

* 2921 AUSTRALIAN MEN'S HEALTH SHED ASSOCIATION—Ms Steph Cooke to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

With respect to the Australian Men's Shed Association:

- (1) Would the Minister please advise if NSW Health has plans to allocate further funding to the Australian Men's Shed Association as part of the NSW Men's Health Strategy, to support the offset costs of volunteer Executives to provide health and wellbeing assistance to Men's Sheds across New South Wales?
- (2) Has the Minister set a date to meet with the Australian Men's Shed Association to discuss this issue further?

Answer-

I'm advised:

- (1 2) The Men's Health Framework guides the activity of NSW Health to improve men's health. The framework does not have funding attached to it. The request for further support is under consideration communication with the NSW Branch of Australian Men's Shed Association is ongoing.
- * 2922 REGIONAL TRANSPORT RESILIENCE FUND—Ms Steph Cooke to ask the Minister for Regional Transport and Roads—
 - (1) Could the Minister please advise if the 'building back better' approach will be carried across to other funding programs for councils to rebuild their transport and infrastructure to ensure they are replacing infrastructure assets for the future not just replacing 'like for like' which is no longer fit for purpose?
 - (a) If so, how?

Answer-

I am advised

The NSW Government is looking to deliver infrastructure betterment by ensuring damaged roads and transport infrastructure are rebuilt stronger, better and more able to withstand future natural disasters through funding programs such as:

- Regional Roads and Transport Recovery Package (RRTRP) helps communities become
 more resilient to natural disasters by investing in building better infrastructure to improve
 transport networks across northern NSW, and
- Regional Transport Resilience Fund (RTRF) helps to upgrade and build resilience into priority transport networks in Central West NSW impacted by extreme weather in 2022.

The RRTRP and RTRF were developed based on the level of damage to the eligible regions due to specific 2022 flooding events, in consultation with the Department of Regional NSW, the NSW Reconstruction Authority and the Australian Government's National Emergency Management Agency.

While many activities can constitute betterment, a list is provided to councils as an example of projects which would achieve betterment outcomes, including:

- Stabilisation works to address high risk slopes where they form part of the essential public asset, vulnerable during natural disaster events.
- Raising the level of key vulnerability points on the road network to mitigate community connection risks due to flood.
- Strengthening road pavements, such as stabilisation, to improve resilience of road assets during flood and fire as a general measure to ensure timely recovery when flood and fire events occur.
- Installing flood mitigation and other resilience infrastructure to mitigate flooding risks impacting transport infrastructure such as improved drainage.
- Upgrading road corridors to provide improved resilience through enhanced culvert and drainage performance.
- Replacing and upgrading low level bridges on key corridors where bridge assets are vulnerable to natural disaster.

The decision on future betterment programs will be determined by both the NSW and Australian Governments.

Answer-

I am advised

(1) Community Transport is available across all nine Local Government Areas (LGA) in the Cootamundra electorate. The list of Community Transport Service Providers is publicly available on the Transport for NSW website at Community transport operators | Transport for NSW

Transport for NSW subcontracts the delivery of Community Transport within the Cootamundra electorate to the following Community Transport Service Providers:

Answer—

I am advised:

- (1) The NSW Government released NSW's first State Disaster Mitigation Plan in February 2024.
- (2) Development of two place-based Disaster Adaptation Plans is now underway for the Hawkesbury-Nepean Valley and Northern Rivers region.
- (3) The State Emergency Management Plan sets out the roles and responsibilities of emergency management organisations through the different stages of a disaster, including Local Emergency Management Committees, emergency services agencies, and the NSW Reconstruction Authority. The State Emergency Management Plan was reviewed and updated in December 2023, and is available at State Emergency Management Plan (EMPLAN) | NSW Government

* 2925 ORAL HEALTH FEE FOR SERVICE SCHEME—Ms Steph Cooke to ask the Minister for Health, Minister for Regional Health, and Minister for the Illawarra and the South Coast—

With respect to the Oral Health Fee for Service Scheme (OHFFSS), which provides vouchers for patients to receive treatment from a private dental practitioner registered with the public dental service:

- (1) Would the Minister please advise what the turnaround time if for patients to receive these vouchers?
- (2) Would the Minister please advise how patients apply for vouchers under the OHFFSS?
- (3) Would the Minister please advise who is eligible under the OHFFSS?

Answer-

I am advised:

Public dental services are provided according to criteria that prioritises emergency situations, as well as patient groups in most need and at highest risk of disease. Data is regularly updated and can be accessed from the NSW Health website.

Dental vouchers are issued in line with the NSW Health Priority Oral Health Program and the NSW Oral Health Fee for Service Scheme. Public dental staff determine whether a dental voucher is appropriate to provide to a patient.

Information on eligibility for public dental services can be accessed from the NSW Health website.

* 2926 LOCAL SMALL COMMITMENTS ALLOCATION - REMAINING ALLOCATION—Ms Steph Cooke to ask the Premier—

With respect to the Local Small Commitments Allocation (LSCA) Program of which currently only \$43,445 has been allocated to Coolamon Shire Council for the installation of a public Electric Vehicle destination chargers:

- (1) Would the Minister please advise when the balance of the \$400,000 will be allocated to the Cootamundra Electorate?
- (2) Would the Minister please advise where this will be distributed and for what project/s?

Answer-

This question is a matter for the Special Minister of State.

* 2927 WHEELCHAIR ACCESSIBLE TAXIS—Mr Philip Donato to ask the Minister for Regional Transport and Roads—

Regarding wheelchair accessible taxis:

- (1) Does the Government have plans to introduce new incentives for wheelchair accessible taxi drivers to increase the number of active wheelchair accessible vehicles on the road?
 - (a) If so, when?
- (2) Does the Government have a plan to address the crisis of supply of wheelchair accessible taxis, especially in regional areas which has seen some regional towns left with no wheelchair accessible taxis available?
- (3) Is the Government consulting or communicating with disability advocacy groups in addressing issues with wheelchair accessible taxis?

Answer—

I am advised

- (1) A series of Roundtables are being conducted to seek feedback on ways to improve the availability of wheelchair accessible services, while ensuring these services are safe and affordable for passengers who need them and are economically viable for service providers and drivers.
 - To date three Roundtables have been held in Sydney, Wagga Wagga and Ballina. A third Roundtable is being planned to be held in Orange on 2 July 2024.
- (2) The Roundtables bring together people with disability, other local disability and community stakeholders, community transport, local representatives from the Point to Point Industry and other government agencies. Submissions are also welcomed from those who cannot attend.
- (3) The outcomes from these Roundtables will be collated into a single report and provided to Government for consideration regarding next steps. Transport for NSW and the Point to Point Transport Commissioner are continuing to work with the industry, people with disability and disability groups to look at ways to support the availability of safe wheelchair accessible services.
- * 2928 LIVEABLE HOUSING DESIGN SILVER STANDARDS—Mr Philip Donato to ask the Minister for Better Regulation and Fair Trading, Minister for Industry and Trade, Minister for Innovation, Science and Technology, Minister for Building, and Minister for Corrections—
 - (1) Is the Government planning to sign up to adopting the Liveable Housing Design Silver Standards for new residential properties?
 - (a) If so, when?

Answer-

I am advised:

The NSW Government is currently developing a whole of Government response to the Disability Royal Commission's Final Report recommendations, including the recommendation relating to national adoption of the Liveable Housing Design Standard in the National Construction Code.

The NSW Government recognises the importance of accessible housing for many in our community including people with disability, those with mobility issues and seniors.

The Government has previously indicated it will monitor any effects the NCC liveable housing requirements have on both building costs and housing stock across other jurisdictions, noting several jurisdictions have only recently commenced these provisions. This approach will provide NSW with the balance and flexibility to consider options to increase the supply of accessible housing, while minimising any burdens on housing affordability.

- * 2929 PREVENTION OF DOMESTIC VIOLENCE REFORMS—Mr Philip Donato to ask the Minister for Women, Minister for Seniors, and Minister for the Prevention of Domestic Violence and Sexual Assault—
 - (1) Are there any plans for the Government's prevention of domestic violence reforms to include prescribing a strict timeframe for the installation of security hardware and measures to the homes of persons in need of protection, being delivered through the "Staying at home leaving violence" program?

Answer—

I am advised that service providers develop local agreements with contractors for the installation of security upgrades and there are several factors that can impact timeframes outside of the service providers' control. The SHLV program is due for re-commissioning in 2025, during which, efficient contractor engagement and turn-around times for security installations will be considered.

I am aware of concerns raised by the family of Molly Ticehurst in relation to this matter and have asked The Cabinet Office to undertake a review of support services provided to Molly Ticehurst in the lead up to her death.

- * 2930 SHARE BIKES—Mr Alex Greenwich to ask the Minister for Planning and Public Spaces—
 - (1) What complaints has the Government received about problems with share bikes blocking public access and littering footpaths and other public space?

Answer-

I am advised:

- * 2931 PYRMONT PUBLIC TRANSPORT—Mr Alex Greenwich to ask the Minister for Transport—
 - (1) What plans does the Government have to provide a bus stop in York Street Sydney on the 389 bus route, and when will this be operating?
 - (2) What plans does the Government have to provide a bus stop in Murray Street Pyrmont near the Maritime Museum on the 389 bus route, and when will this be operating?
 - (3) What changes to the 501 bus service route does the Government plan as a result of Western Distributor traffic changes, and how will this maintain access to bus services for the northern end of the Pyrmont peninsula?
 - (4) When does the Government plan to re-introduce stops at Pirrama Park for the F10 ferry?

Answer-

I am advised

- (1) To enable the City of Sydney's introduction of the King Street cycleway, the 389 route was modified in December 2021. The first City bus stop for services coming from Pyrmont was changed to match the last City bus stop for services going to Pyrmont -Town Hall Station, Park Street, Stand H.Bus stops on the York Street corridor are currently operating at capacity. Changes to other bus services would be required to enable the 389 to stop there. Transport for NSW will continue to investigate opportunities for a set-down stop on York Street for route 389 as the bus operations and kerbside environment changes.
- (2) Transport for NSW is planning to make some changes to bus route 389 in the Pyrmont area to address passenger feedback, improve access to Darling Harbour and the Maritime Museum, and provide improved interchange opportunities between bus and light rail services. To accommodate these changes, Transport for NSW is currently seeking feedback on proposed parking changes. Any responses received will be submitted to the City of Sydney's Local Pedestrian, Cycling and Traffic Calming Committee for their consideration.
- (3) Transport for NSW is currently investigating options for adjustments to the bus network to support the Western Distributor project. These adjustments may be part of a wider integrated transport network review. Transport for NSW will engage with passengers and the community on any plans for the bus network before any changes are implemented and to ensure that the community understand what the changes are, and how best to travel. As with all transport improvements, any changes identified as part of the planning work will be subject to operational constraints, including the cost of delivering extra services and the availability of resources, such as buses and drivers.

- (4) Transport for NSW is reviewing the vessel, infrastructure, and timetabling requirements necessary of the delivery of ferry services to Pirrama Park for the F10 Ferry. Further details about the F10 stopping at Pirrama Park is expected within the next few months.
- * 2932 ONLINE COMMUNITY ENGAGEMENT—Mr Alex Greenwich to ask the Minister for Families and Communities, and Minister for Disability Inclusion—
 - (1) What work has the Government carried out to understand the needs of people with disability?
 - (2) What measures does the Government use to ensure that people with disability are able to engage with government agencies online?
 - (3) What practical help does the Government expect agencies will provide for people with disability unable to use online forms to be able to contact, use Government services or submit complaints?
 - (4) Does the Government provide dedicated staff to help people with disability or others unable to engage online to obtain services online or make contact?
 - (5) What plans does the Government have to improve access to online services and engagement?

Answer-

I am advised:

- (1) The NSW Government designs its services, programs and products to promote inclusivity for its customers and staff. This is informed by engagement with key stakeholders including the Disability Council of NSW, the key advisory body to the NSW Government on matters affecting people with disability, disability advocates and people with lived experience.
 - The Public Service Commission supports DEN Connect, a network of public servants with disability working across government departments, which provides feedback directly to the Public Service Commission and to me as Minister for Disability Inclusion.
 - Under the Disability Inclusion Act 2014, all NSW government departments and local councils are required to have a Disability Inclusion Action Plan to drive improvements to inclusion of people with disability by understanding and meeting their needs.
- (2) Accessibility professionals specialising in policy, procurement, strategy, and technical product design working within the NSW Government conduct accessibility audits of websites, develop learning modules, and support procurement of digital products, apps and other digital and ICT products and services.
 - A sector-wide community of practice for staff supports the development of in-house accessibility capability in NSW government departments, in line with their Disability Inclusion Action Plans.
- (3) The NSW Government expects people with disability will be provided with practical support to access government services, and be assisted to do business with government. The NSW Government funded Disability Advocacy Futures Program provides targeted funding to organisations to support people with disability navigate government services on a one-to-one basis, funds organisations working towards long-term social change, and funds policy advocacy groups run by, or on behalf of, people with disability. Accessibility professionals work with product teams to provide guidance for departments on designing accessible online forms and to identify and address accessibility issues in NSW Government products, including through reports of accessibility issues encountered by customers and staff with disability.
- (4) Service NSW offers a range of support for people with visible or hidden disability, including the option for customers to book an appointment in a service centre to manage transactions face-to-face with a dedicated customer service representative.
 - Service NSW also offers translation and interpreter services, Auslan video remote interpreters and live captioning. Service NSW is a member of the Hidden Disabilities Sunflower program, and team members are trained to recognise the Sunflower symbol to offer additional assistance, as well as

'Quiet Hour' at most service centres to provide a low sensory environment for customers who prefer a quieter setting.

Service NSW is compliant with the Web Content Accessibility Guidelines and all service centres are accessible.

- (5) The NSW Government is working towards making all government documents that are relevant to people with intellectual disability accessible in Easy Read. This includes developing an Easy Read Style Guide for use across the government, in partnership with people with intellectual disability.
 - Improving engagement and access to services for people with disability is a core responsibility of every government department as part of its disability inclusion action planning.
- * 2933 ONLINE COMMUNITY ENGAGEMENT—Mr Alex Greenwich to ask the Minister for Customer Service and Digital Government, Minister for Emergency Services, and Minister for Youth Justice—
 - (1) Do citizens or community groups who wish to contact Government departments have to open online accounts including providing personal details and passwords?
 - (2) What is the rationale for this requirement and when is it used?
 - (3) What barriers to engagement has the Government identified are caused by this requirement for people:
 - (a) Who only wish to make a simple statement/comment?
 - (b) With disability who may not be able to use online contact systems?
 - (c) Who are concerned about having personal details in multiple locations in case of hacking or data theft?
 - (4) What plans does the Government have to increase accessibility and make it easier for online community engagement?

Answer-

- (1) I am advised that citizens and community groups can provide feedback and engage on policy without opening an account or disclosing personal information. There are various methods to contact NSW Government and provide feedback including webchat, in Service Centre sentiment check (thumbs up thumbs down), and phone. Have Your Say is an online portal for engagement on policy proposals that does prompt for personal information, but alternate channels such as phone and community meeting options are provided for those not wishing to disclose personal information.
- (2) I am advised that there is no such requirement to contact Government.
- (3) As above.
- (4) NSW Government is working to remove the barriers for vulnerable cohorts by making sure that more digital government services can be used by all customers regardless of ability, background or circumstance. One example is the NSW Government's election commitment to make all government documents relevant to people with intellectual disability in Easy Read by 2025, and developing an Easy Read Style Guide with people with intellectual disability.
- * 2934 COMMUNITY ENGAGEMENT—Mr Alex Greenwich to ask the Minister for Planning and Public Spaces—
 - (1) What is the rationale for requiring citizens or community groups who wish to make submissions to major projects and other planning matters on exhibition for public comment to open an account including with personal details and passwords?
 - (2) What assessment has the Government made of barriers to engagement caused by this requirement for people:

- (a) Who only wish to make a simple statement/comment?
- (b) With disability who may not be able to use online contact systems?
- (c) Who are concerned about having personal details in multiple locations in case of hacking or data theft?
- (3) What plans does the Government have to increase accessibility and make it easier for community engagement online?

Answer-

I am advised:

(1) To make a submission on a major project application exhibited by the Department of Planning, Housing and Infrastructure, citizens or community groups are required to have a NSW Planning Portal account.

The requirements encourage accountability and strengthen the legitimacy and transparency of the submissions process. In registering for an account, submitters are informed of their rights and how the Department will use the information provided. User identification is also necessary to exercise appeal rights.

- (2) (a) See response to question 1.
 - (b) The Department is committed to supporting public participation in the planning process. Help and resources are publicly available at www.planningportal.nsw·.gov.au/major-projects/help.
 - For anyone needing further support, Service NSW can provide over the phone assistance to help people make their submission. Service NSW can be contacted on 1300 305 696 and choosing option 2
 - (c) The NSW Planning Portal adheres to government mandated cyber security protocols and requirements. Any personal information that is collected is managed in accordance with the Privacy and Personal Information Protection Act 7998 and the Department's Privacy Management Plan. This information is publicly available at www.planning.nsw.gov.au/privacy.
- (3) In the next financial year, the Department will combine the two planning websites (www.planning.nsw.gov.au and www.planningportal.nsw.gov.au) and review for accessibility, plain English and user experience.
- * 2935 NOISY VEHICLE ENFORCEMENT—Mr Alex Greenwich to ask the Minister for Customer Service and Digital Government, Minister for Emergency Services, and Minister for Youth Justice representing the Minister for Climate Change, Minister for Energy, Minister for the Environment, and Minister for Heritage—
 - (1) How many complaints has the Government received in the past year and past five years about motor vehicles breaching noise controls?
 - (2) Is the number of complaints/reports increasing or decreasing?
 - (3) How many vehicle owners have received penalties in the past year and past five years for:
 - (a) Selling a vehicle that has noise control equipment that is inappropriately modified, defective or missing?
 - (b) Using a vehicle on a road or road-related area that exceeds the prescribed noise limit?
 - (c) Causing or permitting a vehicle to be used when its noise control equipment is defective, is not securely in place or is missing or the vehicle has temporary noise reduction devices or packing fitted?

- (d) Modifying or repairing a vehicle so that its noise control equipment is made defective, is not securely in place, is missing, or has temporary noise reduction devices or packing fitted?
- (4) What plans does the Government have to improve enforcement of noisy vehicles?

Answer-

- (1) 4,455 reports about noisy vehicles were received in the 12 months up to the 30 April 2024. 34,195 reports were received for the past five year period (2019 to 2023 inclusive).
- (2) The number of reports is trending down, although report numbers have fluctuated over the past five year period.
- (3) In relation to the number of penalities issued to vehicles owners in the past year and past five years:
 - (a) None
 - (b) None for the past 12 months up to the 30 April 2024. 74 penalties have been issued in the past five years.
 - (c) None for the past 12 months up to the 30 April 2024. One penalty has been issued in the past five years.
 - (d) None.
- (4) The NSW Environment Protection Authority (EPA) acts on community, NSW Police and local council reports of noisy vehicles via the 'Report to EPA' application on the EPA's website. The EPA may send a legal notice to the vehicle's registered owner, directing the owner to take their vehicle to an EPA approved inspection station to have its exhaust system noise-tested and its pollution control equipment inspected if a second or subsequent report received from a member of the community (more than 21 days after the issue of the advisory letter).

In addition, the EPA participates in joint compliance operations organised by NSW Police and Transport for NSW in areas identified as having noisy vehicles that significantly impact the community. During these operations, the EPA may issue on the spot fines or issue directions for an inspection at an EPA approved station to drivers of noisy vehicles that exceed prescribed noise standards or who modify exhausts and other pollution control equipment.

The EPA is also working to implement the NSW Government election commitment to trial vehicle noise camera detection technology in the Bayside and Wollongong local government areas. Once the trial has concluded, the NSW Government will evaluate whether to expand the use of vehicle noise cameras to areas where noisy vehicles impact the community.

- * 2936 VEHICLE INSPECTION ENFORCEMENT—Mr Alex Greenwich to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—
 - (1) How many complaints has the Government received in the past year and past five years about Authorised Inspection Scheme inspections?

Answer—

I am advised

(1) From April 2023 to April 2024, approximately 207 complaints were referred to Transport for NSW about the Authorised Inspection Scheme (AIS). From July 2021 to April 2024, approximately 397

- complaints were referred to Transport for NSW about the AIS, noting that there is no available data before July 2021.
- (2) Transport for NSW undertakes regular audits of AIS stations and investigates their compliance to both the business and inspection rules. Following such audits, Transport for NSW may apply sanctions which could range from warnings and further education to suspension or cancellation of the proprietor/examiner. Transport for NSW will also prosecute where there has been high risk behaviour impacting safety or repeat offenders.
- (3) Transport for NSW does not hold this information. This is a matter for Minister for Energy, Climate Change, Minister for Environment and Heritage and the Environment Protection Authority, who is the agency responsible for noise control regulations and enforcement.

All of the approximately 500 platforms on the Sydney Trains network have different designs and conditions. Each platform, track, train type and operating conditions must be assessed for the suitability for fitment of gap fillers. Sydney Trains will examine these areas and review in the next round of priorities for the Platform Gap Filler program.

* 2940 FOOD DELIVERY RIDERS AND PLATFORMS—Mr Tim James to ask the Minister for Industrial Relations, and Minister for Work Health and Safety—

The NSW Government committed to expanding rights and protections for gig workers at the election. Safety of gig workers is a regulatory priority for SafeWork NSW.

I am advised:

Part 4.11 of the Work Health and Safety Regulation 2017 requires food delivery platforms to provide riders with personal protective equipment (PPE), unless they have received it from another food delivery platform, and induction training before they are able to commence making deliveries for that platform. This training must include a module on road safety and the selection, fit, use and wearing of PPE. The maximum penalty for noncompliance with this requirement is \$37,950 (345 Penalty Units).

SafeWork NSW is not responsible for enforcing compliance with the NSW Road Rules. The requirements under the WHS Regulation are jointly enforced by SafeWork NSW and NSW Police. This cooperation reflects the important role that NSW Police have in enforcing the NSW Road Rules and their presence within the community.

In its role as the WHS regulator, SafeWork NSW conducts compliance activities to monitor the WHS Regulation requirements by riders and platforms. There were five proactive compliance programs in 2023, with inspectors in the field in delivery hotspots around Sydney.

SafeWork NSW has developed new guidance material for the gig economy, as well as updated guidance for the food delivery sector, including the following fact sheets which have been translated into Arabic, Chinese, Punjabi and Spanish:

Food Delivery Riders – Keeping You Safe

Risks on the Delivery Road fact sheet.

Penalties for non-compliance with the requirements under WHS Regulation commenced on 1 January 2023. Between 1 January 2023 and 16 May 2024 SafeWork NSW issued 48 Penalty Notices to food delivery riders for breaches of the WHS Regulation.

This question should be referred to the Minister for NSW Police to ensure the provision of accurate figures related to compliance activities that have been undertaken by police officers.

- (1) The NSW Police Force is actively engaged with Transport for NSW, Safe Work NSW, local councils, schools, local media and local bike shops in ongoing education activities relating to compliance. Police will continue to use social media platforms, media campaigns, school education, meetings with Consulates and targeted community engagement events to provide adequate and timely information in relation to safe riding practices. The NSW Police Force continues to -conduct regular targeted operations combining education and enforcement in areas with compliance issues.
- (2) 2021-2022 financial year: 1,130 infringement notices.

2022-2023 financial year: 1,037 infringement notices.

- * 2942 RESOURCES TO REPAIR POTHOLES—Mr Tim James to ask the Minister for Transport representing the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—
 - (1) What additional resources have been allocated to ensure the timely repair of the increased numbers of potholes on state roads?

- (1) Transport for NSW has re-prioritised the work effort of its people as well as its budgets in response to increasing demand for pothole repairs, both specific filling of potholes and preventative maintenance work designed to minimise the number of road defects.
 - Transport for NSW also employs over 1,100 front line staff in regional NSW to provide maintenance services which includes pothole repairs.
- (2) Since the beginning of the contract in July 2021, ConnectSydney has repaired approximately 804 potholes on state roads within the Willoughby Electorate.
- (3) Upon inspection, potholes are assessed based on their criticality, and scheduled for repair within seven business days in Greater Sydney. In regional NSW, Transport currently repairs potholes in an average of four days.
 - This is an improvement from November 2022, the height of damage caused by continued La Nina wet weather, where the time was 12 days on average.

The NSW Civil and Administrative Tribunal (NCAT) cannot determine matters that require the exercise of federal jurisdiction. This arises where the Tribunal is asked to exercise judicial power to determine a dispute between parties who are residents of different states.

In 2017, the NSW Parliament passed legislation inserting Part 3A into the Civil and Administrative Tribunal Act 2013 (NSW). The provisions in Part 3A provide for these matters to be heard and determined by an authorised court (such as the Local Court of NSW), which can exercise federal jurisdiction, instead of the Tribunal.

In practice, parties can still apply to NCAT for assistance in reaching an agreement. If they are not able to settle their dispute or want to have an agreed settlement registered and enforced, they will need to go to the Local or District Court. Similar orders can be made by the Local or District Court and there would be no additional fees unless there was a significant change to the application or appeal lodged with NCAT.

Of the eight pumping station projects in the planning phase, one has been completed and another is in the delivery phase. The other six are in pre-delivery investigation and are anticipated to be completed by the end of 2026.

Condition assessments have been undertaken for the anticipated 41 minor capital replacement works. The scoping and prioritisation of the required electrical renewal works are currently underway.
