- (6)(b) All aerial shooting data is captured using an iPad with an ESRI based field data capture application. The app is tailored for each aerial control program to spatially show consenting and non-consenting holding boundaries. It also shows powerline information, satellite map image and road locations. Each animal controlled is recorded as a GPS way point for the corresponding species. The helicopter track is also recorded.
- (7)(a) The average number of shots fired to kill each animal by species is not recorded.
 - The total ammunition utilised for an operation is documented, but not on a per target species basis.
 - FAAST protocols call for the shooter to apply as many shots as is necessary to ensure the animal is humanely euthanised.
- (7)(b) The two firearms approved for FAAST are in .308 win and 12-gauge shotgun.
- (8) Ammunition used in LLS aerial shooting operations is purchased by LLS for use in our aerial shooting and ground programs. It is not charged to landholders as an expense for the program. All FAAST approved ammunition is purchased from retailers and distributors. In most instances, .308 ammunition is purchased in bulk (10000 40000 rounds). The actual cost per round is variable based on manufacturer and retail v's wholesale.. 308 rounds cost between \$1.80 \$2.30 each.
- (8)(a) Only animals listed on the FAAST Operations Shoot Plan are targeted.
- (9) All shooting operations are carried out under the procedures of the FAAST manual. Further to this, all staff who fulfil ground and in-flight roles, undertake specific training in working around aircraft and team resource management.
 - Written landholder consent is required prior to LLS engaging in aerial shooting on any land. The dates of shooting are communicated to landholders/occupiers to allow planning of people movement and farming activities around the shooting timeframe. In situations where unexpected people are observed in the shooting area, shooting will cease, and the aircraft will move to a new location.
- (9)(a) No reports of additional safety actions have been communicated to the LLS FAAST representatives.
- (10) LLS are not aware of any negative impacts to the tourism, agriculture or conservation sectors. Positive impacts would be derived for agriculture and conservation, however this has not been specifically quantified for these operations.
- (11) Over the past three years, LLS has carried out extensive surveillance and monitoring of pest programs utilising all available techniques and technologies. These methods have been used precull to determine a base-line population and post-cull as an indicator of residual population. Methods used have included fixed wing and drone thermal surveillance, helicopter based thermal surveillance and helicopter based visual distance sampling.
 - DPIRD consult with LLS staff regularly to capture local knowledge on the distribution and density of invasive pests across NSW. This allows for the production of detailed maps showing changes in pest presence, population establishment and estimated density. These maps inform planning and coordination of pest programs in-line with the Regional Strategic Pest Animal Management Plans.
- (12) LLS will continue to consult with industry and our research and development partners to ensure our monitoring and surveillance opportunities remain current and inform best practice.
- (13) Detailed reports are provided to participating landholders during and at the completion of the program. This includes the total number of animals (by species) culled, and location where they were encountered.
