#### (Paper No. 390)

- \* 3020 REGIONAL TRANSPORT AND ROADS—FUTURE USE OF THE GREAT NORTHERN RAILWAY LINE—The Hon. Aileen MacDonald to ask the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism representing the Minister for Regional Transport and Roads—
  - (1) Can you clarify the Government's position on the future of the Great Northern Railway line beyond Armidale?
  - (2) Does the Government have any current plans, funding allocations, or strategic priorities to restore train services on the Great Northern Railway Line north of Armidale?
  - (3) If no plans exist to return rail services, will the Government issue a public statement to confirm this, providing clear and definitive guidance to regional communities about the future use of the rail corridor?
  - (4) Are you aware that this issue has caused significant division within local communities due to conflicting messages and unsubstantiated claims from some advocacy groups suggesting a return of rail services?
  - (5) Will you make a public and unequivocal statement to help provide clarity to the community?
  - (6) Will you make a public and unequivocal statement to help alleviate unnecessary division and misinformation?
  - (7) Will you make a public and unequivocal statement to help support alternative uses of the rail corridor, such as the proposed New England Rail Trail, which has the potential to bring economic, social and heritage benefits to the region?
  - (8) Do you understand the importance of making the Government's position clear given concerns about local misinformation and its impact on community unity?

#### Answer—

#### I am advised

Transport for NSW is not currently undertaking a feasibility study into reopening the rail line from Armidale to the Queensland border and does not have any current plans, funding allocations, nor strategic priorities to restore train services on the Great Northern Railway Line north of Armidale.

The government has committed to delivering Strategic Regional Integrated Transport Plans. These plans will reflect the needs of regional communities and will include detailed evaluations of the community's transport needs now and into the future. They will include actions and initiatives that are costed to enable funding decisions to be made based on priorities.

- \* 3021 SPECIAL MINISTER OF STATE—LOCAL SMALL COMMITMENTS ALLOCATION PROGRAM PAPERS—The Hon. Chris Rath to ask the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism—
  - (1) In relation to the papers that you tabled on 20 November 2024, "Premier's Department: Local Small Commitments Allocation Program: Proactive release of documents" dated 11 November 2024, on what website were these papers or pieces of information published?
    - (a) What was the reason or reasons for proactive release?

Answer-

- (1) The documents are published on the Premier's Department Disclosure Log <u>https://www.nsw.gov.au/departments-and-agencies/premiers-department/access-to-</u> <u>information/local-small-commitments-allocation-advice-and-decisions</u>.
- (a) On March 20 2024, in response to a Question Without Notice on the Local Small Commitments Allocation, I said:

I commit to the House- in the same way that I have done with the other projects- that I am very comfortable releasing the approval paperwork for those projects to the House at the appropriate moment so that members can see for themselves the basis on which a decision was made.

Consistent with that commitment, I arranged to have the approval paperwork and associated briefs published once all projects had been assessed.

- \* 3022 CUSTOMER SERVICE AND DIGITAL GOVERNMENT—COVID-19 MICRO BUSINESS GRANTS—The Hon. Damien Tudehope to ask the Special Minister of State, Minister for Roads, Minister for the Arts, Minister for Music and the Night-time Economy, and Minister for Jobs and Tourism representing the Minister for Customer Service and Digital Government, Minister for Emergency Services, and Minister for Youth Justice—
  - (1) How many audits of COVID-19 micro business grants have been conducted between March 2023 and November 2024?
    - (a) Of these audits, how many have resulted in the requirement for the grant, or some portion of it, to be repaid?

#### Answer—

I am advised that:

- (1) Between November 2022 and November 2024, Service NSW conducted 19,771 COVID-19 micro business grant audits, including 1,500 pilot audits conducted prior to 1 March 2023.
  - (a) 2,295, noting data limitations means this includes data relating to the pilot audits.

Answer-

I am advised:

It is a matter for council to determine how it spends ratepayers' funds.

I made my views on the decision by the City of Sydney to support Rising Tide known in a media article in the Daily Telegraph dated November 26, 2024.

Answer—

I am advised:

This question should be directed to the Minister for Local Government.

- \* 3025 PREMIER—SOLAR PRODUCTION IN THE ENERGY MARKET—The Hon. Rod Roberts to ask the Minister for Climate Change, Minister for Energy, Minister for the Environment, and Minister for Heritage representing the Premier—
  - (1) Speaking on the risk of blackouts to Sydneysiders on Wednesday 27 November 2024, you were quoted by the Sydney Morning Herald as stating: "Wherever possible, wherever it's safe, consider not using energy-intensive appliances between the hours of 3pm and 8pm this afternoon," and "The reason for that is that solar production in the energy market starts to come off from 3pm at exactly

the same time as people return home from work. So, if you can not run your pool filter, not run your dishwasher, not run your washing machine this afternoon between 3pm and 8pm, you'll help the grid." Did you say these words or similar?

- (a) What did you mean by "solar production in the energy market starts to come off from 3pm"?
- (b) Noting that you stated that solar production "starts to come off from 3pm", between what hours does solar production provide its peak output of energy to the New South Wales electrical grid?

Answer-

I am advised;

Solar energy production is dependent on the level of sunlight reaching solar panels. This can be impacted by clouds, dust and other obstacles. It also naturally is impacted by the position of the sun in the sky. As the sun gets lower in the sky, the level of sunlight reaching panels begins to reduce and production is noticeably impacted by 3pm.

Generally, the peak times for rooftop solar generation are when the sun is highest in the sky, between 12pm and 1pm. Utility solar farms are designed to track the sun and can stay at peak output between about 10am and 3pm, or even longer.
