Honourable Ernest Meyer Mitchell on the 21st April, 1943, and that an entry recording his death on that date had been made in the Register of Members of the Legislative Council.

- (2.) The President also announced to the House that, in accordance with the provisions of the eighth section of the Constitution (Legislative Council Elections) Act, 1932-1937, His Excellency the Governor had been notified that the seat of the Honourable Ernest Meyer Mitchell became vacant before the expiration of his term of service through his death on the 21st April, 1943.
- 5. UNIVERSITY OF SYDNEY-ADVANCEMENT OF RELIGION:-The President reported and read the following communication from the Chancellor of the University of Sydney:-

The University of Sydney, 4th May, 1943.

The Honourable the President of the Legislative Council,

The Parliament of New South Wales,

Parliament House, Sydney.

Sir,

The Senate of the University, at its meeting on 3rd May, gave consideration to the Resolution, adopted by the Legislative Council on 13th April. The Resolution reads:-

- "(1) That the attention of the Senate of the University of Sydney be drawn to the fact that one of the purposes for which the University has been established and is supplied by Parliament is the advancement of religion and to the other provisions of the University and University Colleges Act, 1900-1937, particularly Section 18 thereof.
- "(2) That this House requests its representative on the University Senate (Sir Henry Manning) to bring the above matters before the Senate (as the body controlling the appointment of teachers) with a view tc obtaining the opinion of that body as to what limits it considers should be observed by the teaching staff of the University on religious or other controversial matters."

The Senate notes that the Resolution was transmitted to it with a view to some action being taken or suggested, and would respectfully point out that any action would, to be effective, require the imposition of some test, or some limitation, on the utterances of members of the teaching staff

As regards the first, it is laid down in the University and University Colleges Act that no religious test shall be applied to the teachers or the students of the University and yet, without it, it is manifestly impossible to ensure that the views put forward by teachers and students will always be generally acceptable. The Senate desires to affirm its conviction that no such test should be imposed and remembering, as it does, the results which have followed the regimentation of Universities in other parts of the world, it is also strongly of the opinion that nothing but harm would follow the stifting in a University of free enquiry. As regards the imposing of limitations, the Senate has in the past relied, and must continue to rely, on the intellectual integrity, and the good sense and the good taste of its staff to approach all problems in as objective, disinterested, and scientific a spirit as possible, and so to state and argue them as not to inflame people's minds to no good purpose.

The Senate desires also to inform the Legislative Council that every facility and encouragement is given to societies and groups within the University whose object it is to foster the Christian religion and to promote the knowledge and observance of Christian principles.

The Legislative Assembly having this day passed a Bill, intituled "An Act to make certain provisions for insuring the secrecy of the police wireless code; for this purpose to amend the Police Regulation Act, 1899-1941, in certain respects; and for purposes connected therewith,"—presents the same to the Legislative Council for its concurrence.
