- the political activities of Phuong Ngo, including his attempts to secure control of branches of the Australian Labor Party in the electorate of Cabramatta
- allegations that Phuong Ngo was involved in other criminal activities involving drug trafficking and extortion
- the role of the criminal group known as the 5T Gang and other criminal gangs in the Fairfield area
- the alleged influence exercised by Phuong Ngo over Fairfield City Council prior to and following his conviction for the murder of John Newman, and

- (3) Notes that the Wonboyn Lake Oyster crisis following changes in the forest industry, the closure of the tuna cannery and ongoing changes in the fishing industry have devastated this area on the Far South Coast.
- (4) Calls on the Government to work with the Commonwealth Government to have oyster farming and aquaculture enterprises included in the eligibility criteria for natural disaster relief arrangements.
- (5) Calls on the Government to provide urgent help through the Rural Assistance Authority to waive lease payments and other management fees and charges.

- (1) Notes that 17 year old Danielle Evans has been forced to wait for treatment on a massive growth on the brain because the angiogram equipment necessary for her treatment has been out of action at Prince of Wales Hospital since late last year.

- (3) Notes that contrary to claims in a press release issued by the Minister, Danielle could not have had treatment at St George Hospital at any time during the past six weeks.

- (2) Notes that the Minister for Agriculture in this place declined to address the question making no commitment as to when the vaccine will be available and whether those sheep vaccinated would be able to be traded.
- (3) Notes that the Minister for Agriculture stated that he was unable to approve wider use of the vaccine outside the approval process, which conflicts with reported statements by Commonwealth Serium Laboratory.
- (4) Notes that the position of many sheep owners caught in the Ovine Johnes Disease net is parlous.
- (5) Calls on the Government to recognise the urgent need for wide, unrestricted use of the Gudair vaccine by sheep producers.

18 Mrs SKINNER to move—

That this House

(1) Notes that Nowra specialist Dr Patrick McSwiney has today advised that five child patients have had their surgery cancelled at Shoalhaven Hospital because of a lack of beds.

- (2) Notes the recovery ward is being used as a general ward, the day surgery ward is being used for long stay patients, the casualty department is being used as a ward and ICU on three occasions this week has had more than its quota of patients.
- (3) Calls on the Premier to listen to the concern of local doctors regarding the acute shortage of health services at Shoalhaven Hospital when he visits the Shoalhaven.

19 Mr HARTCHER to move—

That this House:

- (1) Notes the report from the NSW Local Government Boundaries Commission on the proposed boundary changes affecting the Sydney City, Leichhardt and South Sydney Local Government Areas.
- (2) Notes that the report from the Boundaries Commission contains two conflicting boundary proposals, including one proposal which detours to place key development sites within the boundaries of Sydney City.
- (3) Calls on the Minister for Local Government to refer the boundaries proposals to the Independent Commission Against Corruption to examine the process leading to the final determination of the boundaries proposal.

20 Mr ARMSTRONG to move—

That this House calls on the Premier:

- (1) To introduce appropriate legislation and regulations to exclude charitable organisations turning over less than \$300,000 per annum and volunteer workers assisting those organisations from public liability prosecution.
- (2) To bring in appropriate legislation and regulation to establish \$36,000 as the threshold figure wherein personal injury assessed below that figure be at the risk of the complainant.
- (3) To acknowledge that hundreds of community organisations are at risk of being forced to either postpone or cancel community events across the State because of spiralling public liability insurance costs.

21 Mr DEBNAM to move—

That this House:

(1) Calls on the Premier to explain whether the new CityRail timetable was postponed due to lack of drivers, lack of carriages or angry commuter response to the new slow timetable.

(2) Notes that despite the Minister's claims a month ago that CityRail was urgently recruiting new train drivers, the advertisement only appeared on the weekend and it's for three year traineeships.

22 Mr TORBAY to move—

That this House:

- (1) Condemns Qantas Link for their cavalier attitude to country air services where they have a monopoly.
- (2) Expresses its concern regarding the community feedback, highlighting increased airfares, the lack of Frequent Flyer seats and reduction of services without public consultation.

23 Mr CULL to move—

That this House:

- (1) Commends the Tamworth City Council for organising the New South Wales Summit on the Rural Doctor Shortage held in Tamworth on 18-19 April 2002.
- (2) Notes the recommendations of the Summit.
- (3) Notes that no members of the New South Wales Parliamentary Group of Country Labor attended the Summit.

24 Mr ARMSTRONG to move—

That this House:

- (1) Calls on the Government to conduct a full and independent public inquiry into allegations published in the Sydney Morning Herald of 6 and 7 May 2002 regarding possible breaches of the Fertiliser Act 1985.
- (2) Acknowledges the reported comments by agriculturalists, soil scientists and other experts in relation to such matters as the lack of testing, incorrect labelling and chemical residues.
- (3) Notes the urgency of this matter and further notes the uncertainty that these allegations are creating in the food and fibre marketplace, both nationally and internationally.

25 Mrs HOPWOOD to move—

That this House:

- (1) Notes that Cronulla, Sutherland, Blue Mountains, Central Coast and Hornsby commuters have expressed concern over the Government's plan to reduce and change services in the new slower CityRail timetable.
- (2) Notes that the Minister for Transport's solution to overcrowding on the 3.22 p.m. weekday train from Asquith has been to cancel the Asquith stop in the new timetable.

26 Mr ARMSTRONG to move—

That this House recognises:

- (1) The existing West Wyalong Fire Station building is totally inadequate.
- (2) The building was erected in the late 1920's and is now outdated in terms of accommodating the town's firefighting unit and modern specialist equipment.
- (3) The expenditure of funds on the removal of dangerous asbestos from the building and the construction of a new roof is only a band-aid measure.
- (4) There is an urgent need for the planned redevelopment of the fire station at an estimated cost of \$550,000 to be brought forward and included in the 2002-2003 State Budget.

27 Mrs SKINNER to move—

That this House calls on the Minister for Health to explain why on 18 January 2002 he approved United Medical Protection (UMP) as an insurer under provisions of the Health Care Liability Act when he knew the organisation was insolvent and not likely to survive.

28 Ms HODGKINSON to move—

- (1) Notes with concern that the 156 former employees of the Woodlawn Mine have now been waiting for their unpaid entitlements for more than four years.
- (2) Notes that an agreement between the Administrators of the Woodlawn Mine and Collex Waste Management has been reached to allow the employees to be paid their full entitlements.

- (3) Expresses its concern that continuing delays by the State Government in approving Collex's infrastructure projects has meant that the agreement cannot be concluded and that Miners are still owed \$4.8 million.
- (4) Calls on the Government to immediately approve the Clyde Waste Transfer Station to enable the former Woodlawn employees to receive their unpaid entitlements.

29 Mr DEBNAM to move—

That this House:

- (1) Notes that at 10 pm on 7 May 2002 CityRail passengers were delayed at Warrawee because a Millennium Train broke down and blocked the line.
- (2) Notes that CityRail staff confirmed that the train's brakes had frozen.
- (3) Calls on the Minister for Transport to:
 - (a) Come clean on all Millennium design, production and testing problems.
 - (b) Ensure that further testing takes place after the day's passenger timetable has finished.
 - (c) Tell commuters when they can realistically expect to see Millennium Trains in service.

30 Mrs SKINNER to move—

That this House notes that country hospitals are being paralysed by a shortage of anaesthetists and that:

- (1) Albury patients are being flown to Melbourne and Sydney due to the closure of the hospital's Intensive Care Unit as a result of anaesthetists rejecting unfair employment contracts.
- (2) Dubbo anaesthetists are being forced to work a one-in-three after hours roster, contrary to the AMA's safe working hours code.
- (3) Lismore anaesthetists have, under pressure, signed temporary contracts which expire on 30 June.
- (4) Anaesthetist shortages are also affecting hospitals at Tamworth, Armidale, Grafton, Coffs Harbour, Manning Base, Shoalhaven, Orange, Bathurst and Griffith.

31 Mr ARMSTRONG to move—

That this House:

- (1) Notes that a deposit has been paid and an agreement reached for the sale of Hazleton and Kendall Airlines to the Australiawide airlines syndicate.
- (2) Calls on local, state and federal governments to support the airlines by actively encouraging both elected members and staff to use the airlines whenever possible, particularly during the crucial period of re-establishing regular air services.
- (3) Calls on the airlines new owners to give serious consideration to the possibility of providing air services to the more than twenty four regional towns and communities that have lost their air services in the previous two years.
