- (1) Remissions are only considered in extraordinary circumstances. In general the circumstances for remission need to have arisen after the penalty was imposed, and should not be a foreseeable consequence of the disqualification.

- (3) All remissions granted in 2005 were based on medical grounds relating to the applicant's immediate family. The relatively short period of the remaining driving disqualification period was also an important factor taken into consideration.

Answer—

NSW Police has advised me:

The Department of Juvenile Justice is in the process of implementing a program to assume responsibility for most juvenile escorts across the state. On 1 July 2006 the final stage of this program will commence in the Southern Region, which encompasses Wagga Wagga and Albury.

Following the completion of this process, police will only be required to carry out the first escort of a juvenile to a detention centre or court, with the Department of Juvenile Justice performing this duty for all subsequent journeys. These arrangements have already seen significant savings in police time across other areas of the state.

Answer—

The Ministry for Police has advised me :

(1) Albury police station has undergone works totalling over \$150,000 in the last four years including automatic gates, security enhancement, Target Action Group fitout, storage and general refurbishment. Culcairn, Henty and Walla Walla police stations/residences each received \$20-\$25,000 worth of air conditioning and security upgrades in 2004-05. A review is currently underway of Tumbarumba police station prisoner handling facilities in preparation for a future upgrade.

Approximately \$575,000 was expended on maintenance of Albury Local Area Command police stations/tesidences from July to December 2005, with \$130,000 worth of significant programmed maintenance works at Albury, Culcairn, Henty and Mulwala stations in the 2005-06 financial year.

- (1) Capital Country Tourism is one of the 15 NSW Regional Tourism Organisations (RTOs). RTOs are independent incorporated tourism industry bodies. While Tourism New South Wales works closely with the tourism industry via these and many other tourism industry associations the process to appoint new staff members is a responsibility of the Capital Country Tourism Board of Directors not Tourism New South Wales.
- (2) This is a matter for the Board of Capital Country Tourism.

Noting the analysis by Professor Simon Chapman and Associate Professor Philip Alpers from the University of Sydney that shows a remarkable reduction in gun deaths in the last ten years since rapid-fire rifles and shotguns were banned:

- (1) What evidence does the NSW Government have about the role of handguns in gun deaths over the past 10 years?
- (2) What action has the NSW Government taken to:
 - (a) Prevent semi-automatic handguns from use for suicide and homicide?
 - (b) Ensure that fast draw, lightweight titanium, reduced recoil, and guns with laser sights handguns are not used for suicide and homicide?
 - (c) Ensure that replica, deactivated, converted and imitation handguns are not used for suicide and homicide?
 - (d) Ensure that handguns are safely stored?
- (3) What other action does the Government plan to take to ensure that gun deaths continue to decline?
- (4) Will the NSW Government support action proposed by the Prime Minister to prevent dun deaths?

Answer-

NSW Police has advised me:

- (1) The Australian Institute of Criminology has reported that, for the period 1996 2004, there have been 113 homicides in New South Wales involving the use of a handgun.
- (2)
- (a) NSW legislation enforces a 28-day 'cooling off' period for all firearms licence applicants. This significantly reduces the opportunity for spontaneous firearm related situations. Stringent safe storage requirements are placed on each private and commercial owner of firearms and such facilities are rigorously inspected by police.
- (b) The attributes mentioned do not contribute to the lethality of a firearm and such weapons are not considered separately from other handguns.
- (c) Replica, deactivated and imitation handguns are not capable of firing a projectile and cannot contribute to suicide or homicide. There is no information to indicate that any 'converted' replica firearm has been used in any suicide or homicide.
- (d) I refer the Honourable Member to parts 7 and 8 of my response to her Question on Notice No. 5855 on this subject.
- (3) NSW Police will continue to proactively investigate and prosecute persons involved in the illegal trafficking of firearms, removing the availability for them to be used in violent crimes or suicides. Efforts will also continue with the assistance of the community in identifying the location of illegal firearms, enabling police to take appropriate action to seize these weapons.
- (4) It is unclear to what proposed action this question refers. However, as advised in my detailed response to the Honourable Member's previous Question on Notice No. 4213, NSW has implemented the Prime Minister's increased controls over handguns.

Answer-

The Bureau of Crime Statistics and Research (BOCSAR) analyses NSW recorded crime statistics. I suggest the Honourable Member's questions are more appropriately addressed to the Attorney General, within whose portfolio the Bureau resides.

NSW Police has advised me :

In order to determine the origin of a firearm that has been used in the commission of a crime, it must be identifiable when recovered. The bulk of recovered stolen firearms have the serial number obliterated, making it difficult to ascertain their origin. However, registered firearms held by the Security Industry since 2005 may be identified through stored Forensic Ballistic details. The Forensic Ballistic Unit advises that, to date, one recovered security industry firearm is known to have been used in the commission of an offence.

The Safe Storage Audit Project undertaken in 2003-04 entailed officers auditing 130,986 individual licensed firearm holders and over 500,000 firearms. This audit involved the sighting of each firearm, both long arms and handguns, the sighting of licences and inspection of the safe storage receptacle for each firearm category possessed. This project coincided with the statewide audit of all security companies in February 2004.

The Firearms and Regulated Industries Crime Squad also coordinates ongoing audits of Firearms Dealers to ensure safe storage requirements are being met in the commercial arena.

Category H licence holders must comply with rigorous safe storage provisions under the Firearms Act and are subject to serious penalties if breaches occur. Annual audits of safe storage facilities across all security firms in NSW also take place.

Amendments to the Security Industry Act have tightened the 'genuine need' requirements for armed security guards. This has further reduced the number of handguns in the industry.
