#### 2 APRIL 2012

(Paper No. 80)

- \*1895 PUBLIC TRUSTEE—Mr Richard Amery asked the Attorney General, and Minister for Justice—
  - (1) When was the last time that the fees and charges relating to the cost charged by the Public Trustee were reviewed?
  - (2) What was the outcome of this review?
  - (3) Has there been any reduction in the sliding scale of the capital commission charged by the Public Trustee to administer an estate?
  - (4) When was the last time that these fees were adjusted to take into account the rise in real estate values in NSW?

Answer-

I am advised:

- (1) The fees and charges of the Public Trustee (now the NSW Trustee and Guardian) were last reviewed in 2008.
- (2) Fees were increased in accordance with CPI increases, the maximum allowable common fund management fee was increased from 0.5 per cent to 1 per cent and a long term trust fee was introduced.
- (3) No changes were made to the sliding scale of capital commissions in the 2008 review.
- (4) There have been no other changes to these fees since 1975, whether to take account of rising real estate values or otherwise.
- \*1898 MULTICULTURAL ADVANTAGE GRANTS PROGRAM—Mr Robert Furolo asked the Minister for Citizenship and Communities, and Minister for Aboriginal Affairs—

In reference to the Multicultural Advantage Grants Program:

- (1) What is the dollar value of grants that will be available for each of the three new categories of grants?
- (2) How will the success or effectiveness of Multicultural Advantage Grants Program be assessed?
- (3) What are the priority areas for funding for the Multicultural Advantage Grants Program?
- (4) What is the eligibility criteria for the Multicultural Advantage Grants Program?
- (5) (a) Will the General Grants Program continue?
  - (b) If so what will be the dollar value available to the General Grants Program?
- (6) (a) Will the Sponsorship Grants Program continue?
  - (b) If so what will be the dollar value of grants available to the Sponsorship Grants Program?
- (7) Who conducted the independent review of the CRC's former grants program?
- (8) Which organisations were consulted and how many consultations were undertaken by the review consultants?
- (9) What was the cost of the review?

Answer-

(1) It is anticipated that funds available for the Multicultural Advantage Grants Program will be in the order of \$1.4 million. However, final figures will be determined after the Budget is brought down.

As a general guide the allocations will be:

35% for Multicultural Partnership Grants

60% for Community Inclusion Grants, and

5% for Sponsorship and Cultural Grants

- (2) The Commission is in the process of developing policy guidelines and assessment processes.
- (3) All three grants categories will be in line with the principles of cultural diversity, including priority to projects which facilitate inter-cultural and inter-communal activities. They will encourage inclusion and the promotion of community harmony through mutual respect and acceptance by working together towards a common aim.
- (4) to (6) The Commission has reviewed its grants program which included the General Grants program, and from 1 July 2012 the Commission will introduce the Multicultural Advantage Grants Program comprising three categories: Multicultural Partnership Grants, Community Inclusion Grants and the Sponsorship and Cultural Grants. Eligibility criteria are under finalisation. In terms of funding allocation, see answer to question (1) above.

There will be a Sponsorship and Cultural grants category which will support community cultural activities including a new emphasis on community arts where appropriate.

- (7) EJD Consulting & Associates an independent social policy research firm conducted the review.
- (8) Major community organisations, former grant applicants (successful or unsuccessful) and organisations from new and emerging communities were invited to participate in consultations. The following attended the Grants and Awards Program Reviews Consultations: Ethnic Communities' Councils of NSW, Multicultural Council of Illawarra, Ethnic Communities' Council of Newcastle and the Hunter Region, Multicultural Council of Wagga Wagga, Cabramatta Community Centre, NSW Federation of Community Language Schools, Greek Welfare Centre, NSW Service for the Treatment & Rehabilitation of Torture & Trauma (STARTTS), Sikh Council of Australia Inc, Liverpool Migrant Resource Centre Inc, Australian Iraqi Association of Community Services Inc, Grainery Football Club, Sydney Korean Women's Association, Sudanese Australian Association Inc, Australia Alevi Cultural Centre, Somali Welfare & Culture Association, Auburn City Council, Horn of Africa Relief & Development Agency, Australian Iraqi Association of Community Services Inc, HyeHokiInc, Iranian Community Organisation, Mt Druitt Ethnic Communities Agency Inc, United Indian Association.

Four consultation sessions were conducted. The option to provide written comments was extended to the stakeholders unable to attend.

- (9) The cost was \$21,890.00 (\$19,900 plus GST \$1,990).
- \*1900 PLAN-IT YOUTH—Ms Sonia Hornery asked the Minister for Education—
  - (1) When did the Government decide to discontinue funding for the successful Plan-It Youth Hunter/Central Coast mentoring program after its funding runs out in January 2013?
  - (2) Why did the Government make this decision?
  - (3) What other programs will the Government put in place to replace this program?

#### Answer-

- (1) In September 2007 the Evaluation of the Plan-It Youth Mentoring Program was undertaken by Erebus International. A series of recommendations resulted from the evaluation and extensive feedback on the recommendations was obtained, including the recommendation that the program be undertaken within the broader policy framework of the Department of Education and Communities' 15-19 Year Old Strategy. As a result, additional funds were provided directly to regions for a 4 year period which concludes in June 2012.
  - From the 2012–13 financial year regions will continue to use available equity funding flexibly to target the needs of 15 to 19 year olds and will make local decisions about the use of mentoring programs, including the Plan-It Youth Program.
- (2) This Government is committed to local decision-making which recognises that regions and schools are well placed to identify the specific strategies to support young people who are most at risk of disengaging from education, training or employment.
- (3) The Hunter/Central Coast Region is currently exploring options about the future role of mentors in regard to supporting vulnerable 15 to 19 year old students. A number of support strategies are available at the school and regional level to support these students. Resources such as the support document for regions targeting 15-19 year olds and guidelines for mentoring and supporting students also remain available for school and regional use.
- \*1901 INDUSTRIAL RELATIONS COMMISSION—Ms Sonia Hornery asked the Attorney General, and Minister for Justice—

Given the Government's recent review of the Industrial Relations Commission, is the Attorney General planning to abolish the Commission?

Answer-

I am advised:

The Legislative Council Standing Committee on Law and Justice's recommendations impact upon a number of portfolios across Government. The committee has asked the Government to report by 24 September 2012. The Government is actively considering the committee's recommendations and will respond in due course.

\*1902 POLICE TASER DEATH—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

- (1) What will the Minister do to ensure that the death of a Brazilian student, as a result of a police Taser, will be investigated thoroughly?
- (2) What will the Minister do to ensure that any investigation into the Brazilian national's death will be independent and transparent?

Answer-

The NSW Police Force has advised me:

(1) and (2) A critical incident investigation has been established following this incident. All circumstances surrounding this death are being investigated, including the deployment of police tactical options, with all information to be provided to the NSW Coroner. The NSW Ombudsman has independent oversight of this investigation.

This Government has confidence in these mechanisms to provide thorough, independent investigation and oversight of such matters.

\*1903 GLENDALE POLICE STATION—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

Why has the building of the Glendale Police Station, which was budgeted for \$3.82 million dollars in the 2011-12 budget, been abandoned?

Answer—

I refer the Member to my detailed response to a Question Without Notice asked by the Hon Marie Ficarra MLC on 4 April 2012 regarding the Lake Macquarie Local Area Command.

\*1904 NEWCASTLE UNIVERSITY SECURITY—Ms Sonia Hornery asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

How will the Government improve security for students at Newcastle University?

Answer—

The NSW Police Force has advised me that police from the Newcastle City Local Area Command have recently met with senior representatives of Newcastle University with a view to implementing a range of measures that will improve security for students. These include recommencement of a Student Safety Council, high visibility police patrols of the University and surrounds both day and night, and physical security improvements on campus such as improved CCTV at the University entrance.

Some measures will specifically focus on international students, such as a series of workshops designed to break down cultural barriers between those students and police that may exist based on their home country experiences. Issues to be addressed include personal safety, crime prevention and means of reporting offences. Strategies to improve communication between University management and police in relation to offences against this group are also being examined.

\*1905 PUBLIC HOUSING MAINTENANCE BACKLOG—Ms Sonia Hornery asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—

How has the Government addressed the \$300 million backlog in maintenance work due for public housing homes across Sydney?

Answer-

The Land and Housing Corporation determines the estimated backlog level of maintenance by undertaking condition surveys across the total portfolio.

The Corporation continues to work towards reducing the overall maintenance liability across its asset portfolio through careful budgeting and informed annual maintenance programs.

The Corporation will continue to prioritise managing the annual requirement to ensure best use of our assets and to maintain the backlog to an acceptable level.

\*1906 JOHN HUNTER AND CALVARY MATER HOSPITALS—Ms Sonia Hornery asked the Minister for Health, and Minister for Medical Research—

What infrastructure upgrades and maintenance works are planned for the John Hunter Hospital and the Calvary Mater Hospital in the 2012-13 financial year?

Answer-

I am advised:

Hunter New England Local Health District is currently in the process of finalising the capital works plan for 2012-2013, including for John Hunter and Calvary Mater Hospitals.

The 2012-2013 capital improvement plan is also being finalised and this encompasses planned maintenance works outside the ongoing preventative and statutory work which takes place on a recurrent basis.

- \*1907 JUDICIARY ACT NOTICE—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
  - (1) Will the Attorney General reply to the email from Matthew Lynch dated 9 March 2012 concerning his notice under s78B of the Judiciary Act?
  - (2) If so, what will the answer be?
  - (3) If not, why not?

Answer-

I am advised:

- (1) The New South Wales Crown Solicitor's Office replied to Matthew Lynch's email on 17 April 2012.
- (2) and (3) I will not be intervening in this matter.
- \*1908 EXPERT PANEL ON MERGER OF TRIBUNALS—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
  - (1) Who will be the members of the expert panel proposed to be appointed to advise on the merger of the tribunals?
  - (2) When will the make-up and terms of reference be announced?
  - (3) By what date will the expert panel report?

Answer-

I am advised:

The Legislative Council Standing Committee on Law and Justice's recommendations impact upon a number of portfolios across Government. The committee has asked the Government to report by 24 September 2012. The Government is actively considering the committee's recommendations and will respond in due course.

- \*1909 SUBMISSION TO DISCUSSION PAPER ON CONTRACT LAW REFORM—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
  - (1) Has the Attorney General or his department made a submission to the Commonwealth Government's discussion paper on reforming Australian contract law?
  - (2) If so, will the Attorney General make the decision publically available?
  - (3) If no such submission has been made, why not?

Answer-

I am advised:

The discussion paper is under consideration. The deadline for submissions is 20 July 2012.

- \*1910 SUBMISSION TO DISCUSSION PAPER ON CONTRACT LAW REFORM—Mr Paul Lynch asked the Minister for Primary Industries, and Minister for Small Business—
  - (1) Has the Minister or her department made a submission to the Commonwealth Government's discussion paper on reforming Australian contract law?
  - (2) If so, will the Minister make the submission publically available?
  - (3) If not, why not?

Answer—

- (1) to (3) I am advised that the Department of Premier and Cabinet will be coordinating any response on behalf of the NSW Government. Submissions to this inquiry do not close until 20 July 2012.
  - Submissions on the discussion paper will be publicly available on the Commonwealth Attorney General Department's website.
- \*1911 JUDICIAL COMMISSION—Mr Paul Lynch asked the Attorney General, and Minister for Justice—

What communications and discussions have occurred between the Attorney General and his office with the Judicial Commission on any matter in the period 1 January 2012 to date?

Answer—

I am advised:

On 25 January 2012 and 8 February 2012, pursuant to section 16 of the Judicial Officers Act 1986, I referred to the Judicial Commission matters concerning the conduct of Magistrate Pat O'Shane.

I have had communications with the Research Director of the Judicial Commission in relation to policy research concerning sexual assault and firearm offences.

My department regularly consults with the Judicial Commission on relevant policy matters.

- \*1912 BAIL ACT REVIEW—Mr Paul Lynch asked the Attorney General, and Minister for Justice—
  - (1) Has the Attorney General received a report from the Law Reform Commission on a review of the Bail Act?
  - (2) If so, when did the Attorney General receive it?
  - (3) If the report has not been received, when does the Attorney General anticipate receiving it?

Answer—

- (1) Yes.
- (2) The report was received on 11 April 2012.
- (3) Not applicable.
- \*1913 INVESTIGATION INTO CONSTRUCTION SITE DEATH—Mr Paul Lynch asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—

What investigations are agencies within the Minister's portfolio (including WorkCover) conducting in relation to the death of Atilio Villegas on 27 March 2012 at a construction site in Haymarket?

Answer-

WorkCover attended the worksite on the day of this tragic fatal incident. WorkCover has issued two Prohibition Notices and two Improvement Notices. As WorkCover's investigation into this incident is continuing, it would be inappropriate for me to comment further.

\*1914 COMMUNICATIONS WITH LEIGHTONS AND PERFORMS—Mr Paul Lynch asked the Treasurer representing the Minister for Finance and Services, and Minister for the Illawarra—

In the period 26 March 2012 to date, what communications, correspondence and/ or discussions has the Minister had with:

- (a) Leightons;
- (b) Performs?

Answer—

I am unable to identify the entities referred to.

\*1915 WRONGFUL DETENTION—Mr Paul Lynch asked the Attorney General, and Minister for Justice representing the Minister for Police and Emergency Services, Minister for the Hunter, and Vice-President of the Executive Council—

Given that police were unaware of court determinations, in how many instances since 31 March 2011 have they wrongly detained:

- (a) young people;
- (b) adults?

Answer-

The NSW Police Force has advised me:

Police have been working closely with the Department of Attorney General and Justice to resolve problems with the flow of information between court computer systems and the police database. Data about arrests made on the basis of incorrect bail information is not held discretely on the police database and accurate information cannot be provided.

- \*1918 CAPACITIES OF WYNYARD STATION AND PROPOSED WYNYARD TUNNEL—Mr Jamie Parker asked the Minister for Transport—
  - (1) What is the forecast hourly capacity of the proposed Wynyard tunnel?
  - (2) What is the current hourly capacity of Wynyard Station?

- (3) How much of the extra capacity delivered by the proposed Wynyard tunnel will be handled by Wynyard Station?
- (4) What plans are in place to increase the capacity of Wynyard Station in order to handle the increased flow of people through the proposed Wynyard tunnel?

#### Answer\_

- (1) The pedestrian tunnel to be constructed as part of the Wynyard Walk project has been designed for a capacity of up to 20,000 pedestrians per hour.
- (2) In 2011, the number of rail passengers exiting through Wynyard Station's ticket gates in the morning peak ranged between 22,000 and 24,000 passengers per hour, however between 8-9,000 people currently use the Kent St exit per hour.
- (3) and (4) Transport for New South Wales will undertake a number of upgrades to the station to improve pedestrian flow. These works include installing additional ticket gates and widening the concourse area leading to the entrance of Wynyard Walk. Long-term plans for CBD stations will be dealt with by the Long Term Transport Master Plan, due by the end of the year.
- \*1919 SCHOOL HAND WASHING FACILITIES—Ms Carmel Tebbutt asked the Minister for Education—

Are government schools required to provide satisfactory hand washing facilities for students, including soap and paper towels or hand dryers?

Answer—

NSW Government schools are required to provide appropriate cleansing agents and a method of drying for student hand washing.

#### 3 APRIL 2012

(Paper No. 81)

- \*1920 LIMITED TENURE OF GRAVE SITES—Mr Richard Amery asked the Minister for Primary Industries, and Minister for Small Business—
  - (1) Has the Government announced the review of legislation that covers all aspects of the funeral industry in New South Wales?
  - (2) (a) Will this review include consideration of the burial system known as limited tenure of grave sites?
    - (b) If so, will the Minister rule out adopting a limited tenure of grave sites policy?

#### Answer-

- (1) I recently announced significant reforms in Cemetery and Crematoria management in NSW. These reforms include a more streamlined management of the Rookwood Necropolis, a commitment to develop a single piece of legislation to streamline management and governance of all cemeteries in NSW and the establishment of a NSW Cemeteries and Crematoria Board to replace the Crown Cemeteries Advisory Committee (CCAC).
- (2) (a) While the CCAC has developed a position on renewable tenure burials, the Government is still to consider this policy approach.

(b) No.

- \*1921 PENALTIES AND DETERRENTS FOR CRIMES—Ms Sonia Hornery asked the Attorney General, and Minister for Justice—
  - (1) In view of the increasing crimes in the Hunter, including armed robberies, what is the Government doing to make the penalties fit the crime and discourage people from committing crimes?
  - (2) What programs can magistrates direct people who have committed a crime undertake to enable them to see the consequences of their actions against their victims?
  - (3) What additional resources are being spent to increase programs that work to deter a person from reoffending?

Answer—

I am advised:

The Bureau of Crime Statistics and Research (BOCSAR) recently released its annual recorded crime statistics that show that crime is generally stable in the Hunter, with only one offence (steal from motor vehicle) showing an upward trend.

The Law Reform Commission of NSW (LRC) is currently reviewing the Crimes (Sentencing Procedure) Act 1999 including consideration of current sentencing principles, the need to ensure that sentencing courts are provided with adequate options and discretions and opportunities to simplify the law whilst providing a framework that ensures transparency and consistency. The LRC will report in October 2012. Details of the review are available on the Lawlink website.

There are currently a number of innovative court-based programs available in NSW, which are designed to discourage reoffending. Of these programs, the NSW Drug Court, Forum Sentencing and the Magistrates Early Referral Into Treatment (MERIT) program are all available within the Hunter region.

While the Drug Court and MERIT are designed to address the offender's drug and/or alcohol problems in order to prevent reoffending, Forum Sentencing is specifically designed to bring the offender face to face with the victim in order to discuss what happened, the harm caused by the offence and prepare an "intervention plan" for the offender.

The NSW Government has also committed resources to further measures aimed at reducing reoffending. This includes providing funding for education and training programs in prison and creating a dedicated Metropolitan Drug Treatment Facility for offenders (other than sex offenders) convicted of drug related crimes

\*1922 NEPEAN HOSPITAL TELEHEALTH TECHNOLOGY CENTRE—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the promised \$2 million for Telehealth Technology Centre at Nepean Hospital;

- (1) What will be the main purpose(s) of this centre?
- (2) What will be the total cost of this centre for:
  - (a) establishment;
  - (b) recurrent funding?
- (3) How much of this \$2 million funding will be allocated in the 2011-12 financial year?
- (4) How much of the allocated budget has been spent as at 31 March 2012?
- (5) Is the centre operational?
- (6) If yes;
  - (a) On what date did operations begin?
  - (b) How many patients have utilised the Telehealth service?
  - (c) What services were the most used?
- (7) If no, when does the Minister expect services to begin?

#### Answer-

I am advised:

- (1) The Nepean Telehealth Technology Centre will support the health of the people of Western Sydney and regional and rural NSW through the provision of health services through telehealth. The Centre will complement other statewide telehealth strategies to support clinicians and patients in rural and regional areas providing access to clinical advice and education.
- (2) (a) and (b) \$2 million which allows for the infrastructure to be established using advances in broadband and technology. Funding will be provided over four years at \$500,000 per annum. There is no recurrent funding attached to this project.
- (3) \$500,000 was received in October 2011.
- (4) Orders have been placed for equipment and this initial funding will be expended by 30 June 2012.
- (5) The Centre has been established with Professor Mohamed Khadra chairing a Steering Committee to develop and oversee the workplan of the Centre.
- (6) The first meeting of the Steering Committee was held in October 2011.
- (7) It is expected that services will be provided by the Centre commencing in the 2012-13 financial year.
- \*1923 NSW PAIN MANAGEMENT PLAN—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the Minister's statement in October 2011 that the report of the taskforce into the promised statewide NSW Pain Management Plan would be submitted to the Government on 30 September 2011 (Written Question 0951):

(1) On what date was the report submitted to the Government?

- (2) Has the report been made publically available?
  - (a) If yes, on what date?
  - (b) If no, when is release planned?
- (3) (a) Has the statewide NSW Pain Management Plan been released?
  - (b) If no, when is the planned release date?
- (4) What funding enhancements specifically for pain management services are included in the 2011-12 budget?

Answer-

#### I am advised:

- (1) to (4) The NSW Pain Management Taskforce, established by this Government, submitted a draft NSW Pain Management Plan for consideration in October 2011. The Ministry of Health and the Agency for Clinical Innovation Pain Management Network are working closely to develop the Model of Care and corresponding resources which will be part of the upcoming State Budget.
- \*1925 COMMUNITY PHARMACIES—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the \$10 million commitment for Community Pharmacies and the \$2 million committed for the 2011-12 financial year by the Government (Written Question 0921):

- (1) How much has been spent by 31 March 2012?
- (2) How has the money been spent?
- (3) Have any patients been seen/treated under this programme as at 31 March 2012?
- (4) Who is on the expert committee?
- (5) How many times has the committee met?

Answer-

#### I am advised:

(1) to (3) Following extensive consultation, the Ministry of Health has recently finalised contract negotiations with the National Stroke Foundation and Pharmacy Guild of Australia (NSW) to deliver the "Know Your Numbers" program as the community health checks component of the Community Pharmacies commitment.

As at March 2012, \$1.2 million had been allocated to the Stroke Foundation and the Pharmacy Guild to run the community health checks program.

- (4) to (5) The Advisory Group included representation from the National Stroke Foundation, the Pharmacy Guild of Australia, General Practice NSW, Royal Australian College of General Practitioners, Australian Diabetes Council and the Heart Foundation. The Advisory Group has met 4 times in the past 8 months.
- \*1926 PREVENTATIVE HEALTH FIGHTING FUND—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

With regards to the preventative health fighting fund, and the \$24.1 million committed by the Federal Government for the 2011-12 financial year (Written Question 0763):

- (1) What is the NSW Government allocation for 2011-12?
- (2) What is the total 2011-12 budget for this fund?
- (3) How many positions have been funded?
- (4) How many staff have been recruited?
- (5) In which location in South Western Sydney is the office?
- (6) What work has been performed to date?

Answer—

### I am advised:

(1) to (6) In 2011-12 the budget allocation for obesity initiatives in NSW is over \$35 million.

The Office of Preventative Health will be located in existing NSW Health accommodation in South Western Sydney in accordance with the NSW Government's commitment.

Governance arrangements for the Office of Preventative Health are currently being finalised.

\*1927 BLUE MOUNTAINS HOSPITAL MATERNITY UNIT—Dr Andrew McDonald asked the Minister for Health, and Minister for Medical Research—

The World Health Organisation estimates that approximately 25% of those diagnosed with chronic hepatitis B infection will develop advanced liver disease later in life:

(3) to (4) The management, monitoring and treatment for hepatitis B in NSW is provided in specialist public and private gastroenterology/liver services. General Practitioners play a key role in screening, monitoring and routine follow-up of patients with chronic hepatitis B.

People who are chronically infected with hepatitis B but have no liver damage do not require treatment, but require monitoring with regular blood tests and liver ultrasound as well as advice on lifestyle management. This monitoring and routine follow-up can occur in general practice settings as part of a patient's primary care.

If a person does have liver damage, antiviral medication for hepatitis B is considered, to suppress replication of the virus and decrease the risk of serious liver disease developing later in life. However, it is very rare that treatment will cure hepatitis B infection.

The Australian Government through the Pharmaceutical Benefits Scheme funds several different medications to treat chronic hepatitis B.

(5) The NSW Ministry of Health allocates funding to Local Health District (LHDs) to provide comparable and comprehensive access to services that meet the health needs of their population, including services for the diagnosis, treatment and care of people with hepatitis B. LHDs also liaise closely with General Practitioners and Medicare Locals to develop initiatives that respond to local need and improve clinical referral pathways for people with hepatitis B.

The Ministry also provides funding to projects that aim to increase diagnosis of, and facilitate access to treatment for, chronic hepatitis B in NSW. NSW Health has proposed to the Commonwealth a new arrangement that would pilot the initiation of anti-viral medication in the general practice setting.

(6) Under current arrangements, anti-viral medication is initiated by and monitored in specialist gastroenterology services, in both the public and the private health system. LHDs are provided with the resources to supervise treatment in public health settings. NSW Health is exploring shared-care models of monitoring and treatment between public specialist services and General Practice which will support and enhance the involvement of General Practitioners in providing access to treatment for their patients with chronic hepatitis B.

The Voluntary Management Proposal outlines the process and timing of remediation for the declared area.
