The Government supports a formula based on "nursing hours per patient day" in suitable wards and units, including those at Gosford Hospital.

 - (1) Will the Chief Scientist investigate heavy metal contamination in Newcastle?
 - (a) If not, why?

Answer-

There is considerable research already undertaken into this issue, as well as extensive planning controls and education initiatives.

 - (1) How many students were enrolled at Hunter TAFE in each year from 2011 to 2017?
 - (2) How many teaching staff were employed at Hunter TAFE in each year from 2011 to 2017?
 - (3) How many non-teaching staff were employed at Hunter TAFE in each year from 2011 to 2017?
 - (4) What was the course completion rate at Hunter TAFE in each year from 2011 to 2016?

Answer-

- (1) to (4) TAFE NSW operates in a competitive environment and does not provide data by location.  - (3) What options are available for Members of Parliament to address compliance concerns if department staff are directed not to communicate with them?
 - (4) What further action will the Government take to ensure members of Parliament can advocate on local compliance concerns?

Answer-

(1) An answer was delivered to your office on 14 September 2017.

- (2) There are no restrictions.
- (3) I would suggest raising it with the Minister responsible.
- (4) The Government will always support local members who raise legitimate community concerns.
- *6352 REDUCTION BURNING IN NEW SOUTH WALES NATIONAL PARKS AND FORESTRY AREAS—Mr Guy Zangari asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
 - (1) What is the current progress of reduction burning in New South Wales National Parks and Forestry areas by the NSW National Parks & Wildlife Service?
 - (2) What is the target for reduction burning in 2017?
 - (a) What was the target in previous years from 2011 to date (as at 10 August 2017)?
 - (3) How much reduction burning occurred in New South Wales National Parks and Forestry areas for each year from 2011 to date (as at 10 August 2017)?

Answer-

I am advised:

- (1) Under the Enhanced Bushfire Management Program, the National Parks and Wildlife Service (NPWS) aims to treat 135,000 hectares (ha) each year as a five-year rolling average. NPWS is not responsible for reduction burning in forestry areas.

Answer-

The estimated total cost of every project requested is commercial-in-confidence information as the projects have not been tendered as yet. This allows the department to ensure value for money on school infrastructure projects.

Answer—

I'm advised the current estimated total cost of the Arthur Phillip High School and Parramatta Public School project package is \$225 million.

The current estimated total cost of the Narellan School project is \$20.5 million.

The estimated total costs of the other projects are commercial-in-confidence as these projects have not vet been tendered.

*6357 TRUANCY IN THE CESSNOCK ELECTORATE—Mr Clayton Barr asked the Minister for Education—

- (1) What options is the Department of Education pursuing to reduce the level of truancy in the Cessnock electorate?
- (2) Is the Department working with other community stakeholders to reduce the level of truancy?
 - (a) If so, who are they?
 - (b) Do they hold regular meetings?
 - (i) If so, what are the details of these meetings?
- (3) How many students from the Cessnock electorate of 'compulsory school age' have been directed to attend a compulsory school attendance conference since its inception?
- (4) Generally, what reasons are provided by students who fail to attend school?
- (5) How many parents from the Cessnock electorate have been referred for compulsory attendance enforcement action for failing to ensure their child attends school since 2014?

Answer—

(1) to (5) I'm advised support is provided by staff such as student support officers, school counsellors, and learning and support staff who assist students with additional needs in behaviour, wellbeing and school attendance.

Schools in the Cessnock electorate and departmental officers work with other stakeholders and agencies to improve school attendance. Agencies that support students and the department include NSW Police, the Department of Family and Community Services, the local Aboriginal Education Consultative Group and Headspace.

In Cessnock, the Responding to Educational Neglect program involves an interagency committee that meets once a term to identify and respond to underlying issues affecting school attendance.

Data related to compulsory school attendance conferences and compulsory attendance enforcement is not held centrally by the Department of Education.

Reasons provided for students who fail to attend school are highly contextualised and it is difficult to provide generalised descriptions.

- *6358 SPECIAL INFRASTRUCTURE CONTRIBUTION—Ms Jodi McKay asked the Minister for Planning, Minister for Housing, and Special Minister for State—
 - (1) How much will be raised from the Special Infrastructure Contribution (SIC)?
 - (2) How much will the SIC contribute to the Parramatta Light Rail?

Answer-

I am advised:

- (1) The range for the 12 Special Infrastructure Contribution (SIC) areas across metropolitan Sydney is \$4.2 to \$6.5 billion. This does not include the newly announced priority precincts that are outside the proposed Special Contribution Boundaries we have not commenced work at this time
- (2) Regarding Greater Parramatta and Olympic Park Total forecast SIC income is \$1.7 billion. Given Government's previous commitment to only funding \$500 million of regional infrastructure from this, Parramatta Light Rail contribution is \$1.2 billion (for the entire GPOP area, not just stage 1).
- *6360 BUILDING SAFETY IN CHILDCARE FACILITY CONSTRUCTION—Ms Jenny Leong asked the Minister for Education representing the Minister for Early Childhood Education, Minister for Aboriginal Affairs, Assistant Minister for Education—
 - (1) Who is responsible for ensuring that all health and safety building requirements are satisfactorily completed in the construction of private child care facilities?
 - (2) Who is responsible for the safety of children in private child care facilities in relation to fire hazard and safe haven requirements?
 - (a) How is compliance to safe haven requirements ensured?
 - (b) What mechanisms are in place to evaluate and monitor fire hazard and safety procedures in private childcare facilities?
 - (3) Has consideration been given to the fact that the Building Code of Australia should require sprinklers in multilevel childcare facilities?

Answer-

- (1) The Minister for Planning.
- (2) Under the Education and Care Services National Law, the approved provider of an education and care service is responsible for the safety of children in their service in the event of a fire, and must have policies and procedures for emergencies and evacuations in place.
- (a) There is currently no requirement for the provision of safe havens in child care facilities.
- (b) The Department of Education regulates childcare services under the Education and Care Services National Law. The department requires every early education and care service to anticipate emergencies through a risk assessment and to have plans in place to effectively manage incidents.

If a fire safety or child protection issue is identified by a visiting departmental authorised officer, and there is a significant risk to children, the service is placed on a high level monitoring and compliance plan to ensure the safety of children and compliance with the law.

- (3) The Department of Planning and Environment is responsible for administering the Building Code of Australia in New South Wales. This question should be properly directed to the NSW Minister for Planning.
- *6362 NORTHCONNEX TOLL—Ms Liesl Tesch asked the Minister for Transport and Infrastructure—
 - (1) How will the NorthConnex toll be designed?
 - (2) How much will the NorthConnex toll be from the M1 to the Gore Hill Expressway?

Staffing levels will be in line with activity requirements and models of care.

 - (1) Considering the response to LA Q5875, has the Government invested any of the electricity lease proceeds in the Wollongong Local Government Area?
 - (a) If so:
 - (i) What projects has the Government invested in;
 - (ii) What is the total investment for each project?

Answer—

I refer you to my previous answers on this topic. Our \$20 billion Rebuilding NSW program will invest in world-class infrastructure across New South Wales, including Wollongong.

None of this could have occurred under a Labor government.

- *6366 HEALTH IMPACTS OF WESTCONNEX WORKS AT FORMER ALEXANDRIA LANDFILL SITE—Ms Jenny Leong asked the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—
 - (1) Is there available information to demonstrate that local residents have not been subjected to known carcinogens such as benzene as a result of WestConnex excavations on the former Alexandria Landfill site?
 - (2) Is there available information to demonstrate that standard practices for safe landfill operations have been undertaken including:
 - (a) Covering exposed and disturbed areas daily with high-density polyethylene (HDPE) material;
 - (b) Transporting the leachate which can't be quickly treated onsite to off-site leachate treatment facilities?

Answer-

I am advised:

Environmental issues are managed in accordance with Planning Approval Conditions and Construction Environmental Management Plans.

The priorities of the service delivery models for the provision of bereavement services vary in each Local Health District.

*6368 DEFINITION OF THE WOLLONGONG LOCAL GOVERNMENT AREA AS METROPOLITAN—Mr Paul Scully asked the Premier—

- (1) Has the Government received representations from Illawarra stakeholders in relation to the definition of the Wollongong local government area as metropolitan?
 - (a) If so, which stakeholders have made representations to the Government?
- (2) Why is Wollongong local government area defined as metropolitan?
- (3) Is the Government considering changes to the current definition of Wollongong local government area, including that it is regional capital?
 - (a) If not, why not?

Answer-

- (1) to (3) There is no standard methodology for defining a Local Government Area (LGA) as metropolitan or regional. Agencies can consider different factors when classifying LGAs depending on the policy objectives of a program and the needs of the New South Wales community as a whole.
- *6369 UPGRADE OF THE UNANDERRA STATION CONCEPT DESIGN WORK—Mr Paul Scully asked the Minister for Transport and Infrastructure—
 - (1) Considering the response to LA Q5460, will the Minister publicly release the concept design work for the upgrade of the Unanderra Station, which was completed in July 2011?
 - (a) If not, why not?

Answer-

You recently put in a GIPA application requesting this information.

The concept design work reflects investigations completed in 2011 and may not reflect current or future requirements.

 - (1) Is the Sydney Light Rail on time and on budget?
 - (2) Is the Sydney Light Rail tracking 'green' on time status?

 - (b) McFarlane Street, Cessnock;
 - (c) Vincent Street, Cessnock;
 - (d) Greta Street, Kearsley;
 - (e) Mitchell Avenue, Kurri Kurri;
 - (f) Mcleod Road, Loxford;
 - (g) Neath Road, Neath?
 - (2) What types of maintenance works are undertaken at these rail level crossings to ensure network safety?

These rail level crossings are privately owned and operated. Under the Rail Safety National Law, Rail Infrastructure Managers like the owners of these crossings, are responsible for the roads intersecting with the rail line and the ongoing maintenance of the crossings. The National Rail Safety Regulator has responsibility for compliance and enforcement of the National Law.

- *6376 OFFICE OF STATE REVENUE AND STATE DEBT RECOVERY OFFICES—Mr Clayton Barr asked the Minister for Finance, Services and Property—
 - (1) How many Office of State Revenue and State Debt Recovery offices existed on 31 July 2017?

- (2) Parramatta (2), Maitland (2), Lithgow, Gosford, Newcastle and Wollongong.
- (3) The Administrative Order was approved on 28 June 2017.
- (4) Revenue NSW is responsible for two main functions of collecting tax and administering fines. These functions were split between the Office of State Revenue for taxes and State Debt Recovery for fines. Having a dual brand creates confusion for customers and a siloed approach to working for our staff.

Combining under a single name emphasises our role and services as the Government's revenue management agency so it is clearer to our customers what we are doing and why. This makes us more accountable to the public and provides better customer service.

- (5) A range of stakeholders were consulted in relation to improving customer experience within the Office of State Revenue and making our customer interactions clear, simple and effective, which resulted in the rebranding and the development of a Customer Charter. We drew upon these learnings and feedback from agencies including the Customer Service Commissioner, Service NSW, the NSW Business Chamber, NSW Law Society, NSW Australian Institute of Conveyancers, NSW Ombudsman, Roads and Maritime Services and local councils.
- (6) and (7) All costs associated with the rebranding will be met within Revenue NSW's existing internal budget.

The review of current housing policies will help the Government to ensure that its planning policies continue to encourage the development of a range of different types of affordable housing in different places to help respond to local needs. The Greater Sydney Commissions Draft District Plans nominate a 5% to 10% affordable rental housing target, subject to viability, in urban renewal and land release areas.

The Affordable Rental Housing State Environmental Planning Policy has helped facilitate the delivery of a wide variety of affordable housing across New South Wales.

- *6394 UNSAFE APARTMENT BUILDING CLADDING—Mr Alex Greenwich asked the Minister for Innovation and Better Regulation—
 - (1) What assessment has the Government made about responsibility for cladding that does not meet fire/building regulations that has been installed on apartment buildings?

- (1) Responsibility for remediating non-compliant cladding and any action available will be dependent upon the circumstances of each individual building, and depending on the circumstances responsibility could be enforced through statutory warranties determined in the Home Building Act as well as elements of the Australian Consumer Law.
- (2) Generally, building owners, through the owners' corporation, are responsible for the repair and maintenance of common property. However, they may have rights against builders and developers.
- (3) Individual strata owners or Owners' Corporations can take action to seek remedy for defective building work, such as unsafe cladding, by enforcing statutory warranties or pursuing breaches of Australian Consumer Law. Owners in multi-unit developments of three storeys or less may lodge an insurance claim under the Home Building Compensation Fund for failing to fix defective work.
- (4) As part of the whole of government ten point plan for improving building safety, the Government is introducing new legislation to prevent people throughout the building supply chain from importing, supplying, selling or using building products that are unsafe.

Further improvements are planned to make the website easier to follow for the community and businesses.
- (2) Since the website was launched in February 2016, there have been 6 direct submissions of feedback about the website and all of these have been addressed.
- (3) Plain language is used. There are accessible PDF, online forms and fact sheets. It complies with the Government WCAG2.0 AA access standards.
- (4) The "Community Involvement" section of the website outlines how the community can have their say in the liquor and gaming licensing process and policy reviews. The online Liquor and Gaming Application Noticeboard provides liquor licence application information and the opportunity for the community to submit feedback. It also provides contacts for the Community Access team who provide education to communities on how they can get involved.
- (5) L&GNSW consultation materials use plain English to communicate the purpose, process and closing dates of public consultations, including useful questions to guide discussion, and contact details for more information. Feedback can be submitted in writing and by email, through the L&GNSW website, by online survey, and through the Government's Have Your Say website.
- (6) L&GNSW is currently evaluating the CIS process, including ways in which the community can be better encouraged and supported to comment on proposed liquor licences. An extensive public consultation has been undertaken to inform the evaluation. The feedback provided through the consultation process will inform future enhancements.
- (7) L&GNSW is continually looking at ways to better encourage and support community comment on liquor licence impacts, as demonstrated in the initiatives referred to above.
