- 9263 CURBING HOUSING COSTS—Ms Sonia Hornery to ask the Minister for Planning, Minister for Housing, and Special Minister for State—
- \*9264 LAKE MACQUARIE TRANSPORT INTERCHANGE—Ms Sonia Hornery asked the Minister for Transport and Infrastructure—

Considering the Government's own projections for population increase in the western suburbs of Newcastle, can the Minister provide information on the status of the Lake Macquarie Transport Interchange at Glendale?

Answer-

I am advised:

Transport for NSW, in consultation with Roads and Maritime Services, Department of Planning and Environment and Lake Macquarie City Council, is finalising the Strategic Business Case for the Lake Macquarie Transport Interchange.

- \*9266 FUNDING AND ASSISTANCE FOR SMALL BUSINESS AFFECTED BY DROUGHT—Mr Philip Donato asked the Deputy Premier, Minister for Regional New South Wales, Minister for Skills, and Minister for Small Business—
  - (1) What is the Government doing to assist small businesses across rural and regional New South Wales during this drought?
  - (2) What funding is available to small businesses across rural and regional New South Wales to remain operational and retain staff during this drought?

Answer-

(1) Small businesses, including farm businesses, are able to access practical support through the Business Connect program, including advice on business planning and managing cash flow. A Business Connect resilience roadshow is under way including events in Cobar, Tibooburra and White Cliffs, in partnership with the Department of Primary Industries, RUOK and the Royal Flying Doctors. The Business Bus has been mobilised to provide information and advice to impacted communities.

In addition the Office of the NSW Small Business Commissioner (OSBC) is engaged with assisting small businesses in rural and regional areas through advocating on behalf of small business for support like payroll tax relief, and deferral of business activity statement (BAS) payments via the Australian Tax Office. OSBC mediation and dispute resolution services are also readily available to any business in need of assistance.

- (2) The Government has committed more than \$1 billion to a drought relief package. Information about funding for farm businesses is available at www.droughthub.nsw.gov.au.
- \*9267 WESTMEAD PRECINCT PLAN—Ms Julia Finn asked the Minister for Planning, Minister for Housing, and Special Minister for State—
  - (1) What is the estimated timeline for development of the draft Westmead Precinct Plan?
  - (2) How many new homes will be accommodated in the:
    - (a) Westmead North sub-precinct;
    - (b) Westmead South sub-precinct?
  - (3) When will the final Westmead Precinct Plan be exhibited?
  - (4) When will a recommendation be made to the Minister for the finalisation of the Westmead Precinct Plan?
  - (5) When will a rezoning determination on the Westmead Precinct be made by the Minister?

Answer-

I am advised that:

- (1) and (3) The Westmead precinct will involve two planning process. Exhibition of draft plans is anticipated for 2019, although only Westmead South is likely to involve a rezoning \.
- (2) As planning is in the early stages, the number of new homes that may be accommodated is not yet determined in either sub-precinct.
- (4) and (5) The Department will make a recommendation for the finalisation of the Westmead South

Precinct Plan after public submission have been considered and any further technical work is undertaken.

- \*9268 M1 PRINCES HIGHWAY MOUNT OUSLEY INTERCHANGE—Mr Ryan Park asked the Minister for Roads, Maritime and Freight—
  - (1) When will the detailed design for the M1 Princes Highway Mount Ousley Interchange be completed?
  - (2) What are the funds allocated in the 2018-19 budget specifically for?
  - (3) How much will the project cost to get to shovel ready?
  - (4) What financial year will the project be ready for construction?

Answer-

## I am advised:

A business case is currently being prepared. Timing and construction of the interchange upgrade will be subject to the business case. The funds allocated in the 2018-19 budget are for completion of the concept design and geotechnical investigations. Information about the Mount Ousley interchange is available on the Roads and Maritime Services website.

- \*9269 REMOTE AREA FIREFIGHTERS IN THE NATIONAL PARKS AND WILDLIFE SERVICES—Mr Ryan Park asked the Minister for the Environment, Minister for Local Government, and Minister for Heritage—
  - (1) How many Remote Area Firefighters does the NSW National Parks and Wildlife Services currently have on permanent staff?
  - (2) How many Remote Area Firefighters did the NSW National Parks and Wildlife Service have on permanent staff in each year from 2012 to 2017?
  - (3) How many Remote Area Firefighters have left the employment of the National Parks and Wildlife Service since January 2017:
    - (a) Through redundancy;
    - (b) By any other means?
  - (4) What plans are in place to replace the Remote Area Firefighters that have left the National Parks and Wildlife Service in preparation for the 2018-19 bush fire season?
  - (5) Have all fire trails in the Illawarra Escarpment State Conservation Area been sufficiently cleared and made accessible, in preparation for the 2018-19 bush fire season?

# I am advised:

- (1) to (4) On average, each year since 2012 the National Parks and Wildlife Service (NPWS) has employed approximately 550 staff accredited as remote area firefighters. This number varies slightly according to the annual completion or expiration of accreditation. Approximately 130 new staff are being recruited by NPWS, and additional courses will be rolled out to train new staff as firefighters.
- (5) NPWS is completing its annual inspection and maintenance program. Fire trails are expected to be sufficiently cleared and made accessible by the end of October 2018.
- \*9270 REVIEW OF THE 3:24 PM SOUTH COAST TRAIN SERVICE—Mr Ryan Park asked the Minister for Transport and Infrastructure—
  - (1) Considering that the 3:24 pm South Coast train service departing Central station has only 4 carriages, has the Minister requested the Transport planning unit or timetabling department review the 3:24 pm service?
    - (a) If so, what date was this review requested?
    - (b) If not, why not?
  - (2) Will the Minister commit to the provision of extra carriages on the 3:24 pm South Coast Line service?
    - (a) If yes, when will this happen?
    - (b) If not, why not?

# I am advised:

As the Member is aware, following feedback from the community, a broad review of rail services and fleet availability across the network and the advocacy of Gareth Ward MP, Parliamentary Secretary for the Illawarra and South Coast, on 27 September 2018 the Government announced more capacity on the South Coast Line.

From January 2019, the 3.24pm and 3.54pm Central to South Coast Line services will operate as eight-car Oscar trains. This means that all services departing Sydney for the South Coast in the evening peak will be eight cars, rather than the current four car configuration on certain services. These changes are an important part of Stage 1 of the Government's \$1.5 billion More Trains, More Services program. The program boosts network capability, provides better infrastructure and represents the single largest

  - (1) Considering that per-and polyfluoroalkyl substances (PFAS) were detected in Botany Bay as part of the Government's PFAS investigation program, what is the Government doing to manage the risks to the local community and environment?
  - (2) Has the Environmental Protection Agency also tested other sites along the Cooks River for PFAS contamination?
    - (a) If so, what were the results?

The Government has issued precautionary dietary advice to help regular consumers of fish caught in Botany Bay minimise their exposure to per-and polyfluoroalkyl substances (PFAS). Further information on the PFAS investigation program, including testing site locations is available at www.epa.nsw.gov.au.

- \*9273 PRE-SCHOOLS AND EARLY CHILDHOOD LEARNING CENTRES—Ms Jo Haylen asked the Minister for Education—
  - (1) How many public schools in New South Wales are co-located with pre-schools or early childhood learning centres?
    - (a) Of these schools, how many are at 80 per cent or above enrolment capacity?

Answer-

The Department of Education allows the use of school facilities for children's services, including early childhood education care and out of school hours care, where it does not interfere with the provision of learning programs for students.

There are currently 203 public schools in New South Wales co-located with pre-schools or early childhood learning centres.

Will consideration be given to providing equitable protection for injured police officers by delivering the same level of income protection provided to police officers aged 59 and under, to those police officers aged 60 and over?

\*9277 FUNDING FOR MAIN WESTERN RAIL LINE FEASIBILITY STUDY—Mr Philip Donato asked the Deputy Premier, Minister for Regional New South Wales, Minister for Skills, and Minister for Small Business—

Considering your announcement of funding for the feasibility study of a Canberra-Eden train line, will consideration now be given to the funding of a feasibility study for upgrades to the main western rail line to allow fast travel of the XPT replacement fleet of an average of 100 kilometres per hour between Lithgow and Orange, which would potentially reduce Orange to Sydney travel from 4.6 hours to a 3.7 hour journey?

  - (2) How many new officers have been allocated to the Newcastle local area command since March 2011 (as at 19 September 2018)?
  - (3) How many new officers have been allocated to the Lake Macquarie local area command since March 2011 (as at 19 September 2018)?

Information on the number of probationary constables that have attested from the Police Academy, as well as the location at which they will commence service, is made publicly available by the NSW Police Force at the time of each Attestation.

- \*9280 POLICE OFFICERS PER CAPITA—Ms Sonia Hornery asked the Minister for Police, and Minister for Emergency Services—
  - (1) How many police officers per capita are stationed in local area commands located in the:
    - (a) Sydney metropolitan area;
    - (b) Newcastle local area command;
    - (c) Lake Macquarie local area command?

Answer—

I am advised:

Allocation of police resources is determined by the Commissioner of Police, based on operational need. Police Area Commands and Police Districts aim to ensure that there are an adequate number of police officers on duty to meet demand.

- 9282 CURBING ELECTRICITY PRICES—Ms Sonia Hornery to ask the Minister for Planning, Minister for Housing, and Special Minister for State representing the Minister for Resources, Minister for Energy and Utilities, Minister for Arts, Vice-President of the Executive Council—
- \*9284 MAULES CREEK GROUNDWATER SOURCE—Mr Alex Greenwich asked the Minister for Planning, Minister for Housing, and Special Minister for State—
  - (1) How much water does the Department of Planning estimate that the Maules Creek Mine has extracted from the Maules Creek Groundwater Source so far this year (as at 15 August 2018)?
  - (2) What connectivity exists between the porous rock and the Upper Namoi Zone 11- Maules Creek Groundwater alluvial aquifer?
    - (a) What is the source of this information?
  - (3) Will the Department of Planning investigate whether the Maules Creek coal mine is complying with its approval condition to ensure water use is sustainable and equitable in light of the decline in the Maules Creek Groundwater aquifer and current and forecast drought conditions?

- (1) Maules Creek Coal (MCC) estimates groundwater seepage into the mine from January to June 2018 was between 10 and 18 megalitres a month. Further information about groundwater extraction at the Maules Creek Coal Mine is in the company's Annual Review available at http://www.whitehavencoal.com.au/sustainability/environmental-management/maules-creek-mine/).
- (2) This is a matter for the Hon Niall Blair MLC, as Minister for Primary Industries and Minister for Regional Water.
- (3) Water take at the mine is regulated under the Water Management Act 2000 (the Act 2000) and associated Water Sharing Plans which set out the rules for the sustainable management of water resources in NSW. The project approval requires MCC to obtain relevant licences for its water take under the Act 2000, ensure that it has sufficient water for all stages of the project, and/or adjust the scale of mining operations to match its available water supply. The Department of Planning and Environment has no evidence to suggest the mine is not complying with these conditions.
- \*9285 8:02 AM TRAIN FROM INGELBURN—Mr Anoulack Chanthivong asked the Minister for Transport and Infrastructure—
  - (1) Was the T8 train from Ingleburn railway station at 8.02 am on 21 August 2018 cancelled?
    - (a) If so, why?

This information is publicly available. As the Member is aware, a new timetable was introduced on 26 November 2017 as part of Stage 1 of the NSW Government's \$1.5 billion More Trains, More Services program. The new timetable delivers up to 1,500 new train services across the network. These extra services are needed to address significant patronage growth on public transport and particularly on the Sydney Trains network. Since its introduction, the timetable has operated successfully, with services being delivered close to or above the 92 per cent reliability target. It is disappointing that NSW Labor has committed to cancelling a significant number of vital train services if it is elected in March 2019.

- \*9286 PARKING FINES AT EDMONDSON PARK STATION—Mr Anoulack Chanthivong asked the Minister for Transport and Infrastructure—
  - (1) Is Sydney Trains issuing parking fines at Edmondson Park Station?
    - (a) If so:
      - (i) When did Sydney Trains start issuing fines at Edmondson Park Station;
      - (ii) How many have been issued at Edmondson Park Station?

Sydney Trains Transport Officers conduct parking enforcement activities at various Sydney Trains Car parks, including Edmondson Park, to make our car parks safer for users and to ensure compliance with relevant legislation and regulation.

Issuing parking fines at our station car parks provides a deterrent to stop illegal parking which can often create safety issues. It is not uncommon for customers to double park, block exits, park in a disabled car spot, motorcycle parking bay or in no parking area.

\*9287 RECORDING OF HOMICIDES IN NEW SOUTH WALES—Mr Paul Lynch asked the Minister for Police, and Minister for Emergency Services—

What steps will be taken to prevent the failure of NSW Police to properly record homicides in New South Wales?

The NSW Police Force continually reviews its processes to improve the recording of incidents in COPS.

- \*9289 KORNS CROSSING BRIDGE—Ms Jodi McKay asked the Minister for Roads, Maritime and Freight—
  - (1) When will construction commence on a new bridge over Rous River at Crystal Creek to replace the existing Korns Crossing Bridge?
  - (2) When will construction be completed?
  - (3) What is the total cost of the project?
  - (4) How much of the \$3 million allocated in the 2017-18 Budget has been spent to date (as at 19

September 2018)?

Answer-

Work started in 2017 to develop a number of options to construct a new bridge over Crystal Creek. Approximately \$610,000 has been spent to date on development work, including site investigations, assessments and design. The investigations identified upstream flooding issues resulting in changes to the scope and design of the bridge. Roads and Maritime is currently considering options.

\*9290 METRO RAIL FARES—Ms Jodi McKay asked the Minister for Transport and Infrastructure—

Will fares on the new metro be set at or below existing train fares?

  - (3) What is the type of maintenance performed on the individual carriages to repair them?

  - (1) How many maintenance requests are currently outstanding for social housing properties within in the Keira electorate?
  - (2) How long on average does it take for the maintenance issue to be fixed, once a social housing tenant reports a maintenance issue to Housing New South Wales?
  - (3) What percentage of tenants in the Keira electorate have spent their own money on property maintenance over the last five years?

    - (a) If so, how is Transport NSW or Sydney Trains assisting the Inner West Environment Group to progress their proposal?

Transport for NSW supports the memorial in principle. Transport for NSW will give further consideration to the proposal once the Inner West Environment Group submits a detailed project plan, scope of works and funding arrangements.

- \*9296 MANAGEMENT OF ILLICIT DRUGS IN NEW SOUTH WALES—Ms Jo Haylen asked the Minister for Police, and Minister for Emergency Services—

Considering revelations that drug enforcement data has been erroneously double-counted by the NSW Bureau of Crime Statistics and Research, how can the community have confidence in the Government's approach to managing illicit drugs?

Answer-

I am advised:

The Government remains committed to combating illicit drugs through a multi-pronged approach, including both law enforcement and harm-reduction initiatives.

- \*9298 PRODUCTS OF WESTCONNEX SUPPLIER—Ms Jo Haylen asked the Minister for Western Sydney, Minister for WestConnex, and Minister for Sport—
  - (1) Is the Government aware that products at MOITS a major supplier for road base for the WestConnex project has again been identified by the Environmental Protection Agency as containing asbestos?
    - (a) If so, can the Government guarantee that communities along the WestConnex route have not been exposed to asbestos from products supplied by MOITS?
  - (2) What efforts have been undertaken to protect residents?

Answer—

I am advised that WestConnex contractors have strict protocols in place with their suppliers to ensure the quality of materials used meets Environment Protection Authority standards.

\*9299 FEE FOR BEE HIVE REGISTRATIONS—Ms Jo Haylen asked the Minister for Lands and Forestry, and Minister for Racing representing the Minister for Primary Industries, Minister for Regional Water, Minister for Trade and Industry—

Does the Government still plan to introduce a flat fee for bee hive registrations and eliminate seniors discounts at the end of the current freeze period, even though this will likely deter amateur beekeepers from registering their hives and further put biosecurity at risk?

Answer-

Due to the current drought conditions, the Government has waived fees for commercial grower access to public land. There are no plans to introduce a flat fee for bee hive registration and eliminate senior discounts.

The Department of Primary Industries (DPI) works in close partnership with the honey bee industry through the NSW Bee Industry Biosecurity Consultative Committee. The committee and DPI do not support introduction of a flat fee or the removal of concessions within the beekeeper licencing scheme.

DPI encourages all beekeepers to be registered for the good of the industry. All of the fees raised through beekeeper registration are spent directly on industry biosecurity to support:

- an expanded surveillance program for exotic pests and diseases
- employment of a second bee biosecurity officer to work closely with recreational beekeepers across the state
- important initiatives like the American Foulbrood Minimisation Strategy 2018-2023 which aims to

tackle one of the most serious biosecurity issues for honey bees in Australia.

- \*9300 VERIFICATION OF PAYMENT FOR TRANSIT—Ms Jo Haylen asked the Minister for Transport and Infrastructure—

Transport Officers, Authorised Officers and Police are deployed across the network to deter fare evasion and ensure fare compliance. These authorised officers will be ensuring customers tap on and off with an Opal Card, Opal Single Trip Ticket, or Contactless Payment Card before boarding ferry or light rail services during the trial.

Opal cards and single trip tickets are not always available at wharves or light rail stops and the expansion of the contactless trial means there are now no excuses for adult customers caught travelling on ferry or light rail services without having tapped on.

# Answer—

- (5) During the millennium drought, irrigation bores were restricted; currently these bores are not active and are therefore not having an impact on the groundwater source so there is no need for restrictions to be in place.
- () At this time there is no demonstrated need for a temporary water restriction on the taking of water from Maules Creek.
