#### **BUSINESS**

#### 6.1 Motions Accorded Priority – Both Notices Considered

Standing orders were suspended to permit consideration of both notices for motions to be accorded priority.

# 6.2 Provision for a 'Take Note' Debate on the Budget Estimates and related papers

Standing orders were suspended to provide for a 'Take Note' debate on the Budget Estimates and related papers for 2011-2012 after the Appropriation and cognate bill had been passed by the House

Discussion proceeded on the subject matter of the petition signed by 10,000 or more persons that had been received by the House from certain citizens "requesting 24-hour road and helicopter retrieval services for the Central West region." In accordance with the sessional order, no question was put at the conclusion of the discussion.

The Address in Reply to the Governor's opening speech was adopted by the House. The House proceeded to Government House at the time communicated to the Speaker by the Governor. After the Address in Reply had been received by the Governor, the Speaker reported to the House the Governor's answer:

"It gives me much pleasure to receive your Address and to thank you for your expression of loyalty to Australia and the people of New South Wales.

I am also glad to have your assurance that earnest consideration will be given to the measures to be submitted to you and the necessary provision for the Public Services made in due course.

I have every confidence that your labours will advance the general welfare and happiness of the people of this State."

Standing Order 226 Standing Orders 341-350

(NB: The Standing Orders provide for a free conference to be convened when there is disagreement between the two Houses on a bill. However, Standing Order 226 provides that if the Assembly disagrees to amendments made by the Council, the Council may return the bill with a message insisting on the amendments to which the Assembly has disagreed. The Standing Order then provides that the Assembly may agree to the amendments to which it had previously disagreed; insist on its disagreement to such amendments and lay the bill aside; or request a conference. The Legislative Assembly is currently considering its options. It should be noted that a free conference has not been held by both Houses since January 1978).
