This document provides a summary of significant procedures and precedents in the Legislative Assembly. It is produced at the end of each sitting period. Where applicable the relevant standing orders are noted.

BUSINESS

7.1 Discussion of petition signed by 10,000 or more persons

Discussion proceeded on the subject matter of the petition signed by 10,000 or more persons that had been received by the House from certain citizens "requesting that 'Confucius Classrooms' be removed from schools and be replaced by an Australian-run organisation." In accordance with the sessional order, no question was put at the conclusion of the discussion.

A number of general business notices of motions (general notices) were postponed outside the order of precedence by: (1) the member in charge of the business; (2) the Opposition Whip on behalf of a member of the Opposition; and (3) the Government Whip of behalf of a member of the Government.

7.3 Discussion of petition signed by 10,000 or more persons

7.4 Retirement of the Clerk of the Legislative Assembly

The Speaker informed the House that she had received a letter from Mr Russell David Grove, Clerk of the Legislative Assembly, advising of his retirement from 4 November 2011. The Speaker made a number of remarks from the Chair following which the Premier moved the following motion: "That:

- (1) The Speaker's remarks with reference to Mr Russell David Grove, on his retirement from the position of Clerk of the Legislative Assembly, be entered in the *Votes and Proceedings*.
- (2) Mr Grove's 40 years distinguished service to the Legislative Assembly, including a record 21 years as Clerk of the House, be noted.
- (3) In recognition of his meritorious service and on the occasion of the retirement of Mr Russell David Grove, this House extends him the honorary title Clerk Emeritus."

A number of members spoke to the motion which was passed unanimously.

7.5 Bill considered in detail without amendments proposed

Following the Premier's reply to the agreement in principle debate on the Election Funding, Expenditure and Disclosures Amendment Bill, the Opposition Whip, requested the bill be considered in detail to enable further discussion on the bill even though no amendments to the bill were proposed. The Leader of the House subsequently moved the closure motion "That the question be now put" and the bill was passed by the House following a number of divisions

JOINT SITTING

At the time for the Joint Sitting the House proceeded to the Legislative Council Chamber and upon return the Speaker reported that Arthur Sinodinos had been elected to fill the vacancy and the Speaker tabled the minutes of the proceedings of the Joint Sitting.

MEMBERS

7.11 Vacant seat

The Speaker advised the House that on 16 September 2011 she received a letter from Stephen Rhett Cansdell resigning his seat as member for the electoral district of Clarence. A motion, moved by the Leader of the House declaring the seat vacant was passed by the House.

The Speaker subsequently advised the House that it was her intention to issue a writ for the byelection to fill the vacant seat with the following particulars:

Issue of the writ, Friday 28 October 2011 Close of nominations, Thursday 3 November 2011 Polling day, Saturday 19 November 2011

Return of the writ, on or before Friday 2 December 2011

(NB: In accordance with section 70 of the *Parliamentary Electorates and Elections Act 1912* the House is required to pass a resolution declaring the seat vacant prior to the Speaker issuing a writ to fill the vacancy. If the House is not in session, or if the vacancy occurs during any adjournment for longer than seven days, the Speaker may issue the writ to fill the vacancy without a resolution of the House declaring the seat vacant.)

7.12 Register of disclosures

The Speaker, in accordance with section 21 of the Constitution (Disclosures by Members) Regulation 1983, tabled the Register of Disclosures by Members of the Legislative Assembly as at 30 June 2011.

(NB: Members are required under the regulation: (a) in the case of a newly elected member to lodge a primary return within 3 months after taking the Pledge of Loyalty; (b) in the case of other members, an ordinary return by 1 October each year; (c) in the case of all members, a supplementary return for the period 1 July to 31 December each year; and (d) in the case of all members discretionary returns. The Clerk is required to furnish to the Speaker a copy of the Register of Disclosures for tabling in the House as a Parliamentary paper within 21 sitting days after the lodgement of ordinary returns. Each Register will include all returns received during the previous 12 month period to 30 June.)

7.13 Paper laid on the table for the information of members

During private members' statements, a member laid a document on the table for the information on members which provided a brief overview of the Historical Aircraft Restoration Society, which was the subject of her statement.
