## 13.1 Constitution Amendment (Restoration of Oaths of Allegiance) Bill

The House passed the Constitution Amendment (Restoration of Oaths of Allegiance) Bill. The Bill was a private member's bill received from the Legislative Council and taken up by the Government in the Legislative Assembly. The bill amends the Constitution Act 1902 to give members of the Legislative Council, the Legislative Assembly or the Executive Council the option of taking or making an oath or affirmation of allegiance to Her Majesty Queen Elizabeth II, Her heirs and successors as an alternative to the pledge of loyalty to Australia and the people of New South Wales.

- (1) That, according to section 95 of the Police Integrity Commission Act 1996 (the Act), the Committee on the Office of the Ombudsman and Police Integrity Commission inquire into and report on the following:
  - (a) Whether the inspector of the Police Integrity Commission (PIC) has appropriate resources to carry out the functions of the Inspector under the Act;
  - (b) Whether the provisions of the Act relating to PIC investigators are sufficient to allow the employment of appropriate and a sufficient number of investigators; and
  - (c) Whether the Act should require the PIC to establish a Code of Conduct for its employees.
- (2) That this House requests that the Legislative Assembly pass a similar resolution.
