This document provides a summary of significant procedural events and precedents in the Legislative Assembly. It is produced at the end of each sitting period. Where applicable the relevant standing orders are noted.

#### **BILLS**

## Expedited passage of the Election Funding, Expenditure and Disclosures Amendment Bill

On 14 October 2014, the Premier introduced legislation intended to provide further integrity to the electoral process (for further details of the bill see: Legislation Review Committee Digest No.14 <a href="http://bulletin/Prod/parlment/committee.nsf/0/1A3CFC8F7B10725ECA257D78000ED114">http://bulletin/Prod/parlment/committee.nsf/0/1A3CFC8F7B10725ECA257D78000ED114</a>)

The following day, the House agreed to a motion of the Leader of the House to suspend Standing and Sessional Orders to enable the bill to pass through all stages that day, or at a subsequent sitting. The suspension motion also put limits on the number of members and their speaking times during the Second Reading Debate, where the bill's general principles are considered.

Following the Second Reading Debate, the bill proceeded to Consideration in Detail. This is an optional stage which provides Members with an opportunity to debate and vote on whether a clause or schedule should be agreed to.

During Consideration in Detail, a number of opposition amendments were proposed and debate ensued before the Government Whip moved a motion "That the question be now put".

This motion, which is put and resolved without amendment or debate, is commonly known as the "closure" or "gag" because if it is agreed to there is no further debate on that particular question.

**Standing Order 365** 

(Procedural Note: Suspending Standing Orders in this way removes certain procedural requirements in order to facilitate the passage of the legislation that day. For instance, debate does not then need to be adjourned for five clear days after the mover's has given their second reading speech, which would otherwise be the case; and speakers and speaking times on the various stages of the bill are subject to specific limits.

Another means of expediting the bill's passage would be to declare it urgent, pursuant to SO 189, which again allows the second reading debate and all subsequent stages to take place immediately following the mover's second reading speech).

## Member not permitted to conclude his speech by moving the closure

During the Consideration in Detail stage for the *Election Funding, Expenditure and Disclosures*Amendment Bill, the Leader of the House moved that "the question be now put". The ActingSpeaker, Mr Evans, reminded the Leader of the House that he could not conclude his contribution to the debate with the statement "That the question be now put" - ruling that debate would continue.

(Procedural Note: Standing Order 86 provides for any member to move a motion "That the question be now put". This "closure" or "gag" motion is then put immediately and is decided without debate or amendment.

If the motion is agreed to, then debate on whatever question was before the House ceases and that question is decided upon.

Whilst a member can move the motion, it is the practice of the House that they cannot conclude their speech by moving the closure. The rationale for this being that, if it is important to determine the question without further debate, then the member should not themselves contribute further to that debate before seeking to close it. Similarly, the motion can't be moved by a member who has already spoken to the question.

## Independent member moves to suspend Standing and Sessional Orders

Mr Alex Greenwich moved, by leave, on Thursday 16 October 2014, that standing and sessional orders be suspended to permit two members' bills to have precedence over all other general business that day.

The suspension motion was agreed to, meaning that consideration of the bills could continue beyond the usual cut off time (of no later than 11:30 am) provided for in the Routine of Business.

(Procedural Note: Though it is not uncommon for Standing and Sessional orders to be suspended to expedite the passage of a bill, this is usually done by a Minister in relation to a Government Bill.

While Ministers may, at any time, move a motion that Standing and Sessional orders to be suspended, other Members must firstly seek the leave of the House and leave cannot be granted if any one member objects. The Member then moves the suspension motion which may be debated and amended.)

#### Appointment of new Temporary Speaker

On 14 October 2014, the Speaker informed the House that she had nominated Mr Mark Coure as a Temporary Speaker, in place of Mr Garry Edwards.

(Procedural note: Standing Orders provide for the Speaker to nominate, at the beginning of each Parliament, a panel of up to five members as Temporary Speakers. These Temporary Speakers may exercise the powers and duties of the Speaker whenever the Speaker, Deputy Speaker or Assistant Speaker is absent.

The Speaker may, at any time, nominate another Member to take a Temporary Speaker's place.)

#### Tabling of the Register of Disclosures

The Speaker tabled the *Register of Disclosures by Members of the Legislative Assembly* on 14 October 2014.

It is a requirement that Members of the Legislative Assembly (and the Legislative Council) disclose pecuniary interests such as property, income, gifts and debts. Along with the Code of Conduct for Members, the Register is aimed at addressing any potential conflict of interest between a member's public and private interests.

Members make a primary return disclosing their interests at the beginning of their term in Parliament. Every 6 months after that, members must make either an ordinary or supplementary return disclosing ongoing interests. A member may also make a discretionary disclosure at any time.

Standing Orders 338-339

(Procedural Note: the Committee on Children and Young People and the Committee on the Independent Commission against Corruption are both Joint Parliamentary Committees established by statute. Those establishing acts expressly provide that a person is not eligible for appointment as a member of the committee if the person is a Minister of the Crown or a Parliamentary Secretary.

Accordingly, having become the Parliamentary Secretary for Police and Emergency Services on 17 October 2014, Mr Blair was replaced on those committees.
