That the report be approved, subject to paragraph 16 being altered to read:

'The Committee is conscious of balancing the issues of business impact, the need to reduce red tape, and to promote water recycling and the need to protect sensitive environmental areas and public health interests. Accordingly, the Committee has resolved to write to the Minister suggesting a regulation specifically dealing with sewer mining to encourage water recycling initiatives may be worthy of consideration as an alternative to this proposed regulation'.

- 10. The Committee discussed the wording to be used when a report declares an intention to write to the Minister. Decided to use 'The Committee has resolved to write...'.
- 11. The Committee discussed the usual procedure for reading the draft digest and when copies of bill reports are usually received.
- 12. Resolved, on the motion of Ms Parker, seconded by Ms McMahon:

That the Legislation Review Digest No 1 of 2007 be tabled in both Houses.

- 13. The Committee discussed the forthcoming Scrutiny of Legislation Conference to be hosted by the Parliament of New Zealand from 31 July to 2 August 2007.
- 14. The Committee noted that a Briefing Note on the purpose of the Committee would be useful.
- 15. The Committee discussed the next meeting time for the consideration of Bills Digests and regulations. A meeting is to be organised sometime before Parliament recommences in September 2007.
