Upon which, Mr Mehan moved, seconded by Ms Boyd, that the conclusion, on page 36 of the draft Legislation Review Digest, delete the following paragraph: "However, the RIS states that partitioning certain areas of the Domain will better preserve the wider greenspace and commercialising access to certain areas will fund maintenance costs. It is also likely that the public will still be able to access and enjoy most of the Trust lands if they are designated for activities such as cycling, and so movement may not be significantly more restricted than under the previous regulation. Having regard to these factors, the Committee makes no further comment."

And instead insert: "The Committee notes that the RIS states that partitioning certain areas of the Domain will better preserve the wider greenspace and commercialising access to certain areas will fund maintenance costs. Noting these factors, the Committee refers the regulation to Parliament, with particular regard to the potential to reduce public access and potential for commercialisation of the space."
