Question Taken on Notice # 1

The CHAIR: Going back to my previous question, how does your council work with neighbouring councils which participate in the road safety program?

Mr BOYLE: I do not have the full history of that, but that is probably something we could take on notice. What I can say is that we do have a close working relationship with the City of Newcastle at officer level. For example, I work closely with the transport strategist at that council and we are both refreshing our walking and cycling strategies at the moment and looking for synergies, and obviously road safety is one example of the topics that we look at.

Response

Staff from Lake Macquarie City Council do not liaise with other councils specifically about their respective road safety program(s). We do liaise with other councils and State Government agencies on a range of issues, aiming to share and learn better practices, processes and systems to provide a safer transport network in Lake Macquarie and the wider Central Coast and Hunter regions.

Question Taken on Notice # 2

The CHAIR: Do you have parts of Lake Macquarie where you have a shared or dedicated bicycle land or are they actually on the road?

Mr BOYLE: We have 183 kilometres of shared paths. We do also have on-road cycling facilities but for the most part, most of our roads do not meet requirements for the majority of cyclists.

The CHAIR: Did most of those accidents occur on those roads? If you need to you are welcome to take it on notice.

Mr BOYLE: I think we would need to take that on notice.

Response

Over 2014-2019, 64 crashes occurred involving 66 injuries to cyclists. Over half of those accidents occurred on regional and local roads (35 in total).

However, as a proportion of the road network, more crashes occurred on State roads (0.2 crashes p/km) vs local and regional roads (0.025 crasher p/km).

The number of crashes and casualties peaked in 2017 (16 crashes with 16 injuries). Since 2017 this number has dropped slightly.
