I was only in attendance for day one of this meeting. The presentation from A Gender Agenda was on day two. No papers or slides were circulated in relation to this agenda item.

The minutes indicate ANZCCG members present heard from a panel of four trans and non-binary young people engaged with A Gender Agenda. A Gender Agenda gave an introduction to the service which provides peer support, education and advocacy to support the intersex, trans and gender diverse community in the ACT. Panellists discussed their experiences and the importance of good support at home, school and with community organisations. Their parents also answered questions about their experiences and support needs.

6. **The Hon. GREG DONNELLY:** You said normally that the organisation Australian and New Zealand Children's Commissioners and Guardians [ANZCCG] gets together twice a year.

The ANZCCG last met in person, in Brisbane, on 11-12 November 2019.

The item on supporting LGBTIQ+ children and young people related to the inclusion of data about sexuality and gender by the Australian Bureau of Statistics in the 2021 Australian Census. No papers were circulated in relation to this agenda item.

The Advocate for Children and Young People raised the issue of gender dysphoria at the ANZCCG meeting on 18 August 2020. Members were provided with a copy of the correspondence the Honourable Greg Donnelly MLC sent the Advocate. Members were advised that the Advocate was providing Mr Donnelly with a response.

All meetings since November 2019 have been online and of a shorter nature. They have mainly focused on response to the impact of COVID-19 on children and young people. Gender dysphoria or gender fluidity have not been on the agenda since August 2020.

11. **The ACTING CHAIR:** Noting that the Children's Guardian has recently surveyed a broad range of organisations that are implementing the Child Safe Standards, can I ask if you could update the Committee on any issues that have been raised by stakeholders in the consultations or in your survey?
