Thank you for the opportunity to appear before the Legislative Assembly Committee on Law and Safety on 10 May 2021 for the inquiry on Physical health of police and emergency service workers.

Dr Boris Fedoric and I have reviewed the uncorrected transcript of our evidence and have made a correction on the transcript to a statement made by Dr Boris Fedoric. Please find correction on page 16, attached.
