1) How many phases are involved in the CrownTracker replacement project? Can you please provide a description of each phase of the CrownTracker system replacement project, in particular, what type of work involved in each phase of the project?

The Program has three releases which, will see all Crown Lands' business functionality migrated off the legacy platform, Crown Land Information Database (CLID) onto CrownTracker a contemporary, cloud based business management and geo-spatial system.

- 2) Can you provide a timeline for the entire CrownTracker replacement project (from start to its expected time to complete the project)?
  - Release 1 was implemented in April 2020.
  - Release 2 was due for completion end November 2021. COVID restrictions have impacted on the pace of testing and inhibited face to face group testing and training sessions.
  - Go live has always been subject to user acceptance testing. The testing that has been conducted in the last six weeks indicates that Release 2 needs further development and refinement before user acceptance testing and staff training can progress.
  - This work is underway and is scheduled to complete before the end of the year.
  - A new Go-Live date for Release 2 will be confirmed shortly but will be within the first half of 2022, noting the end of year shut down period.
  - Post the implementation of Release 2, a timeframe for Release 3 will be confirmed. This will include smaller releases of functionality prior to decommissioning CLID.
