Re: Potential inquiry into options to improve access to existing and alternate accommodation to address the social housing shortage

Dear Dora,

Please accept the following clarifications to my evidence provided to the above committee inquiry on 8 November 2021.

The figure cited in my evidence – that there are 70,000 homes vacant in Sydney due to speculation – was publicly reported as 68,000<sup>1</sup>. The number is based on the reported number of vacant homes on census night in 2016, paired with analysis of water usage from Prosper Australia. As this analysis is based upon water usage data and determines usage of less that 50 litres per day as vacant, this would exclude properties that are used as short-term rentals or holiday homes.

Speculative vacancy – where property is held vacant purely for speculative purposes – treats property merely as an investment opportunity, divorced of its social function. The issue of speculative vacancy is a growing concern, which has been criticized by the UN Special Rapporteur on housing.<sup>2</sup> This process affects both old and new properties and has become more a more acute problem due to improvements in cartographic and algorithmic processes for identifying investment opportunities and locations.<sup>3</sup> Speculative vacancy remains a particular concern as the housing system works its way through the pandemic and due attention should be paid to this issue throughout the inquiry.
