I refer to your email dated 9 April 2025 and the attached draft Transcript of Evidence – 2024 review of annual and other reports of oversighted agencies.

Clarification

I have read the draft transcript and would like to clarify my evidence set out on page 23. In my opening statement I stated:

Complaint handling process
