OUTSOURCING COMMUNITY SERVICE DELIVERY - PUBLIC HEARINGS

The Legislative Assembly Committee on Community Services is conducting three days of public hearings in connection with its Inquiry into outsourcing the delivery of housing, home care and disability services to the community sector.

The process of transferring the delivery of Government provided housing, home care and disability services to community based organisations has already commenced and is a trend which is continuing to evolve. The Committee's Inquiry provides the opportunity to examine how successful this process has been to date and to advise Government about the best way forward.

The Chair of the Community Services Committee, Mr Kevin Anderson MP, National Party Member for Tamworth, said: "This is a particularly timely and significant Inquiry which will assess the impact on clients and service providers of delivering services closer to the ground. The Committee has received 83 submissions dealing with a range of matters and concerns including ways to regulate and monitor service providers, improved quality assurance safeguards for clients, building capacity for smaller providers, incentives for private philanthropy and more effective use of technology".

"The hearings to be conducted allow further evidence to be taken from some of the individuals and organisations who have made submissions. Organisations appearing include NSW Government agencies, local government, service delivery organisations and advocacy groups. In addition, the Committee will speak to individuals who want to share their personal experiences of service providers and the system generally", Mr Anderson said.

The first day's hearings will commence at 9.30am on Monday, 3 September at Parliament House. This will be followed by subsequent all day hearings on 10 and 17 September 2012. A detailed program for the three days is attached.
