Annual report on General Meetings

The information in relation to my office's budget in the attached table is taken directly from the financial statements included in my office's annual reports. The tables with information about the office's staffing profile are taken from pages 28 and 31 of my office's annual report for 2011-2012.

As convenor of the Child Death Review Team (CDRT), my office provides support and assistance to the CDRT members in performing their functions. My office is provided with funding to perform this work, and this forms part of the office's total budget allocation.

The current members of the CDRT, with the exception of Ms Mitchell, are listed in the CDRT annual report for 2011. I have included a copy of the relevant page. The staff providing support to the CDRT work within the Systemic Reviews Unit of my office's Human Services Branch. In addition to supporting the CDRT, these staff also conduct reviews of children and people with disability living in care, as well as reviewing the deaths of children who die as a result of abuse or neglect or in suspicious circumstances, and children in care, as well as the deaths of people with disability living in care.
