Inquiry - Risk Management in the NSW Public Sector

I wish to provide a submission to the Committee on behalf of IAB Services (Internal Audit Bureau of New South Wales).

IAB Services is a NSW Government Trading Enterprise providing internal audit, risk management and other consultancy services exclusively to the NSW Public Sector. Accordingly, I would like to draw the Committee's attention to the work that we perform in the sector and to offer to provide further information and assistance to the Committee during the Inquiry should this prove helpful.

In facilitating an extensive range of risk assessments and related assignments with Government agencies, we have developed deep insights into the kinds of risks faced by public sector managers and the range of treatment options that are available. We also recognise the constraints within which public sector managers operate, including in the management of human resources, recurrent and capital funding flexibility, management of multiple stakeholders, external reporting and review requirements and the management of political relationships.

Our approach to facilitation of risk assessments and the development of risk management approaches is based on the Australian/New Zealand Standard AS/NZS 4360:2004. The Standard is highly regarded both in Australia and overseas and provides a robust, easily understood approach to the assessment of risks and the development of actions or strategies to address them. The approach in the Standard has been applied successfully in wide range of environments in the private and public sectors, and in a range of different risk contexts.

In addition to a strong methodology, however, a successful risk management approach requires a strong understanding of an organisation's environment to ensure that the right risks are identified and that realistic, achievable approaches are developed to manage them. As a specialist Public Sector consultancy organisation, the Internal Audit Bureau applies an empathetic approach in facilitating improved risk management in our Public Sector clients, based on our extensive experience in the sector.

While we assist agencies to assess and manage specific risks, we also provide advice on improvements to related management systems and processes, organisational culture and structure, and risk-focused internal audit activity. Our specialist risk services include organisation-wide risk management, information technology risk management, project risk management, probity, and investigations in sensitive risk areas like fraud and corruption and disciplinary matters. In addition we provide Internal Audit services to a large number of agencies.

In the light of our experience in the field that is the subject of the Committee's Inquiry, we would be pleased to provide assistance to the Committee in its deliberations, if required, including in the following areas:

• the benefits of robust risk management approaches in the Public Sector; and

• assistance in the analysis of information presented to the Committee during the Inquiry.

Additional material on the Internal Audit Bureau, our risk management and related services and the range of our NSW Public Sector clients is provided for the information of the Committee in the attachments to this submission.

Thank you for providing the opportunity to make this submission. I would be pleased to provide further information on any of the issues raised in this letter and to discuss the manner in which the Internal Audit Bureau might be able to assist the Committee in its Inquiry.

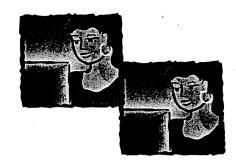

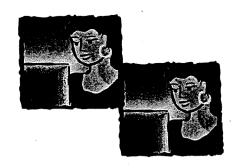

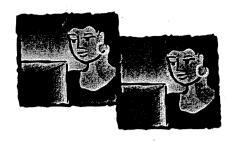

CORPORATE GOVERNANCE SERVICES

- strengthen stakeholder and public confidence in the integrity and efficiency of operations;

- demonstrate how they are discharging their legal, social and ethical obligations;
- better manage exposures to possible fraudulent, dishonest and or unethical behaviour; and
- protect the interests of stakeholders and the public.

Corporate Governance Models - Public sector agencies vary in their organisational complexity, the nature of the goods and services they provide and consume, their size and geographical location/s, their client/stakeholder base and in their social, economic, political and service objectives. Agencies also differ in terms of their management structures with many having governing Boards. Thus there can be no single model of corporate governance however, there are a number of common elements that are the essential building blocks to form a robust and effective public sector governance framework.

Risk Management within NSW Public Sector - The establishment by Public sector agencies of a systematic and rigorous Risk Management framework and culture is now recognised as being an essential element in the establishment and maintenance of an effective and robust Corporate Governance regime. Research by the NSW Audit Office and Treasury Managed Fund (TMF) however, shows that many agencies, while they are aware of the need to manage risk, have yet to put in place effective risk management practices that meet accepted "better practice" principles. This research also shows that a significant proportion of public sector managers have a less than ideal understanding and knowledge of the government's risk management requirements and expectations.

Need to adopt an "Enterprise Wide" perspective to risk management - Risk management initiatives adopted within agencies have tended to be developed along separate lines (eg OHS, fraud, business continuity etc) in various parts of the organisation. This contrasts with accepted "best practice" that emphasises the importance of risk management being co-ordinated in a systematic and integrated fashion and developed from an "enterprise wide" perspective where all business risks faced by an organisation (ie social, ethical, environmental, safety, financial and operational etc), are considered.

How IAB Services can assist agencies with their risk management requirements -

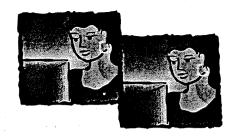

- Ensuring that the process has been impartial and fair with no party being given advantage over another;

- Ensuring that all relevant participants in the process are aware of their responsibilities to disclose conflicts of interests
- Reviewing documentation to ensure an appropriate level of accountability has been maintained;
- Assessing arrangements to ensure the confidentially of information;
- Providing reports to management based on predetermined milestones, or as requested, or when considered necessary, to provide a record of the process confirming that probity has been observed; and
- Preparation of a signed, written final report expressing the probity auditor's opinion as to agency's performance and which highlights significant findings and recommendations
