Council resolved on 4 May 2009, to make a submission to the Joint Standing Committee on Electoral Matters.

North Sydney Council has a number of concerns in relation to the 2008 Local Government Election. These issues concern changes to polling places which caused confusion amongst the electorate; insufficient staff at polling places; absentee voting and the cost of the election.

Details are:

North Sydney Council wrote to the Electoral Commissioner of NSW on 14 October 2008, setting out the following concerns:

#### 1. "Changes to Polling Places

The Polling Place selected by the Electoral Commission were in different locations in a number of wards to those previously used for Local Government Elections. This caused much confusion for electors.

North Sydney Council requested that the previously used polling places be used but the Electoral Commission would not agree.

Electors had particular difficulties finding the Polling Place at SCEGGS Redland.

Council advertised the Polling Places on our website, in the local newspapers and in our Community Newsletter as well as via our Precinct Committees. We also promoted the Electoral Commission's website, however, electors were still confused due to the changes.

#### 2. **Insufficient Staffing**

There was insufficient staffing to cope with the number of electors. This was particularly evident at Neutral Bay Primary School where electors had to queue for hours.

Council put a number of referendum questions to the electorate, which obviously would take more time to complete, but it would appear that this was not taken into consideration when determining staffing levels.

## 3. Absentee Voting

The legislation disallowing Absentee Voting in Local Government Elections, continues to create problems for electors. There needs to be much more promotion leading up to the elections in the future in order to minimise this problem.

North Sydney Council requests that the Electoral Commission takes these matters into consideration when preparing for the next Local Government Election."

In addition, the Council resolved that the following points should be raised:

- There were insufficient staff and polling booth boxes to cope with the number of electors throughout the Council area, in particular Neutral Bay Public School, Crows Nest Uniting Church, St Peters Church Neutral Bay and North Sydney Demonstration School.
- There needs to be a more even distribution of polling booths, in this context we query the need for North Sydney Girls High School.
- Access to polling booths for the elderly or those with disabilities needs to be improved.
- Better information needs to be provided to assist people, particularly elderly people, to access postal voting.
- Shaded areas need to be provided at polling booths for those waiting in queues.
- We need to revert to the old system of organising Council elections, whereby with Council administration input, cost were reduced over all.

## **Election Costs**

North Sydney Council has received an account for \$333,400 (GST exclusive) from the Electoral Commission of NSW for the conduct of the 2008 Local Government Election.

North Sydney Council is concerned in relation to the costs, particularly as they compare to the 2004 election. Direct costs for the 2004 election were \$145,666.07. This did not include the cost of accommodating the Returning Officer.

North Sydney Council provided accommodation for the Returning Officer at a cost of \$72,100. When subtracted from the above amount, it leaves a total of \$261,300. This is a 79% increase on the previous costs.

Whilst the expenses have been itemised by the Electoral Commissioner (copy attached), the costing has not been justified in any way.

One item of concern has been specifically which was raised with the Electoral Commissioner is the cost of Printing Ballot Papers. In 2004 North Sydney Council conducted a poll, consisting of three questions. The cost for printing both the ballot and poll papers was \$7,700. For the 2008 election, the cost of printing ballot and poll papers, albeit for five questions was \$51,930. We consider this to be excessive.
