## Examination of Auditor-General's Performance Audit Report 157 Condition of State Roads

We have reviewed the submission provided by the Roads and Traffic Authority concerning the recommendations in the above performance audit report.

Following tabling of the report, we were pleased that the Chief Executive Officer indicated he accepted all of the report's 14 recommendations. His response to the report also provided some additional details regarding how they planned to address each recommendation (see attachment 1).

The latest submission from the Chief Executive Officer confirms the acceptance of all recommendations and advises that the Authority's plan to implement these is well advanced.

The submission, however, does not contain sufficient detail for us to make any assessment of the progress of the Authority in implementing each recommendation. We have not substantiated the Authority's submission.

You may wish to consider asking the Chief Executive Officer to provide further information on the status of each recommendation, the outcomes-that the changes are intended to achieve, progress against milestones, who has responsibility for implementation and how progress is monitored.

I plan to forward a copy of this correspondence to the Chief Executive Officer, Roads and Traffic Authority for his information.

I am very happy to provide any further assistance the Committee may need in completing-its examination.
