## INQUIRY INTO THE MANAGEMENT OF DOMESTIC WASTEWATER

Reference is made to your invitation for written submissions regarding the Inquiry into the Management of Domestic Wastewater.

The Terms of Reference have been reviewed whereby the following issues/concerns relating to the management of domestic wastewater are raised for the Committee's consideration:

- 1. Information related to domestic wastewater management is exhaustive however much of this is not mandated and is too complex for ordinary landowners to understand the requirements and their responsibilities.
- 2. There is insufficient regulation of the food production industry. The NSW Department of Primary Industries (DPI) and the NSW Food Authority (FA) need to increase their roles and be given more power and resources to better manage food production and its safety.
- 3. Many Council's currently don't have the resources to exercise the functions imposed upon them for the management of sewage management facilities and the requirements and expectations are increasing beyond what Council's can manage.
- 4. The responsibility of regulating the food production side of things must remain with the DPI and the FA.
- 5. Considerable focus should be placed on the means and methods in reducing the overall number of on-site sewage management facilities in food production regions.
- 6. The penalties for non-compliance with Approvals to Operate and Orders under the Local Government Act 1993 are far too lenient and do little to discourage bad/illegal practices. This would especially apply where an income is being received from food production activities.
- 7. The issue of domestic wastewater and food production really needs to be managed and controlled at a State level and should not be the responsibility of local government. Perhaps intervention or assistance by the Federal Government is possible particularly in circumstances where food is exported.
- 8. The servicing of aerated wastewater treatment systems (AWTS) is an unregulated industry despite Council's pleading with the State Government for years to do something about it however it seems to be repeatedly put in the "too hard basket". The industry needs to be regulated by NSW Fair Trading due to the fact that these service agents move between local government areas. It cannot and should not be a role for individual Councils.
