



### INQUIRY INTO SUSTAINABILITY REPORTING IN THE NEW SOUTH WALES PUBLIC SECTOR

Dear Mr Brown

Gosford City Council has recently become aware of the Public Accounts Committee call for submissions to an inquiry into Sustainability Reporting in the New South Wales Public Sector.

Gosford City Council would like to advise the Committee that it produced its first ever Sustainability Report in 2004. The main aim in producing this report was to allow Council to commence a process that could improve sustainable decision making for the local government area. The report allows for sustainable decision making by providing a transparent link to Council's annual management planning process for economic, environmental and social considerations. Governance and Leadership is an additional element in the report which Council will use to allow for sustainable decision making in regards to policy improvement/development, corporate planning, management structures and internal operations management.

This Sustainability Report breaks away from the current internationally accepted model for Sustainability Reporting (that being, internal corporate sustainability reporting) in that it is reporting on sustainable outcomes for our local community.

Gosford City Council would like to invite the Committee to use its Sustainability Report to provide an example of an initiative from within the public sector, and assist the Committee in their inquiry.

The secretary of the Committee has been provided with a copy of Council's report and Council would be happy to provide additional copies upon request.

### HUMAN SETTLEMENT AT A GLANCE

#### SOLID WASTE

State:

**Improving** 

The total volume of solid waste being landfilled is decreasing. The level of domestic recycling and waste diversion is increasing. The life of existing landfill sites has been extended.

Pressure:

Increasing

Population increases result in higher volumes of solid wastes to be managed.

Response: Good

Council has introduced an extensive domestic waste management service to the community. This incorporates an expanded commingled recycling service and a new garden organics service. Council has also resolved to implement resource recovery (recycling/diversion of soils, green waste and construction/demolition waste) at its two-landfill depots and introduced financial incentives to encourage more sustainable disposal practices. This will significantly extend the life of the existing landfill sites and provide Council with adequate timeframes to address long-term waste management solutions.

#### HERITAGE

State:

Declining

Not all significant sites are adequately protected. Council is currently in the process of transferring items of Environmental Heritage listed in Development Control Plan No. 34 to the Draft Heritage Locals. Environmental Plan.

Pressure: Increasing

Legislation provides protection for environmental heritage listed items, and the pressures on heritage resources include:

 increasing land values resulting in a push to maximise development potential of sites; and


 development reflecting current trends rather than the existing character of the area. These have resulted in the loss of context and the degradation of streetscapes where consistent older style streetscapes have given way to a mixed variety of residential designs with little relationship to each other.

Response: Good

The Draft Heritage Local Environmental Plan, which includes items identified in Stage II of the Heritage Study and Development Control Plan No. 34 - Items of Environmental Heritage Conservation, is to be re-advertised. Those items identified in the Heritage Review in the Gosford City Centre and existing heritage items are to be included in the Gosford City Centre draft Local Environmental Plan which is currently being advertised.



#### NOISE Council is unaware of any substantial unreasonable noise issues in Reasonable State: Gosford. Development is increasing the pressures on land, which can result in land degradation due to poor management practices.

Response: Reasonable

Council is currently reviewing its policies on Erosion and Sediment Control and integrating these principles into an integrated Water Cycle Management Development Control Plan.

#### CONTAMINATED LAND

State:

Reasonable

The data within Council's Contaminated Sites Register has been imported into Council's database.

Pressure:

Increasing

The pressures on contaminated land are increasing with the redevelopment of land throughout the city.

Response:

Good

Council is implementing the Contaminated Sites Register and is adhering to the provisions of SEPP No 55 and EPA Guidelines for remediation and assessment of contaminated sites within Gosford LGA:

### LAND USE

State:

Stable

Medium density residential areas are being increasingly developed to accommodate future growth. Many town centres are in need of revitalisation. Rural areas on the plateau are generally prosperous and diversifying.

Pressure:

Increasing

Sydney's continued population growth and Gosford's relative affordability of housing results in continuing migration pressure on services and the environment.

Response: Reasonable

Council implements a variety of strategies to address land use pressures Council has regard to the principles of ecologically sustainable development when improving existing strategies and developing new strategies for the Local Government Area.

### WATER AT A GLANCE

#### DRINKING WATER

State:

Increasing

Adequate supplies of good quality drinking water are available for the

near future if the community continues to conserve water.

Pressure: Stable

Drinking water supply catchments are well protected. There may be a slight increase in demand as population increases, however, this may be offset by reductions in consumption on a per capita basis.

Response: Good

Council is implementing water conservation initiatives and is carefully managing its water supply catchments to maintain clean, healthy

managing its water supply catchments to maintain clean, nearing water supplies. Gosford-Wyong Councils' Water Authority introduced Level 2 water restriction in May 2004 to ensure adequate supplies through the recent period of low rainfall and are exploring

alternate water sources.

### WASTE WATER ON-SITE TREATMENT

State:

Stable

The impacts of waste water caused by on-site sewage systems is stabilising with the implementation of Council's On-Site Sewage

Management Strategy.

Pressure:

Increasing

Increased population pressures have resulted in an expansion in residential development and occupancy rates in unsewered areas, the building of large houses on sites that are small and/or difficult to manage and the expectation of residents to reuse treated wastewater on their properties all put pressure on the sustainability of wastewater generated by on-site sewage management throughout the Gosford LGA. In addition, with diminishing town water supply.

resources there is an increasing pressure to reuse treated wastewater for such purposes as irrigation and toilet flushing in sewered areas.

Response:

Good

Council is continuing to implement the On-Site Sewage Management Strategy. This incorporates a program of inspection, monitoring, licensing and educating owners in the responsible use of on-site sewage management systems. As a result of Country Towns Water Supply and Sewerage Program funding opportunities administered by (DEUS), Council and Sydney Water has formed a steering group to investigate an integrated approach on an expansion of the sewerage scheme to some remote river frontage communities.

### WASTE WATER TREATMENT SYSTEM

State:

Excellent

Council's two sewerage treatment plants continue to operate effectively and efficiently and well within DEC licence and Council

requirements.

Pressure:

Increasing

Increasing population Pressures are resulting in increasing hydraulic

#### GROUNDWATER

State:

Uncertain

DIPNR have developed water sharing plans that assume that groundwater on the Gosford Plateau is being used sustainably, however, there is insufficient data to confirm the ongoing status of this natural resource.

Pressure:

Increasing

An increasing number of property owners are seeking consent for the extraction of ground water.

Response:

Water Sharing Plans will establish a management framework that aligns both entitlements and use with the sustainable yield of each groundwater system or zone, as well as ensuring that local impacts are minimised.

### RECREATIONAL WATER

State:

Good

Overall the water quality within Brisbane Water and the coastal lagoons is good, although the water quality of some of the tributary creeks may be poor after a rainfall event.

Pressure:

Increasing

Increased urbanisation and pressure to develop more land within the catchments will potentially deteriorate the ecological health of our waterways.

Response:

Reasonable

Council continues to monitor water quality and initiated a series of studies that will quantify how urbanisation is impacting on waterways.

### FLOODING AND DRAINAGE

State:

Improving

The number and extent of urban flooding problems are decreasing with the introduction of the Drainage Levy.

Pressure:

**Increasing** 

As Council is progressing its Drainage Levy Strategy, it is gradually relieving flooding pressures to existing development throughout the city, however with less suitable land remaining for future development pressures are now being placed on Council to allow development in problem areas.

To reinstate and maintain natural watercourses in an ecologically sustainable manner additional funds are required for each drainage and flood mitigation project, therefore fewer projects are being performed each year with the available funds. In particular annual maintenance recurrent funds are unable to address the required maintenance issues for working in or adjacent to watercourses.

Response: Fair

Council spends in the order of \$4million per year on flood mitigation and drainage proposals, however this is insufficient to address the \$150 million plus of outstanding works, which is growing each year as more studies of old areas of Gosford City reveal the need to upgrade the drainage for these areas. Council also needs to seriously investigate Water Sensitive Urban Design principles to assist in reducing the amount of stormwater run-off and thus flooding problems.





### BIODIVERSITY

#### BIODIVERSITY

State:

Declining

Quantifying the extent and condition of biodiversity is difficult. Actions to measure the extent and condition of biodiversity included:

- I. A systematic and targeted biodiversity survey 2000/01
- 2. Comprehensive local scale vegetation mapping
- 3. Photogramatic analysis of estuarine vegetation through time as a component of the Brisbane Water Estuary Process Study. Preliminary results suggest expansion of mangroves at the expense of saltmarsh.
- 4. Targeted threatened species investigations (Yellow-bellied Glider, Green and Golden Bell Frog, Bush Stone-Curlew, Somersby Mintbush, Tranquillity Mintbush.

Pressure: Increasing

Pressures are increasing as a result of increased urbanisation of many parts of the City. Pressures include clearing/underscrubbing and associated impacts such as fragmentation and land and water degradation, feral and domestic animals, weed invasion, increasing fire frequency, and climate change. Urbanisation and associated changes to foreshore habitats impact on the quality of receiving waters and hence estuarine biodiversity.

Response: Improving but needs to be across all Council. activities and responsibilities Council is responding to the challenges to conserve and manage. biodiversity in Gosford City. Responses include ongoing programs such as Council's Bushcare Program and employment of a Noxious Weeds Officer.

Council plans to employ a full-time Corridors Project Officer and Fire Management Officer in the near future. In addition, Council continues to expand its Coastal Open Space System (COSS) and has recently commenced fox baiting in several of these reserve areas.

Other actions include implementing specific threatened species programs and the commencement of the Brisbane Waters Estuary Processes Study, which will provide guidance for the Brisbane Waters Estuary Management Study and Management Plan to address development pressure on Brisbane Water estuary.



In Gosford City LGA there are almost 88,500 hectares of native vegetation remaining, this includes wetlands.
