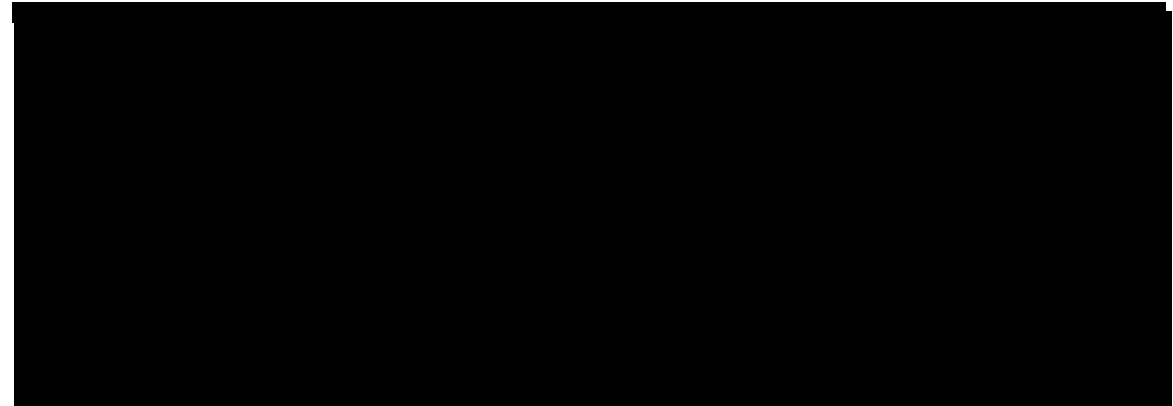
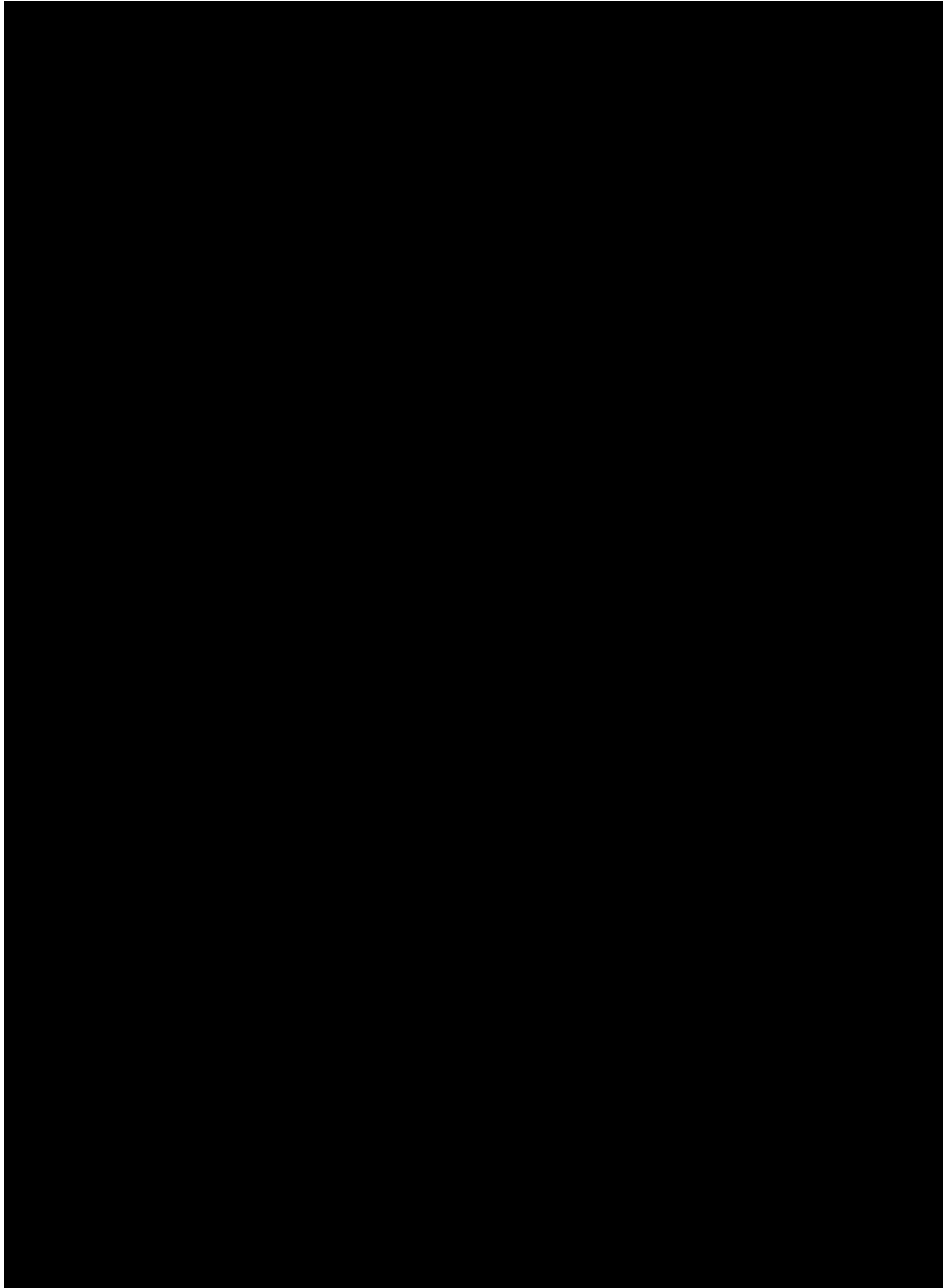

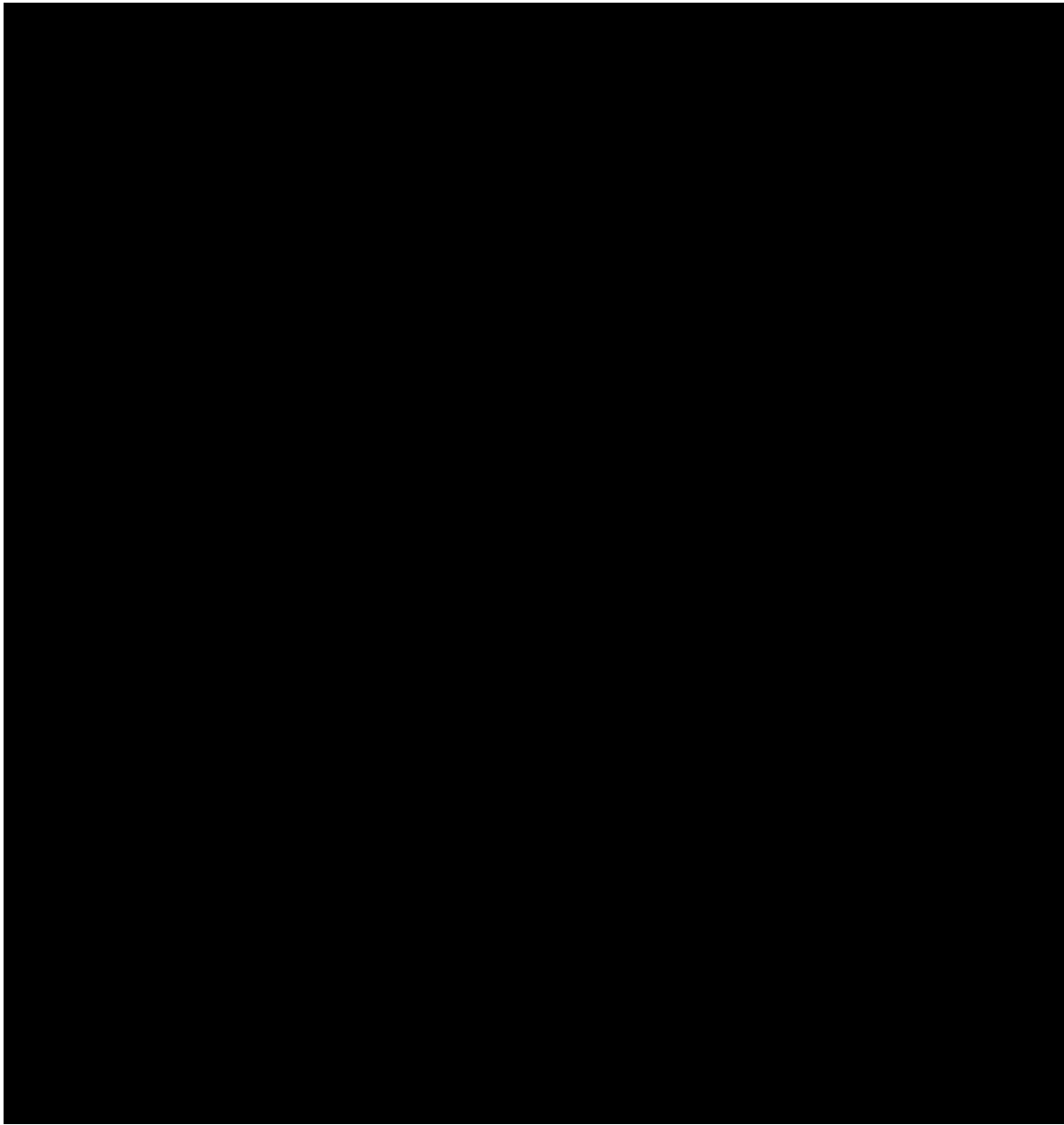

5 steps to extend harm minimisation practices into the lives of sex workers' children.

There are five steps to extending harm minimisation into the lives of sex-workers' children.

1. The background practices that operate in commercial brothels that lead to children being in danger must be eliminated. Significant progress towards this can be achieved by regulating brothels into the form of child aware women's collectives where brothel profits are sequestered for the safety, education and well being of the children of sex workers and sex workers themselves rather than providing income for those who would exploit women and leave their children at risk.
2. Child friendly procedures that support the escape, reporting and recovery of abused children of sex-workers need to be emplaced as a matter of urgency. These must be specifically tailored to the realities associated with being the child of a sex worker. These are to be funded from brothel profits.
3. Independent research into the impacts of sex work on the children of mothers in the sex trade must be undertaken. These are to include research into contemporary experiences of the children, ongoing initiatives into providing for their safety and exploration of their historical treatment. These are to be funded from brothel profits.
4. Independent crèches/child care facilities staffed with abuse aware people that operate in the hours they are required for the children of mothers in sex work are needed. These are to be funded from brothel profits.
5. A modified Swedish model must be implemented to reduce or remove non-compliant sex work.
