## Performance Audit – Community Housing

Thank you for your letter of 6 September 2016 requesting a response to the Auditor-General's performance audit report on Community Housing, including actions taken to date. The Department agrees with the recommendations in the Auditor-General's report and over the last twelve months, has made notable progress in implementing these recommendations. Some key achievements to note:

- The Social Housing Policy, Future Directions for Social Housing in NSW was launched in January 2016. The policy describes new outcomes for people supported by social housing programs in NSW, and includes an expanding role for the community housing sector. Measurable social housing targets that align with the Premier's and State Priorities have been identified. A copy of the policy is provided.
- Release of the Communities Plus Program, which identifies a number of redevelopment opportunities across the social housing portfolio. The Program seeks to engage private sector developers and community housing providers (CHP's) to deliver affordable social and private housing on NSW Land and Housing Corporation land.
- FACS is implementing the Human Services Outcomes Framework, which sets the outcomes that FACS programs, including Community Housing, are expected to achieve into the future.

FACS' responses on the status of the recommendations are detailed in the attached report.
