Inquiry into the sustainability of energy supply and resources in NSW

The energy supply policy currently being pursued by the NSW and Australian Governments is doing enormous harm to the people of NSW. It is costing the people of NSW at least \$10 billion in excess electricity prices every year and it is imposing harm to the health of many NSW citizens as well as great environmental harm. If the policies are continued, it will perpetuate increased harm to the people of NSW. It is not sustainable, nor is the NSW economy if the policy continues.

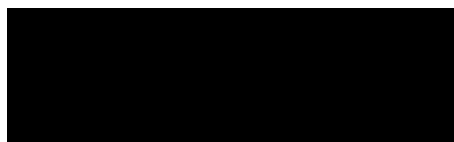
The policy is based on an anti-scientific fraud serving the interests of power-seeking bureaucrats, rent seeking destructive businesses and faux scientists who rely on the hysteria of ignorant politicians and journalists to provide research grants that grease their palms to provide dishonest studies which can further the political and money-grabbing aims of the bureaucrats and crony capitalists.

The policy ignores the massive annual increases in CO₂ emissions by China, India and many other countries which vastly outweigh even the total of Australia's CO₂ emission such that, even were the supposed science not a fraud, the harm being done to the citizens of NSW would serve no useful purpose either for those citizens or for mankind in general.
