Uralla Shire Council Submission – NSW Parliamentary Inquiry into Assets, Premises and Funding of the NSW Rural Fire Service (RFS)

Dear Committee members

It is noted the inquiry is examining the funding, maintenance, accounting, and operational management of assets and premises belonging to the NSW Rural Fire Service, including arrangements with councils.

Council expresses its support for this inquiry and appreciates the Public Accounts Committee's consideration of the issues outlined in this submission.

The Rural Fire Amendment Bill was presented to the NSW Parliament by the Member for Northern Tablelands, the Hon. Adam Marshall, in 2023. Council has repeatedly raised concerns about the financial burden of current accounting standards for rural fire assets, particularly for small rural councils, in recent years. Previous correspondence from the Council regarding these matters is attached documents.

There has been a long-standing dispute between Councils and the State Government over the accounting treatment of the Red Fleet. This came to a head with the Auditor-General's 2021 Report on Local Government issued on 22 June 2022: https://www.audit.nsw.gov.au/our-work/reports/local-government-2021 The Report reinforced the State Government determination that RFS assets are the "property" of councils and must be recorded in Council's financial statements, with Council therefore required to absorb all depreciation costs. The Report applies more pressure on councils and the Office of Local Government (OLG) to conform with this determination, even though councils do not have effective management or control of these assets.

Councils across the State and LGNSW refute this determination. Councils do not have any say in the acquisition, deployment, or disposal of these assets. Comparable assets held by Fire & Rescue NSW (FRNSW) and the State Emergency Service (SES) are not vested anywhere other than with the organisations that purchase, use, maintain and dispose of them.

This submission endorses the comments made by the then CEO LGNSW in correspondence to the A/Deputy Secretary, Local Government, OLG dated 27 June 2023:

"LGNSW is perplexed as to why the NSW Government is now taking such a hard line in insisting that the assets be recognised as local government property. It is logical that RFS assets be treated consistently and in the same way as assets of other emergency service agencies such as the State Emergency Service (SES) and Fire & Rescue NSW, with ownership vested in the respective agencies.

It is the clear position of LGNSW that councils should not record RFS mobile assets in their financial statements and LGNSW will continue to recommend that councils continue to consider their own position on this matter.

It is especially disappointing that contrary to its previous position the OLG is now requesting so many councils across NSW to divert already strained council resources to provide OLG with further information on strategies to respond to the nonsensical position that RFS mobile assets are not assets of the RFS. This diversion of resources will distract councils from their core work for the community and will not provide any public benefit.

Councils across NSW rely on the support of the OLG. I strongly urge the OLG to reconsider its current position on this matter and rightly recognise that RFS mobile assets should be recognised as assets of the RFS for accounting purposes – in line with the independent expert advice OLG commissioned on this matter in 2018."





As you are aware, there has been a long-standing dispute over the accounting treatment of the Red Fleet that came to a head with the Auditor-General's 2021 Report on Local Government on 22 June 2022. The Audit Office Local Government Report is now applying more pressure on councils and the Office of Local Government (OLG) to conform with their determination even though councils do not have effective management or control of these assets.


The Private Member's Bill proposes amending the Rural Fires Act 1997 to transfer the ownership of NSW Rural Fire Service (RFS) vehicles, fire trucks and buildings from local councils back to the State Government. This will reverse what is a significant financial burden on councils, particularly smaller rural councils like Uralla.

On behalf of my fellow Councillors and Northern New England Mayors, I would like to invite you to visit our region to meet with local Mayors to discuss this issue further. As this is an issue of

significance for our councils, we would appreciate the opportunity to introduce you to our region and the impacts the current requirements are having on our councils.
