He unlocked my car, jumped in, and locked it, before I could get to him. There was a porcelain piglet that I tried to break the driver's side window with, but it shattered and cut my elbow. By this time, the car was started, and he slammed it in reverse, going straight through my garage door, pulling away the roller door. The car was written off by the NRMA but I had to pay \$1350 in excess. It took NRMA from the incident until 8/12/22 to repair my garage door.

I hung My Car Keyes where I had hung them pregor to suspected entruser. at affrose 10.55 PM Iwas watching the final game of football when all of a sudden my Frank front Door sung open, checking to see what happend I could not see any body I though how did they open, closing and bothing them again I came back and turned the TV off I did not check the back door because that was where I was setting going into my bedroom I remingted to clean my teeth which I did

every night, as I carrie out of my bedroom to go to the bathroom of nocied my laundy door was open which I had closed early in the night on inspection my gaings does was open going to the garage of switched the light on I saw an intured at the lack of my car I yelled out what do you think you are doing, Not knowing that while I was in the bedroom he came through the back door & got my lot keys of the wall as I was going around the back of my car, He untocked the door an Tumped into into the Olnwer seat and backed the door. pecking up a form of a piglet which I though was made from concrete. I slammed It into the driver side window hoping to brake the glass and shows him with glass only to have the piglet shatter ento a mittion peaces and come back at me and cut my ellow. The entructor was looking schocked at my action he was having trouble inserting the see of got a Vereg good look at her face best at this stage of didn't have a clue who he was. Starting my car he stammed the ca into severce and went backward & smoothed into the gasage door at the first attempt he didn't Succed be them came forward and me on his second attempt he smached right Arrough the voller doorand managed to get away. Calling 000 the police was at my home in SMinutes flat The policeman called police fatrol which he said the car was in his Vision & gave chase but had to give eep as it was dangeros to keep going the Police Said See if the were any finger prints

Asking me if I thought the door were in fact looked I said yes they were hocked she said watch me and she had both them doors open in ten seconds flat. NRMA said my car was write of so they paided me out They gave me an often to beeg my car back for \$500.00 dollars So
I bought it and a friend of mine en
tamworth and repaired it so I could regrister
it which I done. Getting my car back on the road I brought it home to they nepthew to Escamine it on my way home it just didn't seem right. He said it seemed o. K beet he said we will take it for a good test out on the open road. we went out the wondobar road, My nepthew said drop your foot just as though you wanted to pass some one. Diopping My foot it responded well but only for a little while and the car started to shake in the steering an there was a great bang I peelled up as quick as I could and fulled the bonnet catch with smoke Coming out from the bonnet opening it up only to find we had blowned a injector and the Cal was alight, as we had a couple of bottle of water we mearly had it out but vein out off water, The first cal that came along also had one bottle of water beet to No avoid So My Care was burnt beyond sepail

a police chase on the Wondabah road and the person they were chasing lost control and volled a few times ending up with the driver driver being killed, I believe he was ariving a Stolen cart he was suspended from driving. at this wake there was a lot of Photar on face book, my Nephew Showed me the Photo's and I reconesed the chaf that Stole my car. NRMA House insurance covered to change the locks again. Before NRMA repaired the voller door and the stole after me frounting another car a slammed into the tempory door. smashing it to pieces at approse. 4.00 Am on 15th October, We got the whole hot on Camia but could Not get a good look at who was driving the then burnt the Car approse withen Soo MIS of my Home. The No Plates on the Camera was the Same as the car that was beent. Swas very Lucky to Have a Couple of my forcerids who were on the Job + repaired my smashed door, So I Bought them a good bottle of Scotch for their effort. Now I feel like a prisoner in My own Home. with my doors LockED + BARREDE. every Night I Hede my Keys every Night & I Have a heavy Hammer hear my bed en case of fire So I. Can smash a window to get out and at 85 yrs of age it just dose not seem night. TRUSTING YOU FIND EVERYTHING NEEDED
