# COMMUNITY SAFETY IN REGIONAL & RURAL COMMUNITIES INQUIRY SUBMISSION TO HAVE INQUIRY HEARING CONDUCTED IN INVERELL

In November 2023, Council resolved to support the Country Mayors Association of NSW (CMA) in their pursuit of a parliamentary inquiry into crime, law and order in regional NSW. At the time the CMA had produced a report which clearly demonstrated disproportionate crime levels and fewer police resources in regional and rural NSW.

At their meeting on the 22 March 2024 (attended by Inverell Shire Council's Mayor and General Manager) the CMA released their updated Crime, Law and Order report. The report included 2023 crime statistics as provided by the Bureau of Crime Statistics and Research (BOCSAR). The report makes for sobering reading. For the New England North West area, the rate of property crime was 1.9 times above the state average and violent crime 1.8 times above the state average for 2023. The report further broke down into local government areas crime rates per 100,000 population over a range of offences. Concerningly, Inverell is significantly above the state average for a range of offence categories including theft, break and enter, sexual assault, drug offences and domestic assault.

Also noting the recent crime statistics from BOSCAR, the NSW Premier on the 12 March announced a package of reforms and initiatives to support community safety and wellbeing, particularly in regional NSW. The package included legislative reform such as amending the Bail Act to include an additional bail test for youth charged with certain offences and the creation of a new offence for 'posting and boasting'. Other package components included a place-based response in Moree and a range of regional crime prevention initiatives.

The crime problem confronting Inverell Shire is not unique to this area and reflects a much broader social issue being experienced in rural and regional areas across the nation. It has been broadly acknowledged policing alone will not overcome this issue and it will require a multi-faceted approach involving each tier of government to develop both short term and long-term solutions. Whilst councils' sphere of influence on law and order matters is somewhat limited, continued advocacy to authorities and government to advance the interests of our community is obviously paramount.

Member for Northern Tablelands Adam Marshall MP convened a Mayoral Roundtable meeting in Inverell on the 4 April 2024. Shadow Minister for Police and Committee on Law and Safety member, Paul Toole MP was also in attendance. A significant part of the meeting was dedicated to the crime pandemic confronting rural and regional NSW. Whilst Moree has been at the forefront of recent publicity around the matter, it was clear from those in attendance the issue was impacting on each of the Councils across the electorate. Mr Toole stressed the importance of having the Inquiry Committee conduct hearings in regional areas to provide the opportunity for community members to tell their story and put forward suggestions. Mayor Paul Harmon advocated for Inverell to host a hearing to facilitate an opportunity for council representatives and residents from the Northern Tablelands to address the committee. There was consensus from those in attendance at the Mayoral Roundtable for Inverell Shire to make a submission in this regard. Formal letters in support of having an Inquiry Hearing conducted in Inverell have subsequently been received from the Member for Northern Tablelands and Northern Tablelands Councils and are attached for the attention of the Committee.

I welcome the opportunity to host an Inquiry Committee hearing in Inverell and look forward to contributing to the process along with my Northern Tablelands counterparts.

Please note that in addition to Council's request to host an Inquiry Committee hearing, Inverell Shire Council will also be making a separate submission to the Inquiry regarding the level and impact of crime in the Inverell Shire.


