1 MEETING OF THE HOUSE

The House met at 2.30 pm according to adjournment. The President took the Chair and read the prayers.

The President acknowledged the Gadigal clan of the Eora nation and its elders and thanked them for their custodianship of this land.

2 STATEMENT BY PRESIDENT—CENTENARY OF THE FIRST WORLD WAR

The President made a statement that marked the centenary of an address by His Majesty King George V to the British Parliament.

The President then announced that the New South Wales Parliament will hold a centenary of ANZAC exhibition entitled "Politics and Sacrifice: NSW Parliament and the ANZACs", from January 2015, to be opened by His Excellency the Governor.

3 PARLIAMENTARY BUDGET OFFICE—REPORT

The President, according to the Parliamentary Budget Officer Act 2010, tabled the Parliamentary Budget Office Operational Plan for 2014-15, dated 5 November 2014.

4 INTERSEX AWARENESS DAY (Formal Business)

Dr Faruqi moved, according to notice:

- 1. That this House notes that:
 - (a) Intersex Awareness Day is recognised on 26 October every year,
 - (b) people with intersex variations face lifelong discrimination and stigmatisation for their sex differences.
 - (c) intersex people, particularly children, are often subject to disturbing and invasive medical interventions to "correct" their sex differences,
 - (d) there are serious human rights concerns with the way that intersex people are currently considered and treated by the medical community and in general, and
 - (e) broader social awareness of intersex variations remains drastically underdeveloped, and this must change.
- 2. That this House calls on the Government to:
 - (a) acknowledge the human rights of people with intersex variations, and
 - (b) work with the Australian Government to implement the recommendations of the 2013 Australian Senate Community Affairs Committee report on the 'Involuntary or coerced sterilisation of intersex people in Australia'.

Taxi transport subsidy cap for people with disability

Ms Barham presented a petition from 137 citizens of New South Wales stating that the taxi transport subsidy scheme's maximum level of \$30 has been in place since 1999 and has gone without an increase for 15 years during which time taxi fares have increased over 60 per cent, that the current subsidy is inadequate and has not kept pace with the rising cost of living in New South Wales and does not meet the needs of people with a disability, many of whom have no other transport options, calling on the New South Wales Government to recognise that suitable and affordable transport availability for people with a disability is a human right and for many people taxi transport is the only mode available, noting that Victoria doubled its equivalent scheme to \$60 in 2008 and requesting that the taxi transport subsidy scheme's maximum cap be doubled to \$60.
