\*1153 PLANNING—COOKS RIVER—Dr Faruqi asked the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism representing the Minister for Planning—

- (1) What water sensitive urban design practices are currently in place for new developments particularly with respect to stormwater flowing into the Cooks River?
- (2) Is there a State Environmental Planning Policy in place to regulate developments in the Cooks River catchment area?

Answer—

I am advised:

- (1) New development along Cooks River is governed by the relevant local council. While each council has specific development controls relating to stormwater management they have formed the Cooks River Alliance to promote and coordinate sustainable urban water management along the Cooks River.
- (2) The proposed Coastal Management SEPP, currently on exhibition, maps significant areas of coastal wetlands along the Cooks River.

Precinct specific controls apply in the Cooks Cove Sydney Regional Environmental Plan No 33.

There is no specific placed based State Environmental Planning Policy for the wider Cooks River Catchment.

\*1154 ROADS, MARITIME AND FREIGHT—NORTHCONNEX WATER TREATMENT PLANT—Dr Faruqi asked the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council—

- (1) Is the NorthConnex water treatment plant functioning effectively?
  - (a) If not, why not?
- (2) Has there been any flooding and water pollution in Kingsley Close, Wahroonga this year?
  - (a) If yes, what was the cause?
- (3) How many complaints have been made to the NorthConnex Project or Roads and Maritime Services regarding the water pollution?
  - (a) Did Roads and Maritime Services take any action to resolve the issue?
  - (b) If yes, what action was taken?
- (4) What steps has Roads and Maritime Services taken to investigate sediment surrounding the NorthConnex water treatment plant?
- (5) Has Roads and Maritime Services taken any steps to ensure the polluted water is treated appropriately?

Answer—

I am advised:

- (1) -2. and 5. The NorthConnex Water Treatment Plant is functioning effectively. There has been no water pollution from works associated with the NorthConnex project. Due to an east coast low storm event in June 2016 there was flooding as a result of around 300 millilitres of rainfall over 48 hours. All water from the NorthConnex sites is treated by the water treatment plant, or licensed sediment basins, before discharge to the storm water system. All water is treated to the standards set out in the Environmental Protection Licence issued by the Environmental Protection Authority and the project Soil and Water Management Plan approved by the Department of Planning and Environment.
- (2) (see above)
- (3) Nine complaints have been received. The Environmental Protection Authority and the Department of Planning and Environment conducted multiple inspections in the area adjacent to Kingsley Close and found no pollution from the NorthConnex project.

- (4) An independent environmental expert has investigated allegations of sedimentation. No evidence of sedimentation from the water treatment plant was identified.

\*1155 TRANSPORT AND INFRASTRUCTURE—NEWCASTLE LIGHT RAIL PROJECT—Dr Faruqi asked the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council representing the Minister for Transport and Infrastructure—

Concerning the Newcastle Light Rail project for which \$142 million has been set aside in the 2016-17 State Budget:

On 9 August 2016, it was announced that Downer EDI had been awarded the contract to be the Managing Contractor for the Newcastle Light Rail Project.

The contract commenced in August 2016 and is to be completed by 2019.

- (1) How much is the contract worth in total?
- (2) How much is the contract worth for the 2016-17 financial year?
- (3) How much is the contract worth for each financial year going forward i.e. 2017 18 and 2018 19?

Answer—

I am advised:

The value of the contract for Newcastle Light Rail will be subject to Transport for NSW accepting the Target Budget, commercial arrangements and the standard variation clauses of construction contracts.

This contract forms part of the \$510 million Newcastle Urban Transformation and Transport Program, a coordinated program of planning, urban renewal and transport initiatives designed to attract people back to the city centre, create job opportunities and restore the vibrancy of Newcastle's CBD.

\*1156 ENVIRONMENT—KANGAROO MANAGEMENT—Dr Faruqi asked the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism representing the Minister for the Environment, Minister for Heritage, and Assistant Minister for Planning—

- (1) Please provide the raw survey data sheets for the most recent kangaroo survey for the Central Tablelands, Northern Tablelands and South East New South Wales kangaroo management zones.
- (2) Please provide the number of kangaroos shot under landholder licences in each kangaroo commercial shooting zone in New South Wales, broken down by male and females shot and species shot, for the following financial years:
  - (a) 2016/2017 (to date)
  - (b) 2015/2016
  - (c) 2014/2015
  - (d) 2014/2013
  - (e) 2013/2012
  - (f) 2012/2011
  - (g) 2011/2012
- (3) Was a report entitled "Red and Grey Kangaroos in Western NSW" by Dr Jim Hone, provided to the NSW Kangaroo Management Advisory Panel Meeting 14 March 2013?
  - (a) Please provide a copy of that report.

\*1157 ENVIRONMENT—CENTENNIAL PARK TRUST—Dr Faruqi asked the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism representing the Minister for the Environment, Minister for Heritage, and Assistant Minister for Planning—

(1) How many trustees are required to be on the board of the Centennial Park and Moore Park Trust, according to the Centennial Park and Moore Park Trust Act 1983?

(a) How many trustees are currently on the board of the Centennial Park and Moore Park Trust?

\*1158 ENVIRONMENT—BYLES CREEK VALLEY—Dr Faruqi asked the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism representing the Minister for the Environment, Minister for Heritage, and Assistant Minister for Planning—

(1) What was the purpose of clearing undertaken along the firetrail at Byles Creek Valley in the Lane Cove National Park in October this year?

(a) How many trees were removed as part of this process?

(2) Was the clearing undertaken by National Parks and Wildlife Service (NPWS) or by a contractor?

(a) If a contractor, who was the contractor?

(3) Is the NPWS investigating any complaints regarding the clearing?

(a) If yes what were these complaints and how were they resolved?

(4) When is the clearing expected to be completed?

(5) How big an area has been cleared to date?

(a) How much is expected to be cleared in total?

(6) How far along the firetrail has clearing been undertaken?

(a) How far along the firetrail is clearing expected in total?

(7) What is the expected impact of the clearing on any native flora or fauna in the National Park?

(8) Is the NPWS satisfied with the standard of work in clearing along the firetrail?

Answer—

I am advised as follows:

(1) The clearing was essential vegetation management work to ensure Devlin's Fire Trail complied with the safe clearance standards for a Category 1 Fire Trail.

(a) None.

(2) Clearing was undertaken by the National Parks and Wildlife Service (NPWS).

(3) NPWS received complaints around excessive clearing and concerns of an oil spill from machinery. The NPWS investigation found that of the one kilometre of trail treated, around 150 metres had been cleared in excess of the four metre standard. The alleged oil spill was deemed to be a natural secretion in bushland, not machine oil. NPWS met with the complainants on site and presented them with the findings of the review. NPWS assured them that future fire trail maintenance would be managed to retain the four metre standard and take extra care around large trees and watercourses.

(4) The works are complete.

(5) Approximately 3000 square metres of vegetation was treated.

(6) As above.

(7) Potential impacts are minor.

(8) NPWS will incorporate the learnings from this situation when training staff about fire trail maintenance.

\*1160 FINANCE, SERVICES AND PROPERTY—NEWCASTLE RAIL CORRIDOR LAND—Dr Faruqi asked the Minister for Primary Industries, and Minister for Lands and Water representing the Minister for Finance, Services and Property—

- (1) Does the Government intend to sell as freehold, in part or in whole, the land of the former Newcastle rail corridor from Worth Street to Watt Street?
  - (a) If not, is the Government intending to lease the land of the former Newcastle rail corridor from Worth Street to Watt Street?

\*1161 TREASURER—NEW SOUTH WALES PORTS—Dr Faruqi asked the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council representing the Treasurer, and Minister for Industrial Relations—

- (1) Did the Government claim it was not carrying on a business for the purposes of the Commonwealth Competition and Consumer Act 2010 at the Port of Newcastle during its long term lease?
- (2) Did the Government claim it was not carrying on a business for the purposes of the Commonwealth Competition and Consumer Act 2010 at the Port of Botany during its long term lease?
- (3) Did the Government claim it has never carried on a business for the purposes of the Commonwealth Competition and Consumer Act 2010 at the Port of Newcastle during its long term lease?

Answer—

- (1) -3 The Government's transaction team engaged extensively with the ACCC from the early stages of all the port transactions regarding the competition and regulatory framework supporting the transactions.

\*1164 FAMILY AND COMMUNITY SERVICES—WOMEN'S REFUGES—Dr Faruqi asked the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism representing the Minister for Family and Community Services, and Minister for Social Housing—

- (1) Please provide a list of all refurbishments and upgrades of women-only refuges funded by the Responsive Maintenance, Capital Improvements and Disability Modifications Program in:
  - (a) 2016/2017 (to date)
  - (b) 2015/2016.

Answer—

Information on the first quarter of 2016-17 is still being collated and is not currently available. In 2015-16, 50 women-only refuges across NSW received refurbishments and upgrades in addition to regular responsive maintenance conducted on these properties. For reasons of safety and privacy, a detailed list of these properties is not publicly available.

\*1165 JUSTICE AND POLICE—PENALTY NOTICES—Dr Faruqi asked the Minister for Roads, Maritime and Freight, and Vice-President of the Executive Council representing the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—

- (1) How many drivers have been issued penalty notices by police for not passing cyclists at a safe distance since 1 March this year?
  - (a) Please provide a month by month breakdown by Local Area Command.

The NSW Police Force has advised me that official figures relating to the number of penalty notices issued should be sourced from the Office of State Revenue.

\*1166 PLANNING—MOOREBANK INTERMODAL FREIGHT TERMINAL—Dr Faruqi asked the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism representing the Minister for Planning—

- (1) Regarding the Planning Assessment Commission planning approval of the Moorebank Intermodal Freight Terminal, which places a condition that 250,000 twenty-foot equivalent unit not exceed the current capacity of the transport network?
  - (a) Is the only possible road transport solution through the Liverpool Military Area?
  - (b) What is the current status of the Liverpool Military Area?
    - (i) Can its status be altered and if so, how?
- (2) Relating to the answer to question 127 in the supplementary questions for the 2016/2017 Budget Estimates hearing for the portfolio of Roads, Maritime and Freight, specifically that: "The NSW Government has committed \$3.4 million to progress studies into road infrastructure options to manage traffic impacts from the proposed Moorebank Intermodal Terminal and forecast growth in the broader Liverpool and Moorebank area."

\*1167 RACING—BUDGET ESTIMATES SUPPLEMENTARY QUESTIONS—Dr Faruqi asked the Minister for Primary Industries, and Minister for Lands and Water representing the Deputy Premier, Minister for Justice and Police, Minister for the Arts, and Minister for Racing—

- (1) In relation to the response provided by the Minister to question 194 (c) of the Supplementary Questions in Budget Estimates 2016/2017 regarding animal welfare in the greyhound racing industry:
- (a) How will the Government increase animal welfare monitoring in greyhound racing?

Answer—

On 11 October the Government announced that it would give the greyhound industry one more chance in NSW, subject to it agreeing to the strictest regulations to clamp down on animal cruelty.

The Government has established the Greyhound Industry Reform Panel to determine a new regime that will ensure greyhound racing in NSW prioritises animal welfare, has a robust governance structure and a tough independent regulator to monitor the industry.

The Panel, chaired by former Premier the Hon Morris Iemma, includes representatives from RSPCA NSW, the greyhound industry and government.

The Government has asked the Panel to consider:

- mandatory life bans as well as increased jail terms for live baiting
- registering all greyhounds for their entire lives
- an independent regulator with strong new powers to ensure transparency and accountability
- substantially increased resources for enforcement and prosecution as well as animal welfare

Subject to the report of the Panel, legislation will be introduced early next year repealing the racing ban and establishing the new regulatory regime. The Panel will also determine the timing and criteria for a statutory review of the new legislation and regulatory regime.

\*1168 ENVIRONMENT—NORTHCONNEX WATER TREATMENT—Dr Faruqi asked the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism representing the Minister for the Environment, Minister for Heritage, and Assistant Minister for Planning—

- (1) What steps has the NSW Environmental Protection Authority (EPA) taken to investigate water pollution surrounding the NorthConnex water treatment plant?
- (2) What was the outcome of complaints to the EPA in regards to flooding and water pollution in Kingsley Close, Wahroonga?
- (a) Did the EPA take action?
    - (i) If yes, what actions did they take?
- (3) What steps has the EPA taken to ensure that the NorthConnex water treatment plant is being managed appropriately?

Answer—

I am advised as follows:

- (1) The EPA has inspected the NorthConnex water treatment plant at Wahroonga. The treatment plant does not discharge treated water to the stormwater system or to nearby creeks. Treated water is discharged to the sewer under a trade waste agreement with Sydney Water and is not a source of water pollution.
- (2)
- (a) Yes.

- (i) The EPA investigated the complaint about flooding and water pollution in Kingsley Close. It found no evidence the water treatment plant is causing either flooding or water pollution of properties in Kingsley Close, Wahroonga.
- (3) The EPA regularly inspects the NorthConnex project site including the water treatment plant and is in regular contact with the licensee.

\*1169 ENVIRONMENT—INDUSTRIAL NOISE—Dr Faruqi asked the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism representing the Minister for the Environment, Minister for Heritage, and Assistant Minister for Planning—

- (1) Has the Industrial Noise Policy been converted to Industrial Noise Guidelines?
  - (a) If yes, what was the rationale for doing this?
- (2) When will the Industrial Noise Guidelines be released?
- (3) What modelling has been conducted in preparation for the Industrial Noise Guidelines?
  - (a) What were the results of this modelling?
- (4) Do the changes to the management of industrial noise in New South Wales include linear noise?
  - (a) If not, why not?
- (5) Was the objective of protecting the community and its amenities removed in the conversion of the Industrial Noise Policy to the Industrial Noise guidelines?
  - (a) If yes, why?
- (6) What research regarding industrial noise has been undertaken in New South Wales rural areas?
- (7) Will the Industrial Noise Guideline result in increased noise allowance in New South Wales rural areas?

Answer—

I am advised as follows:

- (1) No. A draft Industrial Noise Guideline was exhibited for public consultation. Submissions are being considered and the document is being finalised.
- (2) The submissions on the draft Industrial Noise Guideline will inform government's decision on the finalisation of an updated document.
- (3) Modelling was undertaken following stakeholder consultation, to further examine the impact of the proposed changes.
  - (a) The results of the modelling and stakeholder submissions on the draft Industrial Noise Guideline are being considered by government to inform the finalisation of an updated document.
- (4) Yes. Linear or unweighted noise levels are used as a part of the proposed tonality and low frequency noise assessment approaches.
- (5) No. A draft Industrial Noise Guideline was exhibited for public consultation. Submissions are being considered and the document is being finalised. The Environment Protection Authority's (EPA) objectives in relation to pollution including noise pollution are set out in the Protection of the Environment Administration Act 1991 and the Protection of the Environment Operations Act 1997. These objectives include to protect, restore and enhance the environment in NSW, reduce risks to human health and prevent the degradation of the environment. The EPA's decisions are made in the context of these objectives. In any revision to the Industrial Noise Policy, the intent will be to better reflect the document's role to provide criteria and a framework for assessing and managing industrial noise.
- (6) No research on industrial noise in rural NSW was found during the review of the Industrial Noise Policy. The research and technical information used as a basis for the draft document is outlined in the Draft Industrial Noise Guideline Technical Background Paper that was published with the draft guideline. The paper is available at [www.epa.nsw.gov.au/resources/noise/150207-background-paper-ING.pdf](http://www.epa.nsw.gov.au/resources/noise/150207-background-paper-ING.pdf).
- (7) The draft Industrial Noise Guideline proposed that the minimum daytime noise assessment level criteria be raised from 35 decibels to 40 decibels. This noise level remains below World Health Organisation recommendations for protecting sleep, and below levels that are expected to lead to

unacceptable impacts on community amenity. The draft Industrial Noise Guideline was exhibited for public consultation and a final document is expected to be considered by government in the coming months.

The technical basis for the changes proposed in the draft Guideline is outlined in the Draft Industrial Noise Guideline Technical Background Paper that was published with the draft guideline. \*1170 HEALTH—INDUSTRIAL NOISE—Dr Faruqi asked the Minister for Ageing, Minister for Disability Services, and Minister for Multiculturalism representing the Minister for Health—

- (1) What involvement has the Department of Health had in the development of Industrial Noise Guidelines?
- (2) How will the Industrial Noise Guidelines protect the health of families in rural New South Wales?
  - (a) Will Industrial Noise Guidelines improve or worsen health outcomes for New South Wales families when compared to the Industrial Noise Policy?

Answer—

I am advised:

The NSW Environment Protection Authority (EPA) is completing a review of the NSW Industrial Noise Policy and invited comment on a draft Industrial Noise Guideline in September 2015.

The document is used by planning and environment authorities in accessing industrial developments.

The EPA states that the document 'modernises the existing policy without significantly altering its main principles and processes.'

NSW Health has participated in meetings organised by the Environmental Protection Authority.

\*1171 PRIMARY INDUSTRIES—DOLPHIN MARINE MAGIC—Dr Faruqi asked the Minister for Primary Industries, and Minister for Lands and Water—

- (1) Please provide copies of the two undertakings provided to the Department of Primary Industries (DPI) in relation to meeting with Seal Standards.
- (2) What precisely was the metal object found inside the body of the dolphin calf Ji-Ling?
- (3) Was the DPI provided with a full post mortem for the death of Ji-Ling?
  - (a) If yes, please provide the report.
  - (b) If not, why has DPI not required a full post-mortem report from Dolphin Marine Magic with respect to Ji-Ling?
  - (c) If not, what is the legal basis for excusing Dolphin Marine Magic from the legal requirement of providing a complete post-mortem?
- (4) What further information has DPI obtained from Dolphin Marine Magic regarding the causes of death of the Australian Little Blue Penguins?
- (5) What further information has DPI obtained from Dolphin Marine Magic regarding measures it will take to prevent future high levels of penguin deaths?
- (6) The NSW Dolphin Standards require dolphin enclosures to meet the minimum dimensional requirements at all times. How then is it legally compliant for a barrier to bisect the primary dolphin pool for 1.5 hours per day?
- (7) Please provide the details of the "mid-term seal holding enclosures" used to house the seals when their primary enclosure is being used as a dolphin isolation pool, specifically the number of pools, whether they are permanent or temporary structures, and dimensions for each pool.
- (8) The review of the 'dolphin kisses' has been underway for many months. When will it be completed?

Answer—

- (1) It is not appropriate to provide detailed information on ongoing operational compliance and enforcement action being undertaken by the Department of Primary Industries.
- (2) A small flat piece of metal of unknown origin.

- (3) The Department was provided with an abridged post mortem report.
  - (a) Not applicable.
  - (b) The Department was satisfied with the post mortem report provided.
  - (c) The dolphin standards require that "A complete post-mortem examination by a veterinary surgeon or practitioner, with training and experience of animal pathology, must be carried out on all dead animals. Copies must be kept by establishments and submitted to the appropriate authorities." The Department was satisfied with the post mortem report provided.
- (4) The cause of death of the Little Penguins was Avian Mycobacteria.
- (5) Dolphin Marine Magic has put in place a number of preventative measures to manage the Avian Mycobacteria.
- (6) Please see the General Standards for Exhibiting Animals in New South Wales and the Standards for Exhibiting Bottle-nosed Dolphins (*Tursiops truncatus*) in New South Wales.
